Development of Harraby Closed Cycle Track

Subject Matter:

In July 2015 a report was taken to Executive seeking approval to apply for a solicited grant to develop a closed circuit cycle track in Harraby. The proposed track would be fully funded by British Cycling and span land owned by Carlisle City Council and Cumbria County Council.

Executive approved the application for the grant and delegated authority to develop the final scheme to the Portfolio Holder for Culture, Leisure and Young People, the Leader and the Finance, Governance and Resources Portfolio Holder, following consultation with the Deputy Chief Executive (Key Decision – KD.24/15).

Carlisle City Council was successful in securing the necessary funding from British Cycling in November 2015. Unfortunately the development was delayed following Storm Desmond. An agreement for lease has now been reached with Cumbria County Council for the land necessary to progress the scheme and a tender exercise has been completed for the construction contract (and the winning tender is within budget).

Summary of Options rejected:

DECISION

To take leasehold of a parcel of land to the South of the new Harraby Community Campus from Cumbria County Council on a 99 year, peppercorn lease.

To appoint the winning bidder from the cycle track tender exercise conducted in Spring 2015 and develop the cycle track in accordance with the planning permission granted in 2015 (Application number 15/0246).

Reasons for Decision

To take advantage of significant (£650,000) of external funding and develop a Closed Circuit Cycle Track to the South of the Harraby Campus. This will deliver one of the major facilities identified in Carlisle City Council's current Sports Facilities Strategy.
