### **Summary:**

This report provides an update on plans by Churches Together in Carlisle & District to support homelessness initiatives in Carlisle

#### 1. BACKGROUND INFORMATION

- 1.1 Churches Together in Carlisle and District have been in existence since the late 1980s. It is open to any Christian Church in Carlisle and District who wishes to join. They currently have members from about 15 churches which represents about a third of all places of Christian worship in the district.
- 1.2 Its aims are to enable Christians of any denomination to work together in unity.
  They do this by both prayer and worship and through practical measures within the community in which they live. Often described as Practical Christianity.
- 1.3 Examples of these measures over the last few years have been setting up of the Street Pastors, and Carlisle One World Centre and the Homeless Food Voucher Scheme. At present, Churches Together are in the process of setting up a food bank in conjunction with other agencies in the City, such as the CVS and COWC. They also have some involvement in the Johns St Hostel for the homeless.

#### 2. GRANTS FROM CARLISLE CITY COUNCIL

- 2.1 The proposed funding grant would enable Churches Together to continue to develop the initiatives mentioned above.
- 2.2 It is proposed that the Wellbeing Team would support and monitor the appropriate targeting of resources to enhance the initiatives proposed by Churches Together. This could include awareness raising sessions through community centres or staff delivering activity that adds to existing or proposed projects.

#### 3. **RECOMMENDATIONS**

3.1 That the Executive consider the proposal associated with budget amendments raised at Council on the 7<sup>th</sup> February, the allocation of a grant allowance of £5,000 to Churches Together in Carlisle and District to fund homelessness initiatives
