Summary

As part of its Revenue Budget for 2003/04 the City Council has allocated £17,350 for the provision of new amenity lighting in the district. This report sets out a proposed programme of work for providing new lighting prepared after consultation with the Police and based upon requests received from the public, Council Members and Parish Councils.

AMENITY LIGHTING PROGRAMME 2003/04

1. BACKGROUND INFORMATION AND OPTIONS

- 1.1 As part of its Revenue Budget for 2003/04 the City Council has allocated £17,350 for the provision of new amenity lighting in the district.
- 1.2 A considerable number of requests for new lighting have been received from Members, Parish Councils and the public. Having considered the various requests received and obtaining comments from Cumbria Police it is proposed that the lighting improvements listed in Table 1.2 below be implemented. It is estimated that schemes No. 1 to § can be implemented this year with the funds available. The remaining schemes 10 and 11 to be implemented if further funding becomes available.

In the urban area the comments from the Crime and Disorder Reduction Team strongly request that the remaining funds be targeted in Currock and Upperby. Taking on board these comments, two specific locations have been selected with the remaining £9050 to be agreed with representatives from the Crime and Disorder Reduction team and community representatives.

in response to your letter dated 9.1.03 re the above, the Crime & Disorder Reduction team recommend that <u>ALL</u> the budget be targeted at the Currock and Upperby wards.

Justification for this will be found in the CDRP Leadership Group directive for activity in that area. 'Hotspot' activity is a priority in the 2002/2005 strategy. Currock and Upperby were chosen on sound intelligence from partnership data. One action falling out of a problem solving exercise there, was improved lighting. Leabourne Road and Sunnymeade were identified as particular problems, though we suggest the Community Beat Managers be consulted on individual locations prior to approval.

We appreciate that this may not politically be the best recommendation, but Section 17 etc, the council needs to consider where the money will have most impact, and we advise as above. In helping to persuade councillors that this is the best approach, you can say not only does it contribute to delivery of the Crime and Disorder Strategy, but also Best Value report recommendations on Community Safety - mainstreaming. Both Paul and i will be happy to attend any committee meeting.

On a more positive note. Is it possible to have all the names of those requesting lighting improvement in the Currock and Upperby wards?

It strikes me that we have an opportunity to get a lot of positive mileage out of this. Not only will it generate good press coverage, but we potentially have a ready made *community task force* from those making the requests. Having seen there voice have an impact we could involve them in other community actions from the problem solving exercise -

- referral agents for the graffiti project
- new Neighbourhood Watch co-ordinators
- · barometers for community tension community intelligence gatherers

Please let me know what you are to recommend (a copy of the committee report would be appreciated). I'll pop up and discuss if it helps.
