#### **Purpose / Summary:**

The purpose of the report is to ask Members to consider whether Upperby Men's Institute, which currently holds a club premises certificate, continues to satisfy the conditions for being a qualifying club in relation to a qualifying club activity to which the certificate relates.

#### **Recommendations:**

Members are to consider whether Upperby Men's Institute fulfils the requirements of a qualifying club and if not, withdraw the club certificate.

#### 1. BACKGROUND

- 1.1 Club Premises such as Upperby Men's Institute are issued with a Club Premises Certificate under the Licensing Act 2003 and are afforded certain key benefits as opposed to other licensed premises. These benefits include:
  - Under the authority of a Club Premises Certificate, to supply alcohol to members and sell it to guests on the premises to which the certificate relates without the need for any member or employee to hold a Premises Licence.
  - The absence of a requirement to specify a Designated Premises Supervisor required under normal premises licences and who is the person responsible for all sales of alcohol with those premises.
  - More limited access rights of entry for the police and authorised persons because the premises are considered private and not generally open to the public.
  - Exemption from police powers of instant closure on grounds of disorder and noise nuisance because they operate under their codes of discipline and rules which should be rigorously enforced by the club's management committee.
  - Exemption from orders of the Magistrates Court for the closure of all licensed premises in an area when disorder is happening or expected.
- 1.2 The Licensing Act 2003 prescribes the conditions and determinations which need to be considered in order for a club to qualify as a club premises. The relevant sections (62-64) are attached in full at Appendix . In summary:
  - 1.2.1 **Section 62** of the Licensing Act 2003 sets out the general conditions which a club must satisfy if it is to qualify as a club premises. In summary, to qualify as a members club:
    - the club must have rules regarding admission to membership
    - the club must be established and conducted in good faith
    - there must be at least 25 members
    - alcohol is supplied to members on the premises by or on behalf of the club
  - 1.2.2 **Section 63** of the Act (Appendix 1) gives guidance as to the matters to be taken into account by the Licensing Authority when determining whether a club is established and conducted in good faith. These include:
    - arrangements restricting the club's freedom to purchase alcohol
    - provision in the rules for distribution of monies or property otherwise than for the benefit of the club

- the arrangements for giving members information about club finances, books of account and other records
- the nature of the premises occupied by the club.
- 1.2.3 **Section 64** sets out additional qualifying conditions for those clubs which supply alcohol. These include:
  - the purchase and supply of alcohol being managed by committee
  - no person is to receive at the expense of the club commission or similar for the purchase of alcohol
  - any pecuniary benefits from the supply of alcohol accrue to the club as a whole.
- 1.3 The Licensing Authority must give notice to a club if it appears to it that the club does not satisfy the qualifying conditions, (Section 90 of the 2003 Act Appendix 2). The Government's explanatory notes to S90 state "A club which ceases to meet the criteria set out at sections 61, 62, 63 and 64 will have its certificate withdrawn by the Licensing Authority".

#### 2 HISTORY

- 2.1 Under the Licensing Act 2003 most non profit-making clubs could apply for a Club Premises Certificate. Upperby Men's Institute was issued a Club Premises Certificate (CP023) on 24/11/2005 (Appendix 3).
- 2.2 A Licensing Sub-Committee was held on 2<sup>nd</sup> November 2007 to consider a variation to the Club Premises Certificate to extend the licence to the boundaries of the Club property including the car park area. Representations were made by many local residents and the application was rejected.
- 2.3 A further application was made in May 2009 to extend the area for Licensable activities to the outside smoking area. Due to representations from local residents a Licensing Sub-Committee was held on 30<sup>th</sup> June 2009 and the application was granted with the imposition of additional conditions.
- 2.4 Between June 2009 and December 2014 there have been no other issues brought to the attention of the Licensing Authority with regard to the Club.

#### 3 CURRENT POSITION

3.1 From December 2014 the Licensing Authority has received, and continues to receive, correspondence from local residents, club members and ex club members detailing various concerns about the running of Upperby Men's Institute.

- 3.2 Details of all correspondence (which has been redacted to protect identities), including letters to the Club Committee from the Licensing Office, are attached at Appendix 4. These include letters of complaints from Members to the Licensing Office as well as Cumbria & District branch of the Workmen's Club & Institute Union Ltd (CIU). Some complainants wish to remain anonymous as it is alleged that the current Chairman Mr Ruddick is very volatile (see 'D' dated 07/01/15 and letter 'T' undated).
- 3.3 Following liaison between Cumbria Police and the Licensing Authority it was agreed to enter the premises on Friday 11<sup>th</sup> September 2015 under Section 97 Of the Licensing Act 2003 which allows a constable to enter and search a club premise if it is suspected that an offence under the Misuse of Drugs Act 1971 has been, is being or is about to be committed there.
- 3.4 On entering the premises, Licensing Officers approached a young barman, Anthony Crangle, who is listed as a member of the club. He did not know who the club steward was and commented that he was just there to serve people. He was not aware of the entry procedures. It was noted that no entries had been recorded in the visitors book for the previous two days. The main doors to the premises were open allowing anyone access to the premises and there appeared to be no control as to who entered the premises. All these being breaches of club rules and conditions.
- 3.5 With the permission of the Chairman of the Club, Licensing Officers were allowed to remove the Club's Committee Minutes file from the premises in order to examine them at the Licensing Office. An examination of the minutes revealed that no entries could be found regarding acceptance of new members to the club or minutes of a committee meeting in relation to the changing of the club rules. If the club breaches the club rules or chose to disregard the rules they are then at risk of losing the Club Premises Certificate.
- 3.6 Officers from Cumbria Police and the Licensing Authority held a prearranged compliance visit to the Club on Wednesday 16<sup>th</sup> October 2015 to meet with the Chair, Paul Ruddick, and Secretary, Linda Baker. One other Committee Member was also present. This was held to establish how the premises was run by the committee and to establish their understanding of the Club Premises Certificate and conditions attached which must be adhered to. The police make comment in that it was evident from the outset of the visit that no one on the committee had any understanding of club rules or the Club Premises Certificate (Appendix 5). During the visit it was openly admitted that they allow the Concert Room to be hired and used by nonmembers. This is a clear breach of the Club Premises Certificate.
- 3.7 Cumbria Police have provided a detailed overview of the meeting and this is included at Appendix 5 and sets out their concerns in relation to the conditions of the CPC. This includes:

- Insecure entrance doors
- The lack of understanding of the club rules by Committee Members present
- The club being opening used for functions where members of the public were freely allowed admission
- Lack of understanding of the four licensing objectives or any statutory requirements to comply with the relevant provision of the Licensing Act 2003.
- Concerns that there appeared to be no one able to operate the CCTV system
- No challenge 21 or 25 posters and no written age verification policy
- 3.8 In relation to <u>the five general conditions</u> which a relevant club must meet to be a qualifying club (para 1.2.1) and determining if the club is established in good faith (para 1.2.2) 4 out of the 5 conditions are not being met:

#### **Admission of Members**

- 3.8.1 <u>Condition 1</u> Under the rules of the club persons may not be admitted to membership, or be admitted as candidates for membership to any privileges of membership, without an interval of at least 2 days between their nomination or application for members and their admission.
- 3.8.2 <u>Condition 2</u> Under the rules of the club, persons becoming Members without prior nomination or application may not be admitted to the privileges of membership without an internal of at least 2 days between becoming members and their admission.
- 3.8.3 Upperby Men's Institute have in fact adopted more stringent rules for the admission of Members found under section 7 (p.3) of the Club Rules booklet (Appendix 6). In summary a nomination can be received by two members who have been members for a least six months. The nomination is required to be prominently displayed in the club premises for at least seven days prior to the name being submitted to the Committee for election.
- 3.8.4 As noted above in para 3.5 an examination of the Club's Committee minutes revealed that no entries could be found regarding acceptance of new members to the club or minutes of a committee meeting in relation to the changing of the club rules. On inspection of the premises both on 11<sup>th</sup> September and 16<sup>th</sup> October 2015 no evidence could be found regarding the prominent display of nominations.
- 3.8.5 It was evident that new Members were being accepted at this time as on the visit on 11<sup>th</sup> September the Club's Chairman presented Licensing Officers nomination forms for new Members that he was currently processing.

3.8.6 An email was received by Licensing Authority on 5/1/15 (Appendix 1 'H') regarding how applications from Membership are dealt with which confirms the above and is a clear breach of Club Rule 7.

#### **ESTABLISHING AND CONDUCTING IN GOOD FAITH**

- 3.8.7 Condition 3 The club is established and conducted in good faith as a club.
- 3.8.8 As noted in para 1.4 above, Section 63 of the Licensing Act 2003 gives guidance of the matters to be taken into account when determining whether a club is established and conducted in good faith.
- 3.8.9 The first consideration 63(2)(a) states that the licensing authority will have to consider and take into account is whether there are any arrangements restricting the clubs freedom to purchase alcohol.
- 3.8.10 During the joint visit to Upperby Men's Institute on 16<sup>th</sup> October 2015, Licensing Officers asked the Chair whether the Club had the freedom to purchase alcohol.
- 3.8.11 Officers were informed that the club currently owed money to two alcohol suppliers and were currently acquiring their alcohol through an independent wholesaler who the club hope will take over the debt owed to the suppliers.
- 3.8.12 Officers are aware that one main supplier will charge £250 loading fee to pay back current trade debt if the club choses to purchase direct from them.
- 3.8.13 It is argued that the due to current debts and the conditions attached to the purchase of alcohol from suppliers that the Club do not have the freedom to purchase alcohol.
- 3.8.14 The CIU state that "The club are in breach of condition 3 if they have failed to honour the trading agreements and load repayments with both suppliers of alcohol." (Appendix 7)
- 3.8.15 Evidence supporting the concern about the clubs financial situation and whether the club is run in good faith and has the freedom to purchase alcohol is further supported through inspection of the clubs accounts and committee minutes.
- 3.8.16 Inspection of the audited financial statements for the club for the year ending 31<sup>st</sup> December 2014 by Saint & Co Chartered Accountants show a financial loss of £23,683 and a further £18,559 owed to HMRC with regard to the VAT on gaming machines which was reclaimed and then clawed back following appeal. This takes the loss for 2014 to £42,242. The accountant states that "...the club requires the continued support of its creditors in order to continue to trade" and with regard to ongoing litigation "indicate the existence of a

- material uncertainty which may cast significant doubt about the club's ability to continue as a going concern."
- 3.8.17 The financial statement also refers to ongoing litigation against the club and a recent letter from the CIU (Appendix 7) notes that "Both the previous club Secretary & Stewardess have both reached settlements with the club following their dismissals and are awaiting their compensation payments."
- 3.8.18 The clubs Committee minutes of 7<sup>th</sup> July 2015 report the stocktake deficit of:

186 pints Strongbow

167 pints Fosters

33 bottles alcopops

60 pints Tetleys Mild

12 bottles of Carlsberg.

Float down £2500

- 3.8.19 The Committee also agreed at this meeting to make enquires to obtain at £50,000 loan.
- 3.8.20 The second consideration 63(2)(b) relates to finance and states that any gain from the carrying out of the club is to be applied for the benefit of the club.
- 3.8.21 It could be argued that the members of the committee, ie the current Chairman, Paul Ruddick, are making a gain from the carrying on of the club by receiving a salary. At the joint visit on 15<sup>th</sup> October 2015, Licensing Officers and Police were informed by the Club Secretary that the Chair receives an honorarium of between £30-£100 per week dependent on the amount of time he has given.
- 3.8.22 Remuneration to committee members and officers of the club (ie the Chairman, Treasurer and Secretary) is covered explicitly by the clubs rules 19 and 20.
- 3.8.23 Club Rule 19 (Appendix 6) states "No goods or labour shall be supplied, nor any contract entered into for work to be done for the club, nor any office of salary, profit or remuneration, to be held by any member of the committee nor shall any honoraria be paid to committee members, unless authorised by a general meeting or on the authority of two officers in an emergency for the benefit of the club."
- 3.8.24 Club Rule 20 (Appendix 6) goes on to say "The Officers of the club shall receive such honorarium, if any, or in the case of the secretary such salary, as the committee or a general meeting may from time to time determine."

- 3.8.25 Officers question whether the weekly payment to the Chair constitutes an "honorarium". Committee members should not receive a salary and the steward of the club should not be a member (Carly Ruddick appears to be a member according to club records). There is no reference in any of the Committee minutes examined of reference to payment to the Chair and as noted above, Club Rule 20 states that this is the decision of the Committee. These are breaches of the club rules and appear to be of benefit to them and not the club considering the financial difficulties the club is in.
- 3.8.26 The only reference to payment to Committee Members could be found in the clubs committee minutes for the meeting of 18<sup>th</sup> November 2014.
- 3.8.27 Under matters arising the minutes state "the Chairman mention to the committee about the hours the secretary undertakes, as we are in financial trouble, it was agreed that the secretary's hours would be dropped to the minimum necessary" Later in the same meeting under Any Other Business it is minuted "A proposal was made from P Ruddick to be paid for carrying out work whilst the secretary is away"
- 3.8.28 Concern has been raised by members regarding the emptying of the club lottery machines by the Chairman (see Appendix 4 letter 'G'). Licensing Officers inspected these machines on their visit on 16<sup>th</sup> October 2015 and questioned Mr Ruddick on the procedure for emptying. He confirmed that only he emptied the cash from the machines every Tuesday.
- 3.8.29 Mr Ruddick was informed that although more research was required, these machines may need to be licenced under a Small Society Lottery Licence. This would require 20% of the income to be donated to a charity or good cause. His response to this was that he if was required to donate 20% of the income then he would take them down.
- 3.8.30 The club passes **Condition 4** as they have well over 25 members.

#### SUPPLY OF ALCOHOL TO MEMBERS

- 3.8.31 <u>Condition 5</u> Alcohol is not supplied, or intended to be supplied, to members on the premises other than by or on behalf of the club.
- 3.8.32 During the joint Police/Licensing visit on 11<sup>th</sup> September 2015 a non-member was observed playing pool and drinking alcohol.
- 3.8.33 The Chair and the Secretary of the club confirmed to Police and Licensing Officers on their visit on 15<sup>th</sup> October 2015 that the club function room is hired out for parties and events when non-members attend and are allowed the facilities of regulated entertainment and the supply of alcohol. Indeed it was freely admitted that the following day (16<sup>th</sup> October) a pool competition

- had been arranged and would be attended by people from "all over", the majority of which would not be members.
- 3.8.34 On discussion of the above, advice was given to the Chair and Secretary regarding their option of submitting Temporary Events Notices (TEN) to cover non-member functions. The Chair's response to this was that he "would have to turn business away" and did not seem to appreciate that the privileges afforded to a club restricted in some part the ability to trade freely. Indeed the club's public facebook page invites bookings for the function room (Appendix 9).
- 3.8.35 It is noted from recent entries on social media sites that the club appears to continue to hold functions without Temporary Events Notices (Appendix 9).
- 3.8.36 Revised guidance issued under Section 182 of the Licensing Act 2003 states that "although there is no mandatory requirement for guests to be signed in by a member of the club a point may be reach where a club is providing commercial services to the general public in a way that is contrary to its qualifying club status. It is at this point that the club would no longer be conducted in "good faith" and would no longer meet "general condition 3" for qualifying clubs in section 62 of the 2003 Act."
- 3.8.37 Cumbria Police have also commented on this, "The Club would appear to be openly used for functions that were taking place at the weekend (pool competition on Saturday) where members of the public were going to be freely allowed admission. We also established they were hosting three functions planned towards the end of the month where it would appear members of the public would be freely allowed entry." (Email Appendix 5)
- 3.8.38 The CIU states that "it would appear from the complaints I have received from members of this club that the current regime are running this club more like a public house than an club". (Letter Appendix 7)
- 3.8.39 A statement from the Council's District Environmental Health Officer detailing her visit in March 2015 supports the argument that the club fails to control or monitor admission to the premises. (Appendix 8)

#### 4 CONCLUSION

- 4.1 The Licensing Office has serious concerns regarding the management of these premises and whether Upperby Men's Institute satisfies the five general conditions which a relevant club must meet under the Licensing Act 2003.
- 4.2 Neither the Committee, or staff employed, appear to have any knowledge or understanding of a Club Premises Certificate or indeed the conditions attached to them. The committee are not abiding by the rules of the club such as Rule 17 in

relation to monetary grants to members, Rule 19 in relation to no office or salary, profit or remuneration, be held by any member of the committee unless authorised by a general meeting, Rule 20 regarding any change of Secretary must be notified by the Chairman or Secretary within 42 days to Magistrates and Rule 34 in relation to guests attending the premises.

- 4.3 There are a number of breaches of conditions attached to the club premises certificate which carry considerable maximum penalties such as the club not having an age verification policy (this is a Mandatory condition with maximum penalty £20000 fine and or 6 months imprisonment). They are also in breach of conditions attached to the certificate in relation to carrying out alterations carried on the first floor of the premises without the approval of the council. Again they are in breach of a condition attached to their licence in relation to children only being allowed to attend occasional members private functions as children have attended other events such as weddings, birthdays and anniversaries etc in the function room which is hired out by the committee.
- 4.4 The club openly hires out the function room for events such as weddings, anniversaries, birthday parties when non- members have attended. The Licensing Office previously warned the club by letter, however this does not seem to have been taken seriously by the committee. This is a clear breach of a Mandatory condition attached to the Club Premises Certificate. The maximum penalty for such a breach is £20.000 fine and or 6 months imprisonment. This was openly admitted by the chairman during a meeting held at the club when police and Licensing Officers were present. A Licensing authority can request the Club Premises Certificate be withdrawn for this alone.
- 4.5 Premises such as Upperby Men's Institute are afforded certain key benefits because the local authority has issued them with a Club Premises Certificate under The Licensing Act 2003. It is believed that Upperby Men's Institute no longer meets the five general conditions they must meet to be a qualifying club and therefore the Club Premises Certificate should be withdrawn.
- 4.6 The findings outlined above from officers from the local licensing authority, Cumbria Police and CIU indicates that Upperby Men's Institute does not satisfy the conditions of the Licensing Act 2003 Sections 62.
- 4.7 If the Licensing Authority decides for any reason that the club does not satisfy any of the conditions in Section 62 of the Licensing Act 2003 then it must give the club notice of its decision and its reason for the decision.

#### 5 OPTIONS

Members should decide whether the Upperby Men's Institute satisfied the conditions set out in S62 and either:

- 5.1 Give notice to the club withdrawing the certificate in relation to the supply of alcohol, if it is agreed that the club no longer qualifies for a Club Premises Certificate; or
- 5.2 Take no action and allow the Club Premises certificate to continue, if Members consider that the conditions are satisfied.

# Licensing Act 2003

#### **2003 CHAPTER 17**

#### PART 4

#### **CLUBS**

#### Qualifying clubs

#### 61 Qualifying clubs

- (1) This section applies for determining for the purposes of this Part whether a club is a qualifying club in relation to a qualifying club activity.
- (2) A club is a qualifying club in relation to the supply of alcohol to members or guests if it satisfies both—
  - (a) the general conditions in section 62, and
  - (b) the additional conditions in section 64.
- (3) A club is a qualifying club in relation to the provision of regulated entertainment if it satisfies the general conditions in section 62.

#### 62 The general conditions

- (1) The general conditions which a club must satisfy if it is to be a qualifying club in relation to a qualifying club activity are the following.
- (2) Condition 1 is that under the rules of the club persons may not-
  - (a) be admitted to membership, or
  - (b) be admitted, as candidates for membership, to any of the privileges of membership,

without an interval of at least two days between their nomination or application for membership and their admission.

(3) Condition 2 is that under the rules of the club persons becoming members without prior nomination or application may not be admitted to the privileges of membership

without an interval of at least two days between their becoming members and their admission.

- (4) Condition 3 is that the club is established and conducted in good faith as a club (see section 63).
- (5) Condition 4 is that the club has at least 25 members.
- (6) Condition 5 is that alcohol is not supplied, or intended to be supplied, to members on the premises otherwise than by or on behalf of the club.

#### 63 Determining whether a club is established and conducted in good faith

- (1) In determining for the purposes of condition 3 in subsection (4) of section 62 whether a club is established and conducted in good faith as a club, the matters to be taken into account are those specified in subsection (2).
- (2) Those matters are—
  - (a) any arrangements restricting the club's freedom of purchase of alcohol;
  - (b) any provision in the rules, or arrangements, under which-
    - (i) money or property of the club, or
    - (ii) any gain arising from the carrying on of the club,

is or may be applied otherwise than for the benefit of the club as a whole or for charitable, benevolent or political purposes;

- (c) the arrangements for giving members information about the finances of the club;
- (d) the books of account and other records kept to ensure the accuracy of that information:
- (e) the nature of the premises occupied by the club.
- (3) If a licensing authority decides for any purpose of this Act that a club does not satisfy condition 3 in subsection (4) of section 62, the authority must give the club notice of the decision and of the reasons for it.

#### The additional conditions for the supply of alcohol

- (1) The additional conditions which a club must satisfy if it is to be a qualifying club in relation to the supply of alcohol to members or guests are the following.
- (2) Additional condition 1 is that (so far as not managed by the club in general meeting or otherwise by the general body of members) the purchase of alcohol for the club, and the supply of alcohol by the club, are managed by a committee whose members—
  - (a) are members of the club;
  - (b) have attained the age of 18 years; and
  - (c) are elected by the members of the club.

This subsection is subject to section 65 (which makes special provision for industrial and provident societies, friendly societies etc.).

(3) Additional condition 2 is that no arrangements are, or are intended to be, made for any person to receive at the expense of the club any commission, percentage or similar payment on, or with reference to, purchases of alcohol by the club.

- (4) Additional condition 3 is that no arrangements are, or are intended to be, made for any person directly or indirectly to derive any pecuniary benefit from the supply of alcohol by or on behalf of the club to members or guests, apart from—
  - (a) any benefit accruing to the club as a whole, or
  - (b) any benefit which a person derives indirectly by reason of the supply giving rise or contributing to a general gain from the carrying on of the club.

### 65 Industrial and provident societies, friendly societies etc.

- (1) Subsection (2) applies in relation to any club which is-
  - (a) a registered society, within the meaning of the Industrial and Provident Societies Act 1965 (c. 12)(see section 74(1) of that Act),
  - (b) a registered society, within the meaning of the Friendly Societies Act 1974 (c. 46) (see section 111(1) of that Act), or
  - (c) a registered friendly society, within the meaning of the Friendly Societies Act 1992 (c. 40) (see section 116 of that Act).
- (2) Any such club is to be taken for the purposes of this Act to satisfy additional condition 1 in subsection (2) of section 64 if and to the extent that—
  - (a) the purchase of alcohol for the club, and
  - (b) the supply of alcohol by the club,

are under the control of the members or of a committee appointed by the members.

- (3) References in this Act, other than this section, to-
  - (a) subsection (2) of section 64, or
  - (b) additional condition 1 in that subsection,

are references to it as read with subsection (1) of this section.

- (4) Subject to subsection (5), this Act applies in relation to an incorporated friendly society as it applies in relation to a club, and accordingly—
  - (a) the premises of the society are to be treated as the premises of a club,
  - (b) the members of the society are to be treated as the members of the club, and
  - (c) anything done by or on behalf of the society is to be treated as done by or on behalf of the club.
- (5) In determining for the purposes of section 61 whether an incorporated friendly society is a qualifying club in relation to a qualifying club activity, the society is to be taken to satisfy the following conditions—
  - (a) condition 3 in subsection (4) of section 62.
  - (b) condition 5 in subsection (6) of that section,
  - (c) the additional conditions in section 64.
- (6) In this section "incorporated friendly society" has the same meaning as in the Friendly Societies Act 1992 (see section 116 of that Act).

#### 66 Miners' welfare institutes

- (1) Subject to subsection (2), this Act applies to a relevant miners' welfare institute as it applies to a club, and accordingly—
  - (a) the premises of the institute are to be treated as the premises of a club,

#### **2003 CHAPTER 17**

#### PART 4

#### **CLUBS**

#### Withdrawal of certificates

#### 90 Club ceasing to be a qualifying club

- (1) Where-
  - (a) a club holds a club premises certificate, and
  - (b) it appears to the relevant licensing authority that the club does not satisfy the conditions for being a qualifying club in relation to a qualifying club activity to which the certificate relates (see section 61),

the authority must give a notice to the club withdrawing the certificate, so far as relating to that activity.

- (2) Where the only reason that the club does not satisfy the conditions for being a qualifying club in relation to the activity in question is that the club has fewer than the required number of members, the notice withdrawing the certificate must state that the withdrawal—
  - (a) does not take effect until immediately after the end of the period of three months following the date of the notice, and
  - (b) will not take effect if, at the end of that period, the club again has at least the required number of members.
- (3) The references in subsection (2) to the required number of members are references to the minimum number of members required by condition 4 in section 62(5) (25 at the passing of this Act).
- (4) Nothing in subsection (2) prevents the giving of a further notice of withdrawal under this section at any time.

- (5) Where a justice of the peace is satisfied, on information on oath, that there are reasonable grounds for believing—
  - (a) that a club which holds a club premises certificate does not satisfy the conditions for being a qualifying club in relation to a qualifying club activity to which the certificate relates, and
  - (b) that evidence of that fact is to be obtained at the premises to which the certificate relates,

he may issue a warrant authorising a constable to enter the premises, if necessary by force, at any time within one month from the time of the issue of the warrant, and search them.

(6) A person who enters premises under the authority of a warrant under subsection (5) may seize and remove any documents relating to the business of the club in question.

- 2) Any alcohol supplied for consumption off the premises must be in a sealed container.
- 3) That any supply of alcohol for consumption off the premises must be made to a member of the club in person.

Provision may be made for the public entertainment in the premises by the reproduction of wireless (including television) broadcasts (or of programmes included in any programme service [within the meaning of the Broadcasting Act 1990] other than a sound or television broadcasting service), or of public entertainment by way of music and singing only which is provided solely by the reproduction of recorded sound.

#### General

The Club Management, Stewardess and Bar Staff are informed of the Licensing Act 2003 objectives and statutory requirement to comply with the relevant provisions of the Act. We believe that our Club Rules and the conditions relating to our existing Certificate, have already proved to be quite adequate, in respect of all four objectives, thus while we have no specific proposals for further improvement, we are always prepared to accept further advice.

#### The prevention of crime and disorder

All past Certificates have been issued subject to inspection/approval by the police, whom have never objected to any application, during my 29 years as Club Secretary. Warning notices are posted against Drugs, Contraband goods, misbehaviour etc, and we have rarely ever, needed to call in the police. Admission to the premises is confined to Members and bona fide guests, and is continuously monitored/controlled, via a computerised/CCTV door entry system.

#### **CD12**

A tamper proof CCTV system shall be installed at the premises in liaison with and to the satisfaction of the Cumbria Police Licensingand Community Safety Officers and shall be used to record during all hours that a licensable activity takes place on the premises.

#### **CD14**

Where CCTV equipment is fitted, it shall be maintained in good working order in accordance with the manufacturer's instructions.

#### **CD16**

The images recorded by the CCTV system shall be retained in unedited form for a period of not less than 31 days.

#### **Public safety**

Similarly, certificates have been subject to inspection/approval by the Fire Prevention Officer and all necessary improvements have been updated, as required over the years, the latest being September 2003. Additionally, we employ specialist advice on Health & Safety matters, applying to Staff and Members alike, and three full time staff members possess Certificates in first aid.

#### PS<sub>3</sub>

All parts of the premises shall at all times be kept free from defect and no changes, alterations of any kind to the surface finish or coverings including furniture and flooring on any part of the premises shall be made without the prior approval of the Council.

#### PS<sub>6</sub>

All exits and escape routes to those exits (including external escape routes) from the premises shall be provided with slip resistant even surfaces and shall be maintained in good repair, correct working order

and kept free from all obstructions when the public are on the premises. External escape routes shall also be kept free from ice and snow.

The nosings on all steps and landings shall be maintained so that they are clearly visible by painting them in contrasting colours or other similar means.

#### PS8

All doors or gates both inside and outside the premises which are on an escape route shall be fitted only with approved fasteners and shall at all times be properly maintained, free from obstruction and be capable of being opened easily and fully so that they do not restrict the public leaving the premises and shall open in the direction of the escape route.

#### **PS10**

All exit doors and gates from premises or enclosure(s) surrounding it shall be capable of being opened by any person without the use of a key, card, code or other similar means and be kept free from all fastening devices when the premises are open to the public.

#### **PS12**

The method of opening any exit door or gate from the premises or enclosure(s) surrounding it shall be clearly displayed immediately above or below the fastening in white block lettering on a green background in letters not less than 50 mm high.

#### **PS14**

Where a fire-resisting door is fitted within the premises and that door is required to be kept closed at all times then the door shall be clearly marked on both sides with a sign bearing the words "FIRE DOOR KEEP CLOSED" in block letters not less than 50mm high and clearly visible when the premises are open to the public.

The furniture or seating in premises shall be arranged so that it does not obstruct any exit, route to any exit or to any facility within the premises.

#### **PS20**

Before the premises are opened for the purposes authorised by the licence an inspection shall be carried out to ensure that the premises are safe for use. Details of the inspection, defects discovered and remedial action taken shall be recorded in writing in a logbook kept for that purpose. That logbook shall be made available for inspection on demand to an Authorised Officer of the Council, a Fire Officer or a Police Constable.

The premises shall be maintained so that the following fire retardancy standards are complied with:

All upholstered seating meets on a continuous basis the pass criteria for smouldering ignition source 1 and crib ignition source 5 when tested in accordance with section 5 of BS 5852:1990.

All repairs or refurbishment of existing seating or upholstery shall include the removal of untreated polyurethane foam and its replacement by fillings which conform to the Furniture and Furnishings (Safety) Regulations 1988 (as amended).

#### **PS22**

Where any furnishing or fitting in the premises including wall, floor and ceiling linings, requires further periodic treatment to maintain the surface spread of flame qualities, they shall be treated in accordance with the manufacturers specifications. When such treatment is carried out, a written record shall be made in the logbook kept for that purpose and a certificate showing the treatment has been carried out shall be obtained and retained for inspection by the Fire Authority.

#### **PS23**

No curtain, hanging or any other decoration shall be positioned so as to obstruct any exit, sign or fire fighting equipment. Curtains covering doorways should be divided down the middle and so hung that the lower edge of the curtain does not touch the floor. They should not obstruct notices, exit signs, fire fighting equipment etc.

#### **PS26**

A person who is nominated for the purpose of taking control in the event of a fire, fire alarm, emergency or event which may effect the safety of persons attending the premises shall be on and in charge of the premises at all times when any licensable activity is being provided.

That person shall be responsible for calling the Fire Service in the event of any fire and that person shall also be responsible for meeting the Fire Service and advising them of the location of the fire.

#### **PS27**

Any outbreak of fire of any kind shall be reported to the Fire Service immediately and a written record shall be made in a logbook kept for that purpose.

#### **PS71**

Emergency Lighting will be tested in accordance with BS 5266 Part 1, 1999 Emergency Lighting. The results of the tests will be recorded in a logbook. A satisfactory NICEIC (or equivalent) inspection report will be provided annually to the Licensing Authority.

#### **PS72**

The fire alarm detection system will be tested in accordance with BS 5839 Part 1 2002 Fire Detection and Fire Alarm Systems for buildings. The results of the tests will be recorded in a log book. A satisfactory inspection report will be provided annually to the Licensing Authority.

#### **PS76**

Fire fighting equipment shall be provided throughout the premises at suitable locations and be appropriate to the risk to comply with BS 5306 Part 8, Selection and Installation of Portable Fire Extinguishers.

No specific conditions have applied to past Certificates, but we are obviously aware that we must live harmoniously with our neighbours, many of whom are Members of the Club, and our Concert Room, for example, was built to be soundproof, for this reason. Members are warned, and disciplined if necessary, against making a noise, or causing a disturbance, when leaving the premises, at any hour, day or night.

#### The protection of children from harm

Club rules prohibit Members under the age of 18 years. Children are permitted to attend the occasional Member's private function - Christenings/Birthdays/ Weddings etc, as long as they are accompanied by adults, and restricted to the first floor Concert Room. Warning notices are posted in the Concert Room, against the supply of alcohol to minors. In other respects, the Club does not promote any entertainment with a sexual, or immoral content.

#### ANNEX 3 - CONDITIONS AS A RESULT OF A HEARING

#### **Decision of Licensing Sub Committee 30th June 2009:**

The additional conditions to be imposed on the Premises Licence are:

- 1. The outside area may be used for the consumption of beverages only between the hours of 11.00am and 10.00pm and no drinks in open canisters shall be taken out of the Premises at any other time.
- 2. There shall be no waitress service to the outside seating area.
- 3. No drinks shall be taken to the outside seating area other than in polycarbonate glasses. For the avoidance of doubt, no glass bottles or glasses shall be taken outside at any time.
- 4. There shall be no regulated entertainment in the outside seating area.
- 5. No children shall be permitted in the outside seating area at any time.
- 6. The CCTV system currently installed at the Premises in compliance with the condition attached to the Premises Licence shall be extended to cover the outside seating area.
- 7. Employees of the Club must make regular checks of the outside seating area to ensure that patrons are not causing a nuisance to residents by way of noise or disorder and, if they are, action must be taken to desist this. A written record must be kept showing the dates and times of the checks and any action taken. It is the opinion of the Sub-Committee that these checks should be carried out frequently and at least every hour.





You will recall I contacted you a while ago to voice some concerns I had regarding the chair of the club and the running of the same, unfortunately I again feel it necessary to bring to your attention a few ongoing concerns, In particular with reference to the totally unfair treatment of Alison Wilson.

As you are aware I worked behind the bar for around two years and as a result got to know both staff and regulars quite well, I continued to visit the club as a customer mostly on a Wednesday evening to help call bingo and also play bingo.

I am aware that Alison is currently not working at the club due to what I can only describe as a personal vendetta I believe Paul (chair) has against her. I genuinely believe she has been unfairly treated since Paul became the chair and has had to endure what I can only describe as numerous verbal attacks from him. He is dam right rude and walks around like he owns the place, he breaks the fules constantly, drinking behind the bar, using foul language, closing early on occasion, allowing his children in the bar to name only but a few.

Alison was the manager whilst I worked their and I always found her approach to be fair whereas as soon as he became chair he was the complete opposite and was totally unapproachable and acted like he was the manager as it was his club, I therefore made the decision to leave working there.

I currently no longer attend the club like many others as he is just rude and obnoxious.

I'm finding it very difficult to comprehend that he can and is getting away with everything that he is just because he is the chairman. He has gathered all his friends to become committee members and when I attended the AGM he behaved absolutely disgustingly towards myself and refused to allow me to join the committee on the basis that I had not been a member for six months yet then told me that I should have always been a member even when I was employed their. It is absolutely clear to me that since he became the chairman his goal was to get rid of both Les and Alison and not only get his wife a job behind the bar (which might I add would be absolutely fine if she didn't get drunk and play the bandits whilst supposedly working) and then pay himself 16 hours a week for being the chairman.

I would rather my complaint remain confidential as he can be very intimidating and although I felt it necessary to raise the issues as above I'd rather their were no repercussions for myself which I believe there would be if he was made aware of my details.

### Added this on the end

I am worried that the club will end up closing as a result of his behaviour / actions / abysmal running of the club and hope that the CIU can assist Alison in returning to the club, he should not be allowed to use his role to intimidate people the way that he does and he seems to have no regard for employment law whatsoever and just breaks every rule going and does as he pleases.

I am a resident of lamb street Upperby Carlisle, I am writing this letter today after talking to some of my neighbours about the Upperby mens club that is situated right

in front of my house....

I would say for at least the past 6-7 months the coming and goings from the club are really shocking and to be honest a damn right pain for us living on the street. The times that people are locking the place up are a bit disturbing and they have no manners at all as the noise from them is disgusting, in to the early hours of the morning you can hear loud foul and abusive language coming from either the clubs smoking shelter or from people leaving the club.

I my self am not a member of the club and I never have been as I am not a drinker but there seems to be a pattern over the last few months, mainly Friday and Sunday nights are the worst.. Some Friday nights its inbetween 3-5 am when its getting locked up and loud drunk people leaving. Friday just gone you could clearly hear at least 3 loud women in the smoking shelter when they were out having a cigarette and it was nearly 5am when it was getting locked up, the other Sunday night it was after 530 am when you could hear people leaving and it getting locked up. And nearly once a month on a Sunday starting around 930 am a lot of people are seen with pool cues going in to the club and they have been seen outside at 10am drinking in the smoking shelter.. I have looked on line at the club opening times and its nothing untill 11am and the latest on a weekend is 1 am so right away you can see that they are selling alcohol after the right time...

I have lived here for many years and have never really had a problem with noise from the club but with having small children I am very concerned about this ongoing problem, please could you have a word with about there relaxed opening times and about the noise in the smoking shelter . If this matter isn't addressed soon I will be seeing some more of the residents near by and we will contact our local mp.

Good Morning Sue,

As requested please find below an overview of the meeting that Sgt Stuart Campbell & myself attended with Fred & Nicola at the above premises on Friday 16<sup>th</sup> October 2015.

We met with the following persons;

Mr John Paul Ruddick, Chairman

Mrs Linda Baker, Club Secretary

Mr Malcolm Gardner, Committee Member.

We were able to enter the premises through the main entrance doors that were insecure at the time despite secure access facilities provided that were deactivated.

Initially Mr Ruddick outlined that the front door was broken and not capable of being electronically secured and then he activated the system (via a green box on the side entrance) enabling access to be controlled.

Mr Ruddick provided a working demonstration of the controlled entry utilising his key fob that worked.

However, the main entrance door when opened remains wedged open and does not close thereby permitting entry to anyone.

The Club Premises Certificate (CPC) and club rules were available for examination and we established from the outset that no one had any understanding of their club rules or the CPC.

The Club would appear to be openly used for functions that were taking place at the weekend (pool completion on Saturday ) where members of the public were going to be freely allowed admission.

We also established they were hosting three functions planned towards the end of the month where it would appear members of the public would be freely allowed entry.

Advice was given in respect of the rules of the club that permit a member to introduce 3 guests (Rule 34) and further advice was provided in respect of the TEN procedure to facilitate members of the public.

The CPC was discussed that contains conditions that are in some instances are some - what woolly, outdated and duplicated with separate legislation in particular fire safety.

The CPC Summary comprising of 2 pages were correctly displayed in a display cabinet located on the ground floor.

Also displayed were pages 1 & 2 of the CPC that I suggested should be removed.

### Annex 1

As the CPC has not been updated since the introduction of the updated mandatory conditions all members of staff were totally oblivious of the updated mandatory conditions in particular age verification.

The mandatory conditions attached include the following;

Conditions for club premises with off sales

- 1) The supply of alcohol for consumption off the club premises must be made at a time when the premises are open for the purposes of supplying alcohol, in accordance with the club premises certificate, to members of the club for consumption on the premises.
- 2) Any alcohol supplied for consumption off the premises must be in a sealed container.
- 3) That any supply of alcohol for consumption off the premises must be made to a member of the club in person.

The mandatory conditions also contain an embedded condition in relation to recorded music that will have been transferred across from the '64 Act that is some -what unclear;

Provision may be made for the public entertainment in the premises by the reproduction of wireless (including television) broadcasts (or of programmes included in any programme service [within the meaning of the Broadcasting Act 1990] other than a sound or television broadcasting service), or of public entertainment by way of music and singing only which is provided solely by the reproduction of recorded sound.

### ANNEX 2 - CONDITIONS CONSISTENT WITH THE OPERATING SCHEDULE

### General

The Club Management, Stewardess and Bar Staff are aware of the Licensing Act 2003 objectives and statutory requirement to comply with the relevant provisions of the Act. We believe that our Club Rules and the conditions relating to our existing Certificate, have already proved to be quite adequate, in respect of all four objectives, thus while we have no specific proposals for further improvement, we are always prepared to accept further advice.

• On speaking with staff they have no idea of the four licensing objectives or any statutory requirements to comply with the relevant provisions of the Act.

### The prevention of crime and disorder

All past Certificates have been issued subject to inspection/approval by the police, whom have never objected to any application, during my 29 years as Club Secretary. Warning notices are posted against Drugs, Contraband goods, misbehaviour etc., and we have rarely ever, needed to call in the police. Admission to the premises is confined to Members and bona fide guests, and is continuously monitored/controlled, via a computerised/CCTV door entry system.

- This condition is somewhat outdated now bearing in mind there is a new Club Secretary who has been in post since October 2014.
- Warning notices regarding drugs are on display but I would suggest that staff are playing 'lip service' to
  these notices that have no real value or meaning in support of the licensing objectives.
- Admission as highlighted above is not confined to members & bona fide guests and I would suggest is neither continuously monitored or controlled. Page 58 of, 72

### CD12

A tamper proof CCTV system shall be installed at the premises in liaison with and to the satisfaction of the Cumbria Police Licensing and Community Safety Officers and shall be used to record during all hours that a licensable activity takes place on the premises.

- I have spoken with the Constabularies Crime Prevention Officer & the system would appear to have not been checked that comprises of some 8 cameras.
- It has not been established if the system covers all public areas including all entrances and exits.
- The system is contained within a secure cabinet & office.
- We were unable to establish if the system records as no one could operate the system.
- A CCTV monitor has been installed in the downstairs bar to assist bar staff manage the door control system.
   The monitor provides a live image of members (and guests) entering the premises that is available to view by anyone stood at the public side of the bar.
- Advice was given to the repositioning of this monitor to ensure that only staff can monitor the images.
- The system is registered with the ICO registration certificate Z6595611 refers.
- However; the data controller identified as Mr Leslie Armstrong is no longer employed at the premises.
- I have recommended that the ICO be updated with a new data controller.
- There was no CCTV signage on the exterior of the premises to allow members & their guests know they are
  in an area where a surveillance system is in operation. A sign was found inside the premises but there were
  no details of the organisation operating the system, the purpose for using the surveillance system and who
  to contact about the scheme.
- I have recommended that signage be enhanced.

### CD14

Where CCTV equipment is fitted, it shall be maintained in good working order in accordance with the manufacturer's instructions.

- As above, unable to check as no one could operate the system.
- I have recommended that there are members of trained staff at the premises during operating hours able to
  provide viewable copies on request to police or authorised local authority officers as soon as is reasonably
  practicable in accordance with the Data Protection Act 1998.

### CD16

The images recorded by the CCTV system shall be retained in unedited form for a period of not less than 31 days.

As above, unable to verify.

### **Public Safety**

I did no go through the 18 or so conditions attached that largely relate to fire safety. I am aware from the last responsible authority meeting that the fire officer is satisfied with fire safety.

### The prevention of public nuisance

Not discussed.

### The protection of children from harm.

- There was no evidence of any challenge 21 or 25 posters in place at any of the bars.
- There was no evidence of a written age verification policy.

### ANNEX 3 - CONDITIONS AS A RESULT OF A HEARING

The outside area may be used for the consumption of beverages only between the hours of 11.00am and 10.00pm and no drinks in open canisters shall be taken out of the Premises at any other time.

Unable to establish if this condition is being adhered with in the absence of incident book.

There shall be no waitress service to the outside seating area.

Unable to establish if this condition is being adhered with.

No drinks shall be taken to the outside seating area other than in polycarbonate glasses. For the avoidance of doubt, no glass bottles or glasses shall be taken outside at any time.

We were informed that polycarbonate glasses were provided at the premises but it is unclear if this
condition is being adhered with in its entirety.

There shall be no regulated entertainment in the outside seating area.

Unable to establish if this condition is being adhered with.

No children shall be permitted in the outside seating area at any time.

Unable to establish if this condition is being adhered with.

The CCTV system currently installed at the Premises in compliance with the condition attached to the Premises Licence shall be extended to cover the outside seating area.

A single CCTV camera covers the exterior drinking area located at the front of the premises.

Employees of the Club must make regular checks of the outside seating area to ensure that patrons are not causing a nuisance to residents by way of noise or disorder and, if they are, action must be taken to desist this. A written record must be kept showing the dates and times of the checks and any action taken. It is the opinion of the Sub-Committee that these checks should be carried out frequently and at least every hour.

Checks are conducted but the written records comprise of a simple 'tick list' which did not contain dates of when these checks are conducted and we are unable to establish if this condition is being adhered with. Advice & guidance was given to the introduction of an incident preferably an A4 view to day diary to record
activities performed by staff in support of the licensing objectives and conditions attached to CPC.

As discussed with you briefly yesterday, I would suggest that the Club Secretary Linda Baker is oblivious to the concerns that we all have in relation to the management of the premises.

I recommended that she attended a meeting with yourself away from the Club and away from Mr Ruddick that may prove beneficial.

Both Stuart & myself reiterated our concerns regarding the management of the premises in particular surrounding drug misuse associated with the premises that resulted in the drug search conducted at the premises last month in line with our powers contained within S97 LA 2003.

Whilst I acknowledge that many Clubs across the County are struggling and do flout their CPC status by providing commercial services to the public, this type of alleged criminal activity is to my knowledge unheard of.

I would respectfully suggest that whilst you seek legal advice in respect of the action to be taken;

- A written account is provided to the Club Secretary outlining the meeting that took place on Friday and the steps required in support of the licensing objectives, compliance with their club rules and conditions attached on their CPC.
- Further audited meetings at the Club are conducted to ensure that the Club Management are now complying with their club rules and conditions attached within the CPC.
- A joint licensing visit / inspection is conducted after 10pm to establish if the premises are being managed correctly.
- Consideration of a further drug search operation at the premises utilising our specialist teams.
- Consideration of a test purchase operation at the premises that I am aware is currently being planned by Trading Standards later this month / early November.

Invariably, this structured approach will provide further evidence to assist you with your application to withdraw their CPC in line with S90 LA 2003 or support;

- 1. a review application in line with S 87 LA 2003 and / or
- 2. instigate prosecution proceedings for offences contrary to S136 LA 2003 where conditions attached to the CPC are not being adhered with.

In reply to your enquiry in relation to the general conditions which a club must meet in order to be considered a qualifying club I can state:

The club can change its rules following a meeting of the members for that purpose; the club must display the motion on the notice board for two weeks prior to the meeting. Once the motion is passed by the membership then the rule change **must** be recorded with the rules secretary at the C&IU and the FCA, before the rule change becomes effective.

If a club accepts members (without carrying out nomination procedure) as soon as the fee is paid, then the club has breached its own rules as there have been no amendments to rule 7 as far as I can ascertain

The club are clearly in breach of condition 3 if they have failed to honour the trading agreements and loan repayments with both suppliers of alcohol.

The Cumbria branch will only supply the club with goods on a cash basis, due to the club failing to pay for goods in the past and issuing cheques for payment which have bounced. The Cumbria branch of the C&IU have had to take the club to the small claims court and obtain a CCJ against the club for payment.

While it is a recommendation from the C&IU that employees should not be a member of the club as it can cause a conflict of interest, it is up to the club as to how it applies this recommendation.

Both the previous club secretary & Stewardess have both reached settlements with the club following their dismissals and are awaiting their compensation payments.

The club are quite clearly in breach of their CPC as the certificate is issued as a result of the club complying with its own rules, quite clearly this is not the case at Upperby for the reasons stated under not only this section it fails, but all the rest listed.

The club are not operating as a club in accordance with its own rules, a person cannot become a member without the club following the rules as laid out in their rule book, if the club are breaching this rule or chose to disregard the rules, then they are at risk of losing the CPC.

It would appear from the complaints I have received from members of this club that the current regime are running this club more like a public house than a club.

I hope that this brief report is helpful. I am only too pleased to assist in the future if required.

I am Margaret Moir. I have been employed by Carlisle City Council as a District Environmental Health Officer for the last thirteen years. Upperby Mens Institute, Lamb Street Carlisle fall within my enforcement remit in respect of food hygiene, health and safety and nuisance legislation.

On 19 March 2015 I had reason to visit the premises due to receipt of a complaint.


On arrival I immediately noticed very loud music. This was of concern because there had previously been issues with noise nuisance from the smoking shelter. As I walked towards the premises I became aware that the source of the music was from a car that was parked beside the smoking shelter and was surrounded by a group of young men.

When I got to the building entrance I noted the front door was open. This was unusual because at all previous visits it was necessary to press the buzzer to get someone to let me in. During my visit anyone could have walked in as it appears that there was no monitoring of the entrance.

On entering the bar area I had to wait to speak to the barmaid due to the number of people waiting to be served. This was also unusual because at all previous visits there had only ever been a few customers. Just before I was able to speak to the barmaid I noted that one of the young men who had been with the group outside was served. After introducing myself and explaining why I was there, I mentioned about the noise outside to which the barmaid told me that people outside were workmen and didn't usually drink there. She called over a gentleman who she told me was on the committee and who as far as I am aware went out to speak to the group.

On driving away from the premises after completion of my business, I found my windscreen was cracked in my line of vision and my driver's side window was scuffed.
