# Summary:

This report considers budgetary resources originally allocated for 2001/02 to provide health related services in partnership with north Cumbria health economy, social services under the auspices of Carlisle Local Health Group. These resources were categorised as 'C' i.e. general underspends and not automatically allowed to be carried forward by the Executive.

## 1. BACKGROUND INFORMATION AND OPTIONS

- 1.1 The purpose of this report is to inform the Executive of the need to release certain budgetary resources for 2001/02 held by this authority on behalf of the Carlisle Health Group to implement a number of health related initiatives in the district.
- 1.2 The resources set out below are a combination of pooled resources from both the City Council (£10,000) and North Cumbria Health Action Zone (£24,700).
- 1.3 For a variety of reasons, primarily in relation to the elongated processes involved in partnership working and the necessity to determine those areas in the district that would most benefit from interventionist schemes to improve health, these resources have been committed but not spent.
- 1.4 The initiatives are set out in the table below:
