1.0 Background

- 1.1 The City Council is required to prepare a Local Development Scheme (LDS) which sets out the planning policy documents to be produced over a three-year period. Executive considered report DS.102/08 at its meeting on the 22nd September and referred the draft LDS to Infrastructure Overview and Scrutiny Committee for consideration. That report including the draft LDS is attached at appendix 1.
- 1.2 The Executive Report sets out changes to the Local Development Scheme and a draft of the proposed scheme for 2008-2011.

2.0 Issues arising since the Executive Meeting

- 2.1 Since preparation of the draft the Council has sought some clarification from Government Office for the North West (GONW) on two aspects of the draft LDS:
- 2.2 Core Strategy and Allocations DPD Significant land allocations can be made in the Core Strategy. Officers sought clarification on the degree to which the production of an additional Allocations DPD would be necessary. Advice from GONW indicated that it was appropriate to only consider the major strategic allocations in a Core Strategy and that any further land allocations required should be contained in a separate DPD.
- 2.3 Statement of Community Involvement (SCI) Given the delay in production and potential changes to legislation the timing of subsequent stages for the SCI was unclear. GONW advised that whether to re-consult was a choice for the Council. In addition, as the SCI had commenced under the 2004 Regulations an Examination would be required. These points need to be incorporated into the LDS.

1.0 BACKGROUND INFORMATION AND OPTIONS

- 1.1 The Local Development Scheme (LDS) is an integral component of the Local Development Framework. Primarily it sets out a three-year programme of planning policy work on the Local Development Framework and associated evidence base studies. This illustrates how the Local Plans and Conservation team will be utilised in ensuring the Council complies with its statutory planning policy requirements.
- 1.2 The Local Development Scheme is essentially rolled forward each year and any changes/slippage reported through the Annual Monitoring Report which is also a component of the Local Development Framework. Whilst this is usually undertaken in March this year has been an exception due to new guidance produced in PPS12 *Local Spatial Planning* published in June 2008.
- 1.3 The Council's planning policy officers have in recent years undertaken a review of the Local Plan to ensure that the Council has an up-to-date set of planning policies with which to operate. This will also enable work to commence on the Core Strategy setting the strategic spatial policy for the next 15-20 years. This is regarded by Central Government as a key priority for local authorities.
- 1.4 The revisions to this Local Development Scheme have therefore concentrated resources on achieving this priority of producing the Core Strategy. The Core Strategy is also considered to be the key mechanism by which the Council's Growth Bid Expression of Interest can be delivered. Officers are currently working on a Programme of Development for delivery which will be aligned to the Core Strategy process.
- 1.5 Since the Local Plan Inquiry, officers of the Local Plans and Conservation section have been concentrating on the production of Supplementary Planning Documents in order to bring forward additional guidance as identified through Local Plan policies. Whilst there is a commitment to conclude existing work on these as set out in the LDS, the need to undertake additional evidence based work and prepare

- stages of the Core Strategy will remove resources for any additional SPD work.
- 1.6 Appendix A contains a draft of the Local Development Scheme. As this sets out the work priorities for the Local Plans and Conservation section it is considered that Infrastructure Overview and Scrutiny Committee should also be made aware of the resource implications over this period.
- 1.7 Key Changes to the Local Development Scheme include:
 - Remove the Local Plan and Wind Energy SPD as these have been adopted
 - Updating the Core Strategy timetable
 - Re schedule the Statement of Community Involvement this was only partly progressed prior to the Local Plan Inquiry and needs to be redrafted and completed.
 - Re schedule the St Nicholas Area Action Plan Resources are needed to concentrate on the Core Strategy primarily and then focus on other Development Plan Documents as necessary.
 Elements of this will be incorporated in the Core Strategy.
 - Kingmoor Park SPD was to utilise external resources to update the existing guidance but this is delayed
 - Dalston Parish Design Statement was the subject of consultation and the timetable for completion is indefinite
 - North Pennines AONB documents are being produced for the whole AONB but this has been caught up with Local Government restructure in Northumberland and Durham counties.
 - Highways Design SPD is not to be adopted as a Supplementary Planning Document. This could be re-considered as the work progresses however there is currently some overlap with the Urban Design and Public Realm Framework SPD
 - Add in a new SPD for Energy Efficiency
 - Update the evidence base

2.0 CONSULTATION

2.1 Consultation to Date

No formal consultation is required for production of a Local Development Scheme although informal discussions are encouraged with officers from agencies involved in any of the work and also with Government Office and the Planning Inspectorate regarding appropriateness of content and timing. These discussions are currently ongoing and will be reported to Executive as part of the final preparation of this LDS.

4.0 REASONS FOR RECOMMENDATIONS

4.1 To ensure Members are made aware of the statutory obligations of the Local Development Framework and the potential workload for officers and Members over the three-year period.

5.0 IMPLICATIONS

 Staffing/Resources – The Local Development Scheme which forms part of this report will fully utilise the resources of the Local Plans and Conservation Section. There will also be the need to utilise other staff resources whether in Economic Development, Housing, Green Spaces, Leisure, Legal Services etc as required for evidence studies and policy development. External resources may also be required for specialist information e.g. Strategic Flood Risk Assessment update, Market Analysis, Examination in Public

- Financial The financial resources of the Local Plans and Conservation Section are limited. Some work will coincide with growth bid studies for which some finance has been forthcoming to develop the bid. Other resources will also be available from the Planning and Housing Delivery Grant however additional resources for Examination in Public, document production, etc will have to be identified.
- Legal The provision for the Local Development Scheme and Local Development Framework are set out in the Planning and Compulsory Purchase Act 2004 and associated regulations.
- Corporate The Council's corporate priorities will be delivered through documents contained in the Local Development Framework as identified in the LDS.
- Risk Management Programming of work through the Local Development Scheme should take into account the ability to minimise risks although there is a recognition that the LDF process is resource intensive
- Equality and Disability These will be incorporated in the work of the LDS
- Environmental Sustainability and environmental issues are integral to work contained within the LDS
- Crime and Disorder Incorporated where relevant e.g. Designing out Crime SPD
- Impact on Customers Part of the LDS includes a Statement of Community Involvement setting out requirements for consultation

APPENDIX A

DRAFT LOCAL DEVELOPMENT SCHEME 2008-2011

INTRODUCTION

This is the third Local Development Scheme (LDS) for Carlisle District and provides information on how Carlisle City Council intends to produce its Local Development Framework (LDF) over the period 2008-2011. The LDS serves two purposes:

- It sets out the documents that form the development plan for the Carlisle District area:
- It sets out the programme for the preparation of local development documents over a 3 year period including timetables for the various preparation stages of the LDDs.

The Regional Spatial Strategy (RSS) sets the overall spatial context for local planning policies. This is currently contained within RPG 13 but is being updated. The North West Plan (RSS) is now in its latter stages and the Secretary of State's Proposed Modifications were published in March 2008. It is envisaged that it will be adopted early in this LDS schedule. Documents produced in the LDS must have regard to the RSS.

The sub-regional planning context is provided by the Joint Structure Plan, which was adopted in April 2006. This will be a saved document until April 2009 or RSS is adopted, some aspects may be wholly incorporated within the emerging RSS and its sub-regional policies. The RSS will specify which Structure Plan policies remain in force and which have been superseded.

The policies within the adopted Carlisle District Local Plan have been reviewed and the City Council has recently adopted the Carlisle District Local Plan 2001-16 which is a 'saved' document for at least three years from the date of adoption (9 September 2008). The new LDF will incorporate the Local Plan with additional documents being adopted to provide additional guidance and keep the policies and proposals up-to-date.

Initially the Local Plan will provide the spatial context and any documents must have regard to the Plan's strategy. In time, this part of the Plan will be replaced by a separate Core Strategy document as detailed in this LDS. All other documents must conform to the Core Strategy.

The Council has a number of Supplementary Planning Guidance documents. Where these are to be updated/revised they will be reproduced as Supplementary Planning Documents and listed in the attached schedule.

PROGRAMME

A graphic illustration of the timetable to be included

(i) HOW THE LDF IS STRUCTURED

The LDF will comprise the Local Development Documents (LDDs) identified in the previous schedule and contained in more detail in the profiles. The 1997 Local Plan has been under review and will shortly be adopted to ensure continuous policy coverage during this transitional period. This will provide a "saved" plan until at least 2011. The Core Strategy will become the main focus and DPDs will start to update policies. Additional DPDs may need to be produced as the policies are monitored or where updates are required (i.e. to incorporate changing legislation/guidance). This LDS will be updated to include new DPDs where necessary.

Some SPDs will be prepared with direct links to saved policies in the Local Plan as outlined in the schedule.

Statement of Community Involvement (SCI)

The SCI has been under preparation but team resources focussed on reviewing the Local Plan. It is now important to complete work on the SCI. Its relationship with the DPDs/SPDs is that it identifies the processes by which the community will be engaged in consultation on each type of document and at every stage of its preparation. In addition the SCI will also identify how the community will be engaged in the consideration of major development control decisions.

Strategic Environmental Assessment (SEA)/ Sustainability Appraisal (SA)

SEA/SA is a process that will ensure that social, economic, and environmental considerations are fully taken into account at every stage of preparation for each DPD produced. All DPDs and the Core Strategy will need to undergo SEA/SA as required by legislation.

Core Strategy

Following the expiry of the "saved" plan, the Core Strategy becomes the principal document in the LDF. This contains the Council's vision and spatial strategy for the future development of the District. It will identify the development needs for the District and the broad locations for new developments to meet these needs. A key diagram will be used to illustrate this strategy. It will be prepared to be in conformity with RSS and will have regard to the Council's Community Strategy. The preparation of the Core Strategy is the LDD with which all other DPDs/SPDs need to be in conformity.

Generic Development Control Policies

The Core Strategy will not contain the generic development control policies. These will be contained in the saved Local Plan. Policies within this document will be

applicable District wide. These policies will provide a discrete and succinct basis for which the detail of specific development proposals can be considered. These will need to be updated for changes in government policy statements or changes to the Regional Spatial Strategy.

Presentation of LDF

The LDF will be presented as a wallet with each of the DPD/SPDs identifiable. This will enable the documents to be amended and updated easily without the necessity of having to reprint the whole LDF each time. It also means that all of the District Council's planning policies will be contained within one folder at all times. There will still however be a need to have regard to the "saved" Joint Structure Plan, the Minerals and Waste LDF produced by the County Council, and the RSS produced by GONW, all of which will be published separately to the Carlisle City Council LDF. The full version of the LDF will also be placed on Carlisle City Council's web site.

(ii) THE EVIDENCE BASE

The principal technical studies which will be used in the preparation of the LDF and their anticipated timetable for review/updating is given in the table below:

The Council will via the Annual Monitoring Report monitor the need to update these studies and when appropriate commission new studies.

Evidence on other issues and topics will be obtained from other sources as required.

(iii) MONITORING AND REVIEW

Monitoring systems are already in operation to monitor the Local Plan including the post of a full-time Monitoring Officer. The systems are being revised for the production of the reviewed Local Plan to ensure not only that the implementation of the LDF is achieved but also to ensure that the evidence upon which the LDF is based is still relevant and up to date. This information will be collated via the AMR. The AMR is available on the Council's web site.

Monitoring will be undertaken by the Local Plans and Conservation Section, using other internal or external resources where necessary or appropriate.

The AMR will include an assessment of

- whether policies and related targets or milestones in LDDs have been met or progress is being made towards achieving them, or the reasons why they are not being met.
- what impact the policies are having on national, regional and local targets and any other targets identified in LDDs;
- whether the policies in the LDDs need adjusting or replacing because they are not working as intended or are not achieving sustainable development objectives; and
- if policies or proposals need changing, suggested actions to achieve this.

A structured approach to identifying revisions to the LDF will be taken linking the review programme to the AMR and LDS annual update. This does not, however, preclude revisions at other times if circumstances deem it necessary.

(iv) SUPPLEMENTARY PLANNING GUIDANCE

There are proposals to replace some current SPGs with SPDs and these are contained in the schedule. There are seven SPGs that are to be updated as SPD in the future, and these are

- > Trees on Development Sites (currently under review)
- Countryside Design (to be programmed)
- Cumbria Design Guide (currently under review)
- > Designing out Crime in Residential Areas (currently under review)
- Burgh-by-Sands Parish Design Statement (to be programmed)
- ➤ NP AONB Agricultural Buildings Design Guide (currently under review)
- NP AONB Design, Maintenance and Adaptation of Rural Buildings (currently under review)

These seven existing SPGs will be saved and linked to Local Plan policies until they are updated under the new Regulations to SPD.

In addition, the following SPGs will continue to be linked to Local Plan "saved" policies:

- Advertisements
- Shopfronts
- Morton Masterplan and Development Framework
- Former Carlisle Engineering Site Development Brief

Any new guidance will take the form of SPD.

(v) ADOPTED SPD

Denton Holme and Longsowerby Design Statement SPD – January 2006 Cumbria Wind Energy SPD – September 2008

(vi) SAVED POLICIES

The Secretary of State has issued a Direction that 111 of the policies in the adopted (1997) Carlisle District Local Plan are "saved" and are listed in the Appendix of this LDS. In addition the Council will have regard to "saved" policies of the Joint Structure Plan.

(vii) STAFF RESOURCES

The Council's Local Plans and Conservation Team is responsible for all the planning functions except development control and enforcement. The team comprises of:

Principal Local Plans Officer*
Local Plans Officer (x2)*
Landscape Architect/Tree Officer
Monitoring Officer

Principal Conservation Officer
Conservation Officer
Planning Technician
Administrative support

In addition to the above staff resources the planning policy team will work with Carlisle Renaissance on a number of SPDs and DPD during the life of this Local Development Scheme. This will utilise external resources such as Urban Design to supplement the team as appropriate.

Where appropriate, private sector consultants will be commissioned to undertake work on the Council's behalf, particularly in respect of technical background studies. Although the Local Plans Officer posts primarily work on the LDF other posts will contribute as required dependent on the nature of the documents prepared.

The retention of existing staff is fundamental to securing progress on the Local Development Framework and to meet the targets set out in this Local Development Scheme.

The Local Plans and Conservation Manager will take responsibility for overall programme management, including ensuring that the annual monitoring report is produced on time and that the information is fed into the annual review of the LDS. Through the Council's constitution any policy decisions on the development plan are taken by the Council's Executive and full Council.

(viii) JOINT WORKING WITH OTHER PLANNING AUTHORITIES

The County Council will continue to have a strategic planning role working on the Cumbria Sub-regional Spatial Strategy elements of the RSS as well as assessing and monitoring development against the RSS. The County is also committed to assisting with any county wide planning issues which may require additional guidance.. Continuing liaison with the County Council will be necessary to ensure that successful co-ordination occurs, and staffing implications are understood.

Carlisle City Council currently participates on the Highway Design SPD working group and the Landscape working group although recent decisions mean that these will not be preparing a SPD in the first instance. It also works collaboratively with other authorities on Sustainability Appraisal and Monitoring through the Monitoring Officers Working Group. Joint working is undertaken also to assist in data collection such as the biodiversity evidence database for Cumbria.

(ix) FUTURE PRIORITIES

^{*} These 4 posts will concentrate on progressing LDDs.

The City Council has given careful consideration of which Local Development Documents it should produce. This has been influenced by policies and proposals in the emerging Local Plan and RSS. Completion of the main Development Plan documents of the LDF will be the Council's top priority, in particular the need to bring forward the Core Strategy and additional housing and employment allocations. This is evidenced by the growing need to improve the economic performance of Cumbria and work on Carlisle Renaissance economic strategy. Every effort will be made to progress the proposed SPDs according to the LDS milestones, but should available resources be not maintained, it is the SPD timetables which are likely to suffer. The Annual Monitoring Report will address the issue of commitments and resources, when assessing progress on LDDs.

Ongoing reviewing and monitoring of the LDS will identify the potential to bring forward any additional LDDs where practical and possible.

(x) RISK ASSESSMENT

There are a number of risks which could arise during the LDS preparation

STAFF TURNOVER

This LDS has been programmed based on all posts within the team being filled. Should any vacancies arise the implications of this on the LDS outputs will be considered in order to ensure any slippage is minimised. Contingency plans will be put in place eg. Use of consultants, secondment of staff, or joint working arrangements with other local authorities.

SOUNDNESS OF DPDS

This risk can be minimised by working closely with the regional Government Office and PINS at all milestone stages and in the run up to submission of DPDs. Lessons from the examination of other DPDs will be learnt. The self assessment 'Tool Kit' will be used.

LEGAL CHALLENGE

This will be minimised by ensuring that DPDs are "sound" and founded on a robust evidence base and well-audited stakeholder and community engagement systems. Community involvement will be monitored against the Statement of Community Involvement.

PROGRAMME SLIPPAGE

Unforeseen delays in the production and political approval of LDF components could prejudice achievement of the published programme. Additionally, issues of consultation fatigue and the limited response capacity of various community groups and stakeholders could lead to resistance to the timescales which could prejudice the programme. The LDS has been revised to take account of such factors and should minimise future risk in this area.

NEW LEGISLATION, GUIDANCE OR REGULATIONS

National Planning guidance is continually under review. At any time new policy guidance may trigger a need to amend / review LDDs and affect timescales for their preparation. Likewise, new legislation or regulations could significantly affect the contents of the LDS and the timescales and milestones against any document.

The Documents that a local planning authority must prepare, and which have to be subject to rigorous procedures of community involvement, consultation and independent examination. It will include the following elements:

- Core strategy
- Site specific allocations of land
- Area action plans; and
- Proposals map (with insets)

LDF Local Development Framework

The LDF will contain a portfolio of Local Development Documents which will provide the local Planning authority's policies for meeting the community's economic, environmental and social aims for the future of their area where this affects the development of land

LDD Local Development Document

Local Development Documents will comprise Development Plan Documents, Supplementary Planning Documents, the Statement of Community Involvement and the Strategic Environmental Assessment/Sustainability Appraisal

LDS Local Development Scheme

SA Sustainability Appraisal

Assessment of the social, economic and environmental impacts of the policies and proposals contained in the LDF.

SCI Statement of Community Involvement

Document explaining to stakeholders and the community, how and when they will be involved in the preparation of the LDF and the steps that will be taken to facilitate this involvement.

SEA Strategic Environmental Assessment

Assessment of the environmental impacts of the policies and proposals contained in the LDF.

SPD Supplementary Planning Document

SPDs are intended to elaborate on the policy and proposals in Development Plan Documents.
