The reason for the decision by the Executive was to make appointments to Outside Bodies for 2013/14.

The reasons given by the Members for the call-in was "Rationale of decisions".

The call in members highlighted the following nominations and gave reasons for their concerns:

LGA Rural Commission – Two urban ward councillors had been nominated to the Rural Commission and it was understood that the Members did not attend the Rural Commission meetings. It was suggested that it would be more beneficial to appoint two rural ward councillors to the Commission.

Cumbria Health Scrutiny Committee - Health fell under the remit of Community Overview and Scrutiny Panel . The two nominations to the Committee were not Members of the Community Panel and it was felt that they should be to assist with communication between the City and County Councils.

Tullie House and Museum Art Gallery Trust Board – Councillor John Mallinson had been nominated. In cross party representations it had been traditional for the Leader of the Groups to be asked who they wished to be nominated as representative. Had Councillor Mallinson been asked who he would like to be nominated or if he would like to be nominated himself? The decision had always previously been made by the Leader of the Group.

Downagate Community Centre Management Committee – Councillor Graham had been nominated as the City Council representative he had, however, also been nominated to the Committee by the County Council as well which resulted in him representing two authorities.

The Deputy Leader; and Economy and Enterprise Portfolio Holder responded to each of the Panels concerns. He clarified that the rationale behind the nominations had not changed from that of previous Leaders and nominations had been made based on the Members position ie Leader or Ward Member or based on the individual's specific relationship to that community. The late Leader of the Council had made most of the nominations and he had put a lot of thought into the nominations.

He then responded to each of the Panels concerns:

Tullie House and Museum Art Gallery Trust Board – It was understood that Professor Hendry had a lot of respect for Councillor Mallinson and he had felt that the representation on the Tullie House Board should include the Leader of the Conservative Group to move the Board on to the next stage.

Councillor Mallinson was in attendance at the meeting and commented that Professor Hendry had discussed the nominations for Tullie House with him several times but had not reached a conclusion. Professor Hendry had wanted a Conservative member to be a representative on Tullie House and the last discussion had suggested that the nomination should be the Leader of Deputy Leader or the Group alongside the Leader or Deputy Leader of the Council and the relevant Portfolio Holder but there had not been a resolution. Downagate Community Centre Management Committee – He reminded the Panel that the nominations on outside bodies helped Councillors support those that they represented. Councillor Graham had previously campaigned to get funding for Downagate alongside support from Councillor Mrs Parsons. Councillor Graham had approached the Conservative Group when the funding had been secured to become a representative and he had received a poor response. The Community Centre sat close to the border of two wards and served both of the wards. It was felt that it had been unfair to have only one ward represented so Councillor Graham had been appointed in 2012 in the hope that another opportunity came up that would ensure Councillor Mrs Parsons was also on the Committee. Councillor Mrs Parson had been invited by Downagate to join the committee as a co-opted member, however, not as a City Council representative. The Portfolio Holder had not been aware that Councillor Graham had also been nominated to the Committee by Cumbria County Council.

A Member commented that he had felt it was wrong not to have the Ward Councillor as the representative on Downagate Community Centre Committee and felt that this was the opportunity for the Executive to reconsider their decision and have Councillors Mrs Parsons as the City Council representative and Councillor Graham as the County Council representative.

The Deputy Leader; and Economy and Enterprise Portfolio Holder explained that, due the death of the Leader, a further report on representative on outside bodies would be taken to a future meeting of the Executive to appoint to vacancies.

Cumbria Health Scrutiny Committee – Councillor Bowditch had nominated due to his vast experience and knowledge in health and with young people. The appointment had been based on his skills, knowledge and experience.

A Member commented that health was a subject frequently considered by the Community Overview and Scrutiny Panel and she felt that it would be helpful to have a Community Member as the representative to provide up to date information to the Panel.

The Deputy Leader; and Economy and Enterprise Portfolio Holder reminded the Panel that they were able to ask Councillor Bowditch to attend Scrutiny just as they did with officers and Portfolio Holders.

LGA Rural Commission – He was aware that the nominations were both urban members and he assured the Panel that the rural area was just as important as the urban area. It was felt that the LGA needed representation from the Executive to ensure a two way flow of information between the LGA and the Council. He took on board the information regarding attendance and agreed to look into the matter further. If the representation did change it would be important to ensure that information is fed back from the LGA.

RESOLVED – That the matter be referred back to the Executive for reconsideration and that the Executive be asked to ensure that the observations and comments of the Panel be taken into consideration when appointments are being made to outside bodies.
