1. Development Session

Members attended a development session on 15th July 2010 to look at the Panel's Work Programme for this Civic Year. Notes of the session are attached at Appendix 1 for information. The work programme has been amended to reflect the decisions made at the Development Session and Members are asked to approve the amended Work Programme which is attached at Appendix 2.

Members who attended the session may recall that no decision was made on an area to undertake a in-depth scrutiny review although some ideas were proposed. Members are encouraged to make a decision at this meeting.

2. Forward Plan Items

The Forward Plan of the Executive covering the period 1 September to 31st December 2010 was published on 16th August 2010. (Appendix 3 to follow)The issues which fall within the remit of this Panel are as follows.

KD026/10 - Charging for Statutory Notices under the Housing Act 2004 – the Panel are requested to consider whether they wish to consider this item at the next meeting of the Panel on 7th October 2010.

KD006/10 – Women and Families Homelessness Accommodation – the Panel are requested to consider whether they wish to consider this item at the next meeting of the Panel on 7th October 2010. See paragraph 4.

3. Special Meeting

A special meeting for the Panel has been arranged for <u>10am on Tuesday 12th October</u> <u>2010 at Harraby Community Centre</u>. This meeting is to consider the evaluation of the Community Empowerment Pilot as agreed at the meeting of the Panel on 10th June 2010. Members are requested to consider if they wish to invite any partners to this meeting. The Rural Policy will be considered at the ordinary meeting of the Panel on 7th October 2010.

4. Women and Families Homelessness Accommodation

This is a project for the replacement of the hostel for women and families who are homeless which is at 69 London Road. That facility has been in use as a hostel since 1975 and the facilities need to be replaced and brought up to modern standards. A specification for replacement accommodation has been worked on since 2008. Currently

further work is being undertaken to review all sites within local authority ownership to look for the site that fits the criteria for the project in order to take it forward. This work will be reported to the Executive on 4/10/10 and will be available for scrutiny by this Panel at the meeting on 7th October 2010.

5. Accommodation and Foyer Service Development for Young People

The original proposal was that a partnership between the City Council and the YMCA (England) would convert the building owned by the YMCA in Fisher Street into a self contained foyer with 17 units of accommodation and support/training facilities on site. This project had to be reviewed due to the lack of capital funding available through the bids made by the YMCA (England) to Government. It is envisaged that accommodation and foyer services will be taken forward including a number of partners working together using a 'pathway' approach to service delivery for young people in need of accommodation and/or support. The resource centre currently being built by the Council will be the 'hub' for provision of the support services. It is expected that a report on this issue will be available in the Autumn.

Community Overview and Scrutiny Development Session 15th July 2010

Members were informed that the purpose of the session was to:

- Review Work Programme
- Identify areas for Subject Review/Task and Finish work
- Identify Lead Members for topics
- · Identity gaps in knowledge

Members started the session by having a general discussion on the workings of the Panel. Members generally believed that the Panel worked well last year and the Chair was thanked for the amount of work that she had put in behind the scenes.

In the Civic Year 2009/10 the Panel held 14 meetings, including 3 special meetings and spent nearly 30 hours in formal meetings considering a total of 34 substantive agenda items. This is compared with the year previous whereby the Panel had the same amount of meetings but only spent 20 hours scrutinising 42 substantive items.

Task and Finish groups were discussed and generally Members felt that this was a positive way of working and enabled them to get really involved in a topic which could produce real outcomes. It was agreed that there should be more Task and Finish Groups over the next year.

Members had a discussion about the Community Centre work, particularly the working group. Protocol had now been developed for scrutiny members appointed to working groups, however it was agreed that this was not be the preferred way of working.

Cllr McDevitt stated that he would like the Panel to undertake some further work on Community Centres. It was felt that this would occur naturally through developments from locality working especially after the meeting re Harraby and Longtown Pilots. Community Centres should continue to be monitored via improved scrutiny of the budgets.

Members discussed the areas where there could be duplication of work, particularly regarding Tullie House Governance and the Sands Centre Business Plan and probably scrutiny of the budgets. It was agreed that Community O&S would like to continue with the Tullie House Trust Development and invite two Members of Resources O&S. Resources O&S could then be responsible for the scrutiny of the Sands Centre Business Plan and invite

2 Members of Community O&S to their deliberations. Thus enabling a saving around scrutiny administration time and resource, and would broaden the view of both scrutiny panels with this joint input.

Session with Portfolio Members and Officers

Councillor Luckley attended the session along with Jason Gooding, Deputy Chief Executive, Keith Gerrard, Assistant Director (Community), Allan Dickson, Principal Housing Officer (Private Sector), Simon Taylor, Housing & Health Services Manager and Steven O'Keefe, Policy and Performance Manager.

The objective of this session was to inform Members of priorities, ongoing work and future developments of Policy over the next 12 months. Scrutiny Members would then be able to plan their work programme accordingly and may also identify areas of pre-policy work.

The following were suggested:

- Opportunities for O&S to engage with the community in policy development.
- Locality Working could be an area that they Panel undertake further work. This may
 be in conjunction or parallel to any work undertaken by Economy & Environment
 O&S on Area Working Teams. Ideally T&F should spring from special meeting
 around Harraby & Longtown Pilots
- Healthy City and Economic Development, how the Council makes a contribution
- Cuts in services/protection of services how scrutiny can influence decisions and prioritise services - Better Scrutiny of the financial plans
- Affordable Warmth The panel need to meet the new officer Affordable Warmth
 Officer with Alan Dickson and remember that Affordable Warmth will be normally be
 considered in conjunction with Affordable Housing and Health by the Alan so the
 panel to see what he presents and could light the way to T&F
- Changes to performance indicators and assessments

Budget Scrutiny was discussed and it was agreed that Cllrs Clarke and Bradley would attend the meeting of ROSP on 29th July 2010 where the Medium Term Financial Plan was to be discussed.
