**Title:** CLIMATE CHANGE STRATEGY

**Report of:** Head of Environmental Protection Services

**2. BACKGROUND INFORMATION AND OPTIONS**

1. The Government's UK Climate Impacts Programme (UK CIP), in partnership with the Local Government Association and the Improvement and Development Association, has recently published guidance for local authorities on the preparation of 'Climate Change Strategies'. The UK CIP has, in addition, published a report which predicts the possible changes to

the UK's climate as a result of the continuing emissions of greenhouse gases (principally Carbon Dioxide). This report, which provides a fascinating vision of the future, can be accessed on <http://www.ukcip.org.uk/scenarios>.

2. The Government has set a target for the UK to cut its CO<sub>2</sub> emissions by 20% below 1990 levels by 2010. Whilst the Council is already taking action that is helping to cut greenhouse gas emissions, for example by managing its own energy consumption and promoting home energy efficiency measures, the guidance states that a Climate Change Strategy would enable authorities to develop and broaden their response to future climate change.
3. More specifically, the guidance states that the production of a Climate Change Strategy would enable an authority to:
  - i. identify the range of actions that the Council should undertake in the future in order to protect public assets from the negative effects of climate change;
  - ii. help ensure that Council services are able to cope with the climatic changes associated with the expected future changes in temperature and rainfall;
  - iii. detail the actions that local authorities have put, or will put, in place in order to reduce the emissions of greenhouse gases;
  - iv. help identify how addressing climate change can assist in tackling social issues such as fuel poverty.

1.4 In addition to the above, the Government has indicated that the production of a Climate Change Strategy could help an authority to access future funding (for example: the Local Authority Carbon Management programme can provide capital funding for implementing energy saving measures in council owned buildings). Therefore, whilst it is not a statutory duty, a Climate Change Strategy could help deliver significant benefits to the Council.

## 1. Proposed response:

1. As a corporate strategy, the production of a Climate Change Strategy would require inputs from across the Council's business units. However, it is proposed that, if agreed, its production would be co-ordinated by the Head of Environmental Services, recognising the significance of the environmental impacts of climate change. The input from the Council's partners, most notably Eden District Council and Cumbria County Council, will need to be considered.
2. It is also proposed that the Head of Environmental Services will arrange for widespread consultation on the Strategy to be developed through the Carlisle Environment Forum and the Overview and Scrutiny process. A further report to Executive will then outline the scope of a Climate Change Strategy, and the likely time scale involved in its production.
