LC.04/16 UPDATE ON LICENSING ACT 2003
The Licensing Manager presented report GD.11/16 giving Members an update on the applications under the Licensing Act 2003.

The Licensing Manager reported on the licence figures as 4 February 2016.
In 1 April 2015 new legislation came onto the statute book which removed the requirement to renew personal licences and therefore all current licences lasted indefinitely. License holders had been contacted regarding the change and notified should they wish for their licence to be updated to 'indefinite' rather than their expiry date at a cost of $£ 10.50$. Since April 2015 there had been 72 amended licences issued. Licences that were not updated would show an expiry date but would actually still be valid.

LC.05/16 GAMBLING ACT 2005 -UPDATE
The Licensing Manager presented report GD.12/16 giving Members an update on applications made under the Gambling Act 2005.

The Licensing Manager highlighted the licence figures as at 4 February 2016.
She reported that officers were undertaking visits to all Club Premises to ensure compliance certificates and conditions were being adhered too. Gambling premises and licensed premises were also being visited to ensure any 'crane grab' machines were correctly licensed as category D machines as was recommended by the Gambling Commission.

In response to a Member's question the Licensing Manager explained that officers were checking Club Premises licences to make sure Club's understood and followed any conditions attached to their licence and operating schedule. The summary of a licence had to be displayed within the premises but the conditions attached to the licence did not.
