# RP.72/22 MINUTES OF PREVIOUS MEETINGS

RESOLVED - That Council, at its meeting on 3 January 2023, received and adopted the minutes of the meeting held on 23 November 2022. The Vice Chair signed the minutes.

# RP.73/22 HACKNEY CARRIAGE DRIVER- FAILURE TO PRODUCE REQUIRED DOCUMENTS

The Licensing Officer submitted a report regarding a Hackney carriage Driver who failed to provide the Licensing Authority with required documents in order to ascertain his continued fitness and propriety to hold the Licence (GD.71/22).

The Hackney Carriage Driver was not in attendance. The Regulatory Panel agreed to hear the matter in his absence. The Hackney Carriage Driver had submitted a statement to be read in his absence. The statement disclosed that the Driver had recently received a medical diagnosis which had been unexpected and set out his personal position and the reasons he had not submitted the required forms. He was a licensed driver in a different licensing authority and was returning to Carlisle, therefore would be submitted the required documentation.

The Licensing Officer reported that the Hackney Carriage Driver's licence had commenced in June 2021 and expired in 2024. From April 2022 the Licensing Authority undertook DVLA checks via Know Your People and a mandate form was

sent to the Driver in March 2022. The Licensing Officers contacted him several times in the meantime; a new form had been provided for the Driver to check and sign, however the necessary information required to process the check had not been received.

A further letter was sent on 27<sup>th</sup> October 2022 notifying the Driver that the matter would be referred to the Regulatory Panel for consideration.

The Panel raised concerns regarding the fit and proper test that had to be applied to licenced drivers. They questioned whether the Driver had a recent medical examination for his licence. The Licensing Manager confirmed that Drivers were required to undertake a medical examination every three years, therefore the Driver would be due the next medical in 2024.

The Licensing Officer drew Members' attention to the legislation which they must take account of and set out the options for the Panel.

The respective parties then withdrew from the meeting whilst the Panel gave detailed consideration to the matter. The respective parties returned, and it was

RESOLVED - That the Panel Members had read report GD.71/22 and listened carefully to all the evidence heard today from the Council's Licensing Officer and considered the statement the Hackney Carriage Driver had submitted in his absence.

The Panel noted that the Driver had failed to provide his completed mandate form despite several reminders and a new form being sent to him.

Having carefully considered all the evidence before them, the Panel decided to:

Suspend the Hackney Carriage Driver's Licence until such times as he provides the required signed KYP mandate form and required to him to undertake a new medical examination.

The reasons for the decision were:

1. The Driver had failed to provide essential information to the Licensing Office despite numerous requests.

2. The Licensing Office were unable to carry out the necessary checks without the form and were thus unable to issue a licence.

3. The Panel had to be satisfied that the Driver was a fit and proper person to hold a Hackney Carriage Driver's licence.

### RP.74/22 HACKNEY CARRIAGE DRIVER- FAILURE TO PRODUCE REQUIRED DOCUMENTS

The Licensing Officer presented a report regarding a Hackney Carriage Driver who failed to provide the Licensing Authority with required documents in order to ascertain his continued fitness and propriety to hold the Licence (GD.72/22).

The Hackney Carriage Driver was not in attendance. The Regulatory Panel agreed to hear the matter in his absence.

The Licensing Officer reported that the Hackney Carriage Driver's licence had commenced in August 2020 and expired in 2023. From April 2022 the Licensing Authority undertook DVLA checks via Know Your People and a mandate form was sent to the Driver in March 2022. The Licensing Officers contacted him several times in the meantime; a new form had been provided for the Driver to check and sign, however the necessary information required to process the check had not been received.

A further letter was sent on 27<sup>th</sup> October 2022 notifying the Driver that the matter would be referred to the Regulatory Panel for consideration.

The Licensing Officer reported that it was understood that the Driver was no longer driving.

The reasons for the decision were:

1. The Driver had failed to provide essential information to the Licensing Office despite numerous requests.

2. The Licensing Office were unable to carry out the necessary checks without the form and were thus unable to issue a licence.

3. The Driver was no longer driving a Hackney Carriage and did not wish to attend the meeting.

### RP.75/22 HACKNEY CARRIAGE AND PRIVATE HIRE DRIVER- FAILURE TO PRODUCE REQUIRED DOCUMENTS

The Licensing Officer presented a report regarding a Hackney Carriage / Private Hire Driver who failed to provide the Licensing Authority with required documents in order to ascertain his continued fitness and propriety to hold the Licence (GD.73/22).

The Hackney Carriage / Private Hire Driver was not in attendance. The Regulatory Panel agreed to hear the matter in his absence.

The Licensing Officer reported that the Hackney Carriage Driver's licence had commenced in October 2021 and expired in 2023 and the Private Hire Licence commenced in 2020 and expired in 2023. From April 2022 the Licensing Authority

undertook DVLA checks via Know Your People and a mandate form was sent to the Driver in March 2022. The Licensing Officers contacted him several times in the meantime; a new form had been provided for the Driver to check and sign, however the necessary information required to process the check had not been received.

A further letter was sent on 27<sup>th</sup> October 2022 notifying the Driver that the matter would be referred to the Regulatory Panel for consideration.

The Licensing Officer reported that it was understood that the Driver was no longer driving but no contact had been made from the Driver regarding the issue or the referral of the matter to the Panel.

The Licensing Officer drew Members' attention to the legislation which they must take account of and set out the options for the Panel.

RESOLVED - That the Panel Members had read report GD.73/22 and listened carefully to all the evidence heard today from the Council's Licensing Officer and noted that the Hackney Carriage / Private Hire Driver did not attend the Panel and it was believed he was no longer driving.

The Panel noted that Hackney Carriage / Private Hire Driver had failed to provide his completed mandate form despite several reminders and a new form being sent to him.

Having carefully considered all the evidence before them the Panel decided to revoke the Hackney Carriage Driver's Licence and Private Hire Driver's Licence.

1. The Driver had failed to provide essential information to the Licensing Office despite numerous requests.

## Purpose / Summary:

The Licensing Authority sets the rate of fare for Hackney Carriages (Taxis) in the District. The Council's Hackney Carriage and Private Hire Licensing Policy 2022-2027 states that the tariff will be reviewed bi-annually or following a request from the trade.

The tariff was last reviewed in February 2022 (implemented from April 2022) and would be due to be reviewed in February 2024, however a request had been made from Carlisle Hackney Carriage and Private Hire Association to consider an increase to the Table of Fares.

### **Recommendations:**

That members consider the request from the Association and, if a change to the Table of Fares for Hackney Carriages is proposed, agree this subject to consultation.

# 1. Background

- 1.1. Hackney Carriage (taxis) are a vital form of local transport. Local Authorities have the power to set the maximum fares of taxis which they licence.
- 1.2. Section 65 of the Local Government (Miscellaneous Provisions) Act 1976 (Appendix 1) states that

"A district council may fix the rates or fares within the district as well for time as distance, and all other charges in connection with the hire of a vehicle or with the arrangements for the hire of a vehicle, to be paid in respect of the hire of hackney carriages by means of a table (hereafter in this section referred to as a "table of fares") made or varied in accordance with the provisions of this section."

- 1.3. By fixing the fares, the Council is effectively setting the maximum fare that Hackney Carriage drivers can charge. Legally, taxi drivers may charge less than this but may not charge more.
- 1.4. The fares set by the Council include provisions for taxi drivers to earn a wage, cover the costs of running a taxi and providing a service to the public when it is needed whilst ensuring that fares are reasonable for the public to pay for such a service.
- 1.5. The last review of the table of fares was undertaken in February 2022 and the fares were increased by 12% on the national benchmark 2 mile journey (from £5.80 to £6.60).
- 1.6. The Council's Hackney Carriage and Private Hire Policy 2022-2027 states that it is good practice to review the fare scales at regular intervals, and will therefore, consider the fare scales on a bi-annual basis or sooner if a request is received by the trade.<sup>1</sup>

# 2. Proposals and initial consultation

- 2.1 Carlisle Hackney Carriage and Private Hire Association ("the Association") contacted the Licensing Manager in December 2022 to request that the Table of Fares be reviewed due to the increase in inflation and costs of living.
- 2.2 The proposal tabled by the Association was as follows:
  - A reduced distance to the first click
  - Waiting time increased from 20p to 30p per minute
  - Tariff 1 to start at £3.80 (currently £3.40)
  - Tariff 2 to start at £5.10 (currently £4.50)

- Tariff 3 to start at £5.60 (currently £5.10)
- Soiling charge to increase to a maximum of £50 (currently £35)
- 2.3 In the same period some disquiet had also been received by the trade by way of several emails to the Department objecting to any proposed increase. It was therefore decided to gauge a wider view of the Trade prior to reporting to the Panel.
- 2.4 Carlisle City Council currently licence a total of 235 Hackney Carriage Drivers and 106 Private Hire Drivers (341 licences). 27 drivers hold both licences, leaving a total of **314 individuals** who were invited to complete a survey.
- 2.5 The results of this initial consultation are as follows:
  - 127 individuals completed the survey (39%) 90 Hackney Carriage Drivers, 23
    Private Hire Driver and 12 drivers who hold both a Hackney Carriage and Private
    Hire Driver Licence.
  - 98 respondents agreed that the existing tariff of fares should be revised (77% of respondents and 31% of drivers in total)
  - 27 respondents disagreed that a revision was necessary (23% of respondents and 9% of drivers in total).

Comments on the proposals from respondents can be found at Appendix 2.

2.6 In order to review the fares, the Council's Financial Services produce the changes to the RPI to the identified criteria for transport costs since the last review. These changes have been multiplied by the weighting agreed with the Taxi Association with the main costs being fuel, labour and insurance. The calculations show an average increase in costs of 11.68% since the last figure were received in October 2021 and overall inflation is currently running at 14%.

2.7 The current flag fall is £3.40 for the first 1000 meters and 20p for each subsequent 160 yards (approximately 146 meters) or uncompleted part thereof. (Appendix 3 – Current Table of Fares)

2.8 The proposal from the Taxi Association is that the Tariff 1 flag fall is increased to £3.80 and this would result in the following increase to a Tariff 1 journey.

2.9 Carlisle would be ranked 1<sup>st</sup> of the 6 Cumbria Councils for the benchmark 2-mile journey and will be ranked within the 132-147 of the 359 authorities in the country for a 2-mile journey who all have a £7.00 fare. The national average 2-mile journey for Tariff One is £6.93. (Appendix 4)

- 2.10 The proposals to change the flagfall for Tariff 2 and Tarrif 3 are in line with the rate increase (ie plus  $1/3^{rd}$  for Tariff 2 and plus  $\frac{1}{2}$  for Tariff 3).
- 2.11 The above does not take into account the proposal from the Association to reduce the distance to the first click (currently 1000 meters) as the proposals take Carlisle above the national average and the most costly in Cumbria without this taken into consideration.
- 2.12 Members also need to consider the requests to increase the waiting charge from 20p to 30p per one minute and to increase the soiling charge to a maximum of £50.
- 2.13 Members will be aware that Cumberland Council will be established from April 2023. Taxi policies from the sovereign authorities (Carlisle, Allerdale and Copeland) will remain until such a time a single policy for Cumberland is approved. At this point it may be proposed that there is one tariff for the Cumberland district. For information the Table of Fares for Allerdale and Copeland are attached at **Appendix 5**. Copeland are not reviewing their maximum fare prior to April 2023. Allerdale BC Regulatory Committee are to receive a report on 6<sup>th</sup> February 2023 and no change to the tariff is recommended. A verbal update will be given to the Panel.

## 3. Risks

3.1 Any tariff will need to be adopted in accordance with the relevant legislation.

### 4. Consultation

- 4.1 In accordance with Section 65 of the Local Government (Miscellaneous Provisions) Act 1976, the Council must publish their proposed table of fares in at least one local newspaper and a notice placed at the Council Offices for a period of 14 days.
- 4.2 If no objections are received, or are subsequently withdrawn, by the closing date of the 28<sup>th</sup> February 2022, the new tariff will apply from the 31<sup>st</sup> March 2023.
- 4.3 Any objections will be heard by the Regulatory Panel on the 15<sup>th</sup> March 2023 and the tariff shall come into force, with or without modification, on the 31<sup>st</sup> March 2023.

### 5. Recommendations

- 5.1 That Members take one of the following options
  - subject to consultation, members agree, other than the reduction in distance to the first 'click', the proposed changes to the Table of Fares for Hackney Carriages; or,
  - That no change is made to the Table of Fares at this time.

# Local Government (Miscellaneous Provisions) Act 1976

### **1976 CHAPTER 57**

#### PART II

#### HACKNEY CARRIAGES AND PRIVATE HIRE VEHICLES

#### 65 Fixing of fares for hackney carriages.

- (1) A district council may fix the rates or fares within the district as well for time as distance, and all other charges in connection with the hire of a vehicle or with the arrangements for the hire of a vehicle, to be paid in respect of the hire of hackney carriages by means of a table (hereafter in this section referred to as a "table of fares") made or varied in accordance with the provisions of this section.
- (2) (a) When a district council make or vary a table of fares they shall publish in at least one local newspaper circulating in the district a notice setting out the table of fares or the variation thereof and specifying the period, which shall not be less than fourteen days from the date of the first publication of the notice, within which and the manner in which objections to the table of fares or variation can be made.
  - (b) A copy of the notice referred to in paragraph (*a*) of this subsection shall for the period of fourteen days from the date of the first publication thereof be deposited at the offices of the council which published the notice, and shall at all reasonable hours be open to public inspection without payment.
- (3) If no objection to a table of fares or variation is duly made within the period specified in the notice referred to in subsection (2) of this section, or if all objections so made are withdrawn, the table of fares or variation shall come into operation on the date of the expiration of the period specified in the notice or the date of withdrawal of the objection or, if more than one, of the last objection, whichever date is the later.
- (4) If objection is duly made as aforesaid and is not withdrawn, the district council shall set a further date, not later than two months after the first specified date, on which the

table of fares shall come into force with or without modifications as decided by them after consideration of the objections.

- (5) A table of fares made or varied under this section shall have effect for the purposes of the Act of 1847 as if it were included in hackney carriage byelaws made thereunder.
- (6) On the coming into operation of a table of fares made by a council under this section for the district, any hackney carriage byelaws fixing the rates and fares or any table of fares previously made under this section for the district, as the case may be, shall cease to have effect.
- (7) Section 236(8) (except the words "when confirmed") and section 238 of the <sup>M1</sup>Local Government Act 1972 (except paragraphs (c) and (d) of that section) shall extend and apply to a table of fares made or varied under this section [<sup>F1</sup>by a district council in England] as they apply to byelaws made by a district council [<sup>F2</sup>in England].
- [<sup>F3</sup>(7A) Section 8(5) and section 19 of the Local Government Byelaws (Wales) Act 2012 shall extend and apply to a table of fares made or varied under this section by a council for a county or county borough in Wales as they apply to byelaws made by a council for a county or county borough in Wales.]
