2. Detailed Scrutiny Work

There has been some progress on the work as detailed below:

- Older People Cllrs Riddle and Clarke met with Susan Trafford on Wed 24th
 Feb for an initial discussion about the potential for involvement in policy
 development work relating to Older People. This is an informal piece of work
 and arrangements will now be made to ensure that this is pursued in the next
 Civic Year.
- Joint Crime and Disorder Scrutiny the group held a workshop on Monday 15th March. This workshop included the scrutiny Members from Eden and Carlisle along with representatives from the Police Authority and the Leadership Group of the Carlisle and Eden CDRP. This workshop made progress on the following:
 - Developing the Protocol between the Scrutiny Members of Carlisle and Eden Councils and the CDRP:
 - Developing terms of reference for the proposed Joint Carlisle and Eden CDRP Scrutiny Panel;
 - How existing protocols for relations between the Cumbria Health and Wellbeing Committee and the District Councils Scrutiny Panels could be tailored for CDRP scrutiny arrangements;

The outcomes of the March workshop will be reported back to the March meeting of this panel. It remains the proposal that the Joint Panel for Scrutiny of the Carlisle and Eden CDRP will be set up from the beginning of the 2010/11 Civic Year.

The Scrutiny Chairs Group met on Monday 1st March. The minutes from the meeting have been circulated to all Scrutiny Members.
