#### STREET COLLECTIONS 2006

#### 1. INTRODUCTION

The City Council each year receives applications to hold Street Collections from many varied charities and organisations, both national and local.

#### 2. STREET COLLECTIONS

- 2.1 All Street Collections (Flag Days) are subject to their organisers receiving permission from the Local Authority. In 2005 the Panel authorised 15 collections in Carlisle together with all those requested in Brampton (3). In 2004 there were 14 collections in Carlisle and in 2003 there were 21.
- 2.2 In addition, a further 37 "one-off" money raising charity events were authorised throughout the year by the Head of Environmental Protection Services on condition that they did not clash with those authorised by Committee. These collections were all accompanied by some form of street entertainment, display or national event passing through the City.
- 2.3 Organisers of all Street Collections are required to give details of their collections on a formal Statement issued to them at the time they receive authorisation for their venture. The Council should receive this within one month of the collection taking place. As can be seen from tables A1 and A2 all of the charities that were granted a collection last year, and have re-applied, have complied with this condition with the exception of Uncaged Campaigns (an anti-vivisection charity) and it is therefore recommended that their application is refused.

#### 4. RECOMMENDATIONS
