Title:- **DEVELOPMENT CONTROL STATISTICS:  
OCTOBER-DECEMBER 2003**

## Summary:-

The Report summarises the key findings of the recently issued Statistical Release from the Office of the Deputy Prime Minister concerning the relative performances of Planning Authorities in England and Wales for the final quarter of 2003.

- 1.1 During the final quarter of last year District Planning Authorities in England and Wales received a total of 154,000 applications for planning permission and other related consents, the largest number received for that quarter since 1988 and a 4% increase over the equivalent period in 2002. The highest recorded increases was in the North Eastern (12%) and North Western regions (11%), but it is notable that the rising number of applications in the East of England and the South East regions was small (1%), while those in London actually fell by 1%.
- 1.2 The number of decisions made nationally also increased by 3% to 149,000, which is also the highest recorded for the quarter since 1988. Again, all regions except London and the South East saw an increase in the number of decisions, with the North East (18%) and the North west (9%) again leading the way.
- 1.3 The recent trend for the greatest increase in applications being associated with householder submissions was maintained, increasing from 73,200 in October-December 2002 to 77,600 for the final quarter of 2003. This is followed by a rising number of applications for new dwellings, up from 17,000 to 18,600 over the year from October-December 2002. Householder applications now account for over half of all decisions, while new dwellings account for 12% of the total of all decisions.
- 1.4 The speed of decisions made also demonstrated an improvement, with 73% of all applications decided during the final quarter of 2003 being within 8 weeks of receipt (6% up on the comparable period in 2002). Quickest decisions were made in the East Midlands region (75% within 8 weeks) with the North East, West Midlands and the South West being slowest (71%). Similarly when measured over the longer 13 week period, 87% of all decisions were made within that time scale, a rise of 3%.

- 1.5 Members are aware that the Government specifically measures the relevant performances of Local Planning Authorities in dealing with "Major", "Minor" and "Other" applications within the target time scales that have been set and that these are instrumental in determining the level of Planning Delivery Grant awarded to each Council. It will be recalled that the objectives are for 60% of all "Major" applications to be decided within 13 weeks of receipt, 65% of decisions on "Minor" applications to be made within 8 weeks and 80% of all decisions on "Other" applications to be made within the 8 week period. Nationally, the respective average speed of determination of those types of application during the quarter (in comparison with those targets) was 52% (Major), 62% (Minor) and 78% (Other), which represent improvements of 9%, 8% and 6% over the same quarter in 2002.
- 1.6 The Statistical Release is of particular relevance in identifying how each Authority fares in determining applications. Of the 362 District Planning Authorities in England and Wales all but one Council supplied statistical information in time for publication.
- 1.7 Carlisle City Council made a total of 1356 decisions for the year ending on 31 December 2003, 93% of those decisions being "approvals", with 71% of those decisions being made within 8 weeks of receipt of the application. That represented the highest number of decisions made by any of the Cumbrian Planning Authorities. During the final quarter of the year, the Council made 335 decisions on applications, again highest in the county, with 70% of those decisions being within 8 weeks. The level of delegation during that quarter was 81% of applications which remains below the Government target of 90%, which both Allerdale BC and Eden DC achieved, but is higher than the other Districts in Cumbria.
- 1.8 The Council's performance in the three categories of applications that are now specifically recorded shows that for the full year, ending on 31 December 2003, 40% of "Major" applications were decided within 13 weeks, the lowest in Cumbria. Although Carlisle had significantly more of that type of application; 60% of "Minor" applications were decided within 8 weeks, the third best in the county; while 78% of "Other" applications were decided within 8 weeks (equalling fourth in Cumbria).

- 1.9 More tellingly, however, the statistics for the Council's performance during the last quarter of the year reveal that 67% of "Major" applications met the 13 week target, 59% of "Minor" applications met the 8 week target and 77% of "Other" applications met the 8 week target. Thus, the Council met the Government's target for "Major" applications but fell below the 65% and 80% targets set for "Minor" and "Other" applications. While the improvement in the key "Major" category is welcome (it is 50% points higher than the preceding quarter (July-October)), the dip in the other two categories comes as a disappointment after the very good performance in the preceding quarter when 68% of "Minor" applications and 84% of "Other" applications were decided within 8 weeks of receipt. In mitigation, the number of actual decisions that were made was higher, compared to the previous quarter (9 compared to 6 for "Major" applications, 115 compared to 94 for "Minor" applications; 211 compared to 195 for "Other" applications). Moreover, the overall total of all decisions made by the Council in that final quarter (335) was again higher than the preceding quarter (295). Members may also wish to note that the total number of applications "on hand" at the start of the quarter (316) was higher than any other Cumbrian District and the City Council again received the highest number of new applications within the quarter (333).
- 1.10 It is, thus, inevitable that the increasing workload that has been experienced and is continuing to be experienced will have an effect upon the turnover of decisions, but that aspect is being monitored to ensure the maximum efficiency in the delivery of the Development Control service.
