Subject Matter

Pursuant to Minute EX.065/12, the Communities and Housing Portfolio Holder presented report CD.36/12 concerning the Carlisle and Eden Crime and Disorder Reduction Partnership (CDRP)'s work programme for the coming year in the form of their Partnership Plan.

She reminded Members that the new Partnership Plan, attached at Appendix 1 to the report, formed part of the Council's Policy Framework and replaced the existing plan (2011/12). The Plan had been developed by the CDRP's Leadership Group with input from the City Council's lead Officer (Director of Community Engagement) and previous Portfolio Holder, and in consultation with all CDRP partner organisations. It had also been developed in direct consultation with the Carlisle and Eden Joint CDRP Scrutiny Panel at their meeting on 28 March 2012, the Minutes from which had been circulated.

The Communities and Housing Portfolio Holder was pleased that the issue and perception of anti-social behaviour was recognised within the Plan. She emphasised the importance of engaging with communities and taking their views into account.

The Executive had, at its meeting on 1 June 2012, referred the matter to the Community Overview and Scrutiny Panel for further consideration. The Panel had, however, resolved that it would not be considered as an individual Agenda item. A copy of Minute Excerpt COSP.42/12 had been circulated.

The Chairman of the Community Overview and Scrutiny Panel advised that the Panel had approved the Minutes of the Carlisle and Eden Community Safety Partnership Joint Scrutiny Panel. She added that, following discussion, it had been resolved that Carlisle City Council consider withdrawing their Membership from the Joint Scrutiny Panel. In order to take the matter forward, the Community Overview and Scrutiny Panel would

consider the matter at their July meeting and pass their recommendations back to the Executive.

In light of the above, the Communities and Housing Portfolio Holder recommended that the Executive give consideration to the Joint Scrutiny Panel Minutes; and refer the Plan to Council in accordance with the Council's Policy Framework.

The Environment and Transport Portfolio Holder seconded the recommendations.

DECISION

That the Executive had considered the Minutes of the Carlisle and Eden Community Safety Partnership Joint Scrutiny Panel held on 28 March 2012; and referred the Carlisle and Eden Crime and Disorder Reduction Partnership Plan to Council in accordance with the Council's Policy Framework.
