**GAMBLING ACT 2005** 

Title:- APPLICATION UPDATE

Local Authorities took over responsibility for issuing premises licences under the Gambling Act 2005 on 1<sup>st</sup> September 2007. This report gives an update on the current position regarding applications made under this legislation.

# To the Chairman and Members of the Licensing Committee on 12<sup>th</sup> September 2007

This report is presented to give an update on the current position under the Gambling Act 2005.

#### **BACKGROUND**

- 1.1 The Gambling Act 2005 received Royal Assent in April 2005. The main thrust of the new legislation was that Local Authorities took over the responsibility for licensing gambling premises from the Licensing Justices. In addition, the Gambling Commission was formed from the old Gaming Board of Great Britain and has responsibility for licensing operators and personal licence holders.
- 1.2 Over the last two years Officers have been building up their knowledge of the new legislation and Members have received training in their new responsibilities in respect of hearings.
- 1.3 This committee considered a report in February 2007 in connection with the fee structure and delegated authority under the legislation. The City Council subsequently agreed the proposals that the setting of fees and other functions under the Gambling Act 2005 be delegated to the Licensing Committee.
- 1.4 A number of dates were published for existing licence holders to make application to their local authorities during the transitional period:
  - Applications received between 21<sup>st</sup> May and 30 July 2007 were granted continuation rights and could continue to operate.
  - Applications received between 1<sup>st</sup> and 30<sup>th</sup> August 2007 were granted grandfather rights, but could not operate until their licences were issued.
  - The date for the changeover was 1<sup>st</sup> September 2007.
- 1.5 With the exception of one premise (where a variation application is pending) all gambling premises within this local authority area had made their applications by 27<sup>th</sup> July 2007. The licences have not yet been issued due to the late publication of relevant regulations. Once our computer software company has amended the programme the licences will be issued. As the applications were received before 30<sup>th</sup> July they have continuation rights to operate as normal.

#### **CURRENT LICENCES**

3.1 In addition to the new premises licences under the Gambling Act 2005, the council already has responsibility for a number of other gambling permits:

## 3.2 **Gaming Machine Permits**

These are granted to alcohol licensed premises and local authorities have been responsible for their issue since November 2005. The permit lasts for three years but became a Licensed Premises Gaming Machine Permit under the new Act with effect 1<sup>st</sup> September 2007.

### **Small Lottery Licences**

These permits have been the responsibility of local authorities for many years and come under the new legislation with effect 1<sup>st</sup> September 2007. They are usually issued to charities or clubs were there is no personal gain. They annual fee becomes due on 1<sup>st</sup> January each year.
