Title: REVIEW OF PARISHES - SOLPORT AND STAPLETON

### Summary:

A request has been received from Solport and Stapleton parishes that they be grouped under a common parish council. This Report explains the process involved and recommends grouping of the parishes.

### Recommendations:

That the Council make an order under Section 11 of the Local Government Act 1972 to group the parishes of Solport and Stapleton under a common parish council named 'Solport and Stapleton Parish Council' with a view to the first elections to the new council being held on 3<sup>rd</sup> May 2007.

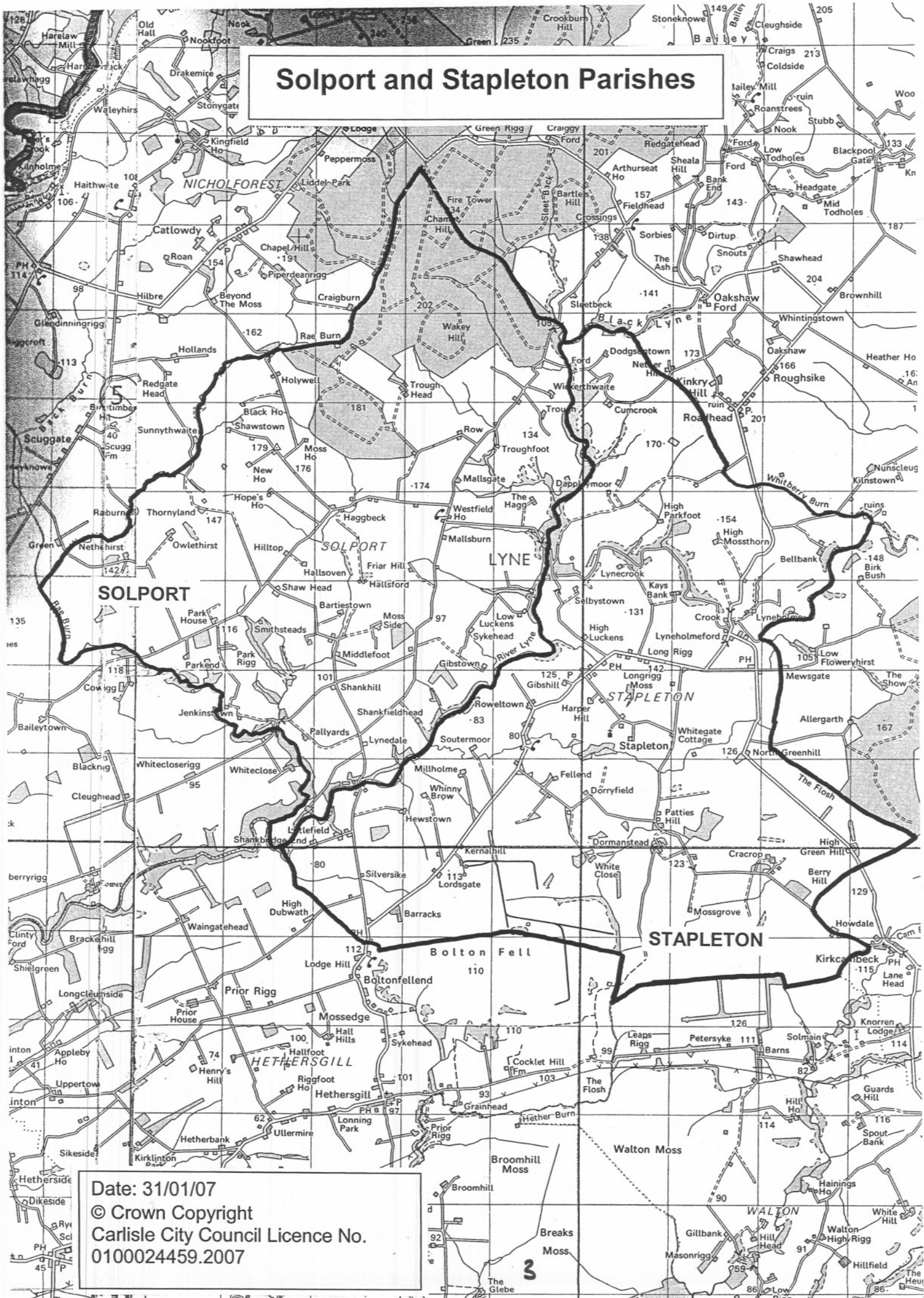

- 1 The Local Government Act 1972 provides for the grouping of neighbouring parishes so that a single parish council can be formed to represent the area of both parishes. Grouping can be used where small parishes no longer require a separate parish council but wish to retain their existing boundaries because they still reflect local community identity. While abolition and creation of parishes requires the approval of the Secretary of State, the City Council has power under Section 11 of the Act to make grouping orders. Parishes, however, cannot be grouped without the consent of the parish meeting of each of the parishes concerned.
- 2 A request has been received from Solport and Stapleton parishes that they should be grouped under a common parish council. The proposal has been agreed by meetings of both parishes. Solport and Stapleton are adjoining parishes in the Lyne ward of the City, north east of Carlisle (see attached map). They have scattered electorates of 142 and 195 respectively; the only centre of population in either parish is the small settlement of Stapleton.
- 3 Grouping would allow the parishes to pull their resources for the benefit of their local communities and operate more efficiently with a single Council and one Clerk. Consultation and communication with other authorities and agencies would also be improved. When undertaking parish reviews, district Councils must have regard to the need 'to reflect the identities and interests of local communities and to secure effective and convenient local government'. These wider aims would be met through the grouping of Solport and Stapleton.
- 4 When grouping parishes, consideration also needs to be given to the number of members to serve on the joint parish council. Parish councils must have at least 5 members and there is no maximum number. In the City Council's area, the sizes of parish council vary widely between 5 and 15 members (see Appendix). A joint meeting of Solport and Stapleton parish councils expressed the view that the number of representatives from each parish on the new council should remain as at present, i.e. 5 from Solport and 7 from Stapleton. This would retain the current balance of representation between the two parishes, reflecting their relative sizes, but the arrangements could be reviewed at a future date if necessary.
- 5 It is suggested that the common parish council be named 'Solport and Stapleton Parish Council'.
- 6 The regular four-yearly elections to both parish councils are due to be held on 3<sup>rd</sup> May, 2007. If a grouping order were made before formal notice of those elections was given on 23<sup>rd</sup> March, elections to the new parish council could take place in May.

That the Council make an order under Section 11 of the Local Government Act 1972 to group the parishes of Solport and Stapleton under a common parish council named 'Solport and Stapleton Parish Council' with a view to the first elections to the new council being held on 3<sup>rd</sup> May 2007.
