# **Summary:**

The City Council has provided £56,470 in 2003/04 in respect of grants to Parish Councils for the provision of concurrent services. This report details the formula for distribution of the grants and includes a schedule detailing the grant to each Parish Council.

## FINANCIAL ASSISTANCE TO PARISH COUNCILS

### 2003/04

## 1. INTRODUCTION

- 1.1 For many years the City Council has provided a revenue grant to Parish Councils as a contribution towards the cost of concurrent services provided by the parishes.
- 2. For 2003/04 the grant available for Parish Councils has been increased from £55,090 (2002/03) to £56,470.

#### 1. GRANT DISTRIBUTSION FOR 2003/04

- 2.1 The proposals agreed between the Parish Councils and the City Council (as subsequently amended) on the distribution of grant are as follows:
- (i) The amount of grant awarded in support of expenditure incurred in maintaining public cemeteries would be at 40% of the expenditure incurred by the Parish Councils concerned in the previous financial year;
- (ii) The grant awarded in respect of general support of concurrent services would be the balance of grant available after first meeting the cost of burial grant. This would be distributed in proportion to the balance of the previous year's parish precept after first deducting the burial expenditure;
- (iii) The reason for basing the distribution on the previous year's precept (rather than the current year) is so as to be able to advise Parishes with greater certainty on the level of grant they are likely to receive at the time that they are considering their annual precepts.
- 2.2 The total precepted levies for 2002/03 made by the Parish Councils totalled £246,855 and after deducting certified burial expenditure of £12,471 there is a

balance of £234,384 on which a general grant in respect of concurrent services can be paid.

2.3 Grant on burial expenditure at 40% absorbs £4,988 leaving a balance of £51,482 which represents a rate of 21.96% of the balance of concurrent services, after first deducting certified burial expenditure.
