### Summary:-

A national working group was formed 18 months ago to produce model national conditions for places of entertainment. These conditions have been published and are available for adoption by local authorities. A local working group has discussed the conditions and consider them worthy of approval.

## To the Chairman and Members of The Licensing & Regulatory Panel 17<sup>th</sup> April 2002

### SUMMARY

In 2000 a national working group was formed to produce model national conditions for places of entertainment. Draft conditions were sent out to interested agencies for consultation early in 2001. The definitive conditions were published on 1<sup>st</sup> February 2002.

Schedule 1 of the Local Government (Miscellaneous Provisions) Act 1982 permit licensing authorities to make regulations prescribing standard conditions applicable to all or any class of entertainment licence. Previously the majority of councils, including this Council, have based their standard conditions on the publications, *Model National Standard Conditions and Model Rules of Management for Places of Public Entertainment*. Both of these documents have been withdrawn.

The *Model National Standard Conditions* have been designed to ensure consistency throughout the country and have the support of many national organisations including:

The Association of British Theatre Technicians

The District Surveyors Association

### **The Local Government Association**

The British Institute of Innkeeping

The British Entertainment and Discotheque Association

Councils are, therefore, encouraged to adopt them as they stand and avoid the temptation to make additional standard conditions or to change these model conditions. Any additional conditions should be added as Special Conditions for particular premises.

At the Licensing and Regulatory Panel on 6<sup>th</sup> March 2002 it was decided to form a small local working group consisting of Members, Officers, Police and Fire Service to consider the proposal. This group met on 21<sup>st</sup> March when various aspects of the proposals were discussed, including implementation date, attaching Special Conditions and the wording of the Technical Regulations. Agreement was reached to recommend to this Panel that the new conditions be adopted immediately and that the City Solicitor & Secretary could impose any reasonable Special Conditions at the request of the agencies. Should there be any dispute regarding these Special Conditions the issue to be referred to the Licensing & Regulatory Panel for decision.

### **OPTIONS**

- 1. To retain the current standard conditions
- 2. To adopt the new model standard conditions with the City Solicitor & Secretary having delegated authority to attach any reasonable Special Conditions at the request of the agencies. Any dispute regarding these to be referred to the Licensing & Regulatory Panel for decision.
