DP Foodbank update –

- Foodbank are moving to Tower Court on West Tower Street, at the former Edenside Carpets store.
- There is a new manager in post, Shane Byrne is keen to speak to her.
- Foodbank Hub Programme developed out of Covid they continue to meet emergency need.
- TR said individuals present to Foodbank with wider ranging needs and if this is now being collated and shared there is an opportunity for wider_officer involvement.
- Foodbank data will be circulated to group. It is one year of comprehensive data, breakdowns parts of city and the issues and challenges being faced in the city

RG update

- Business grants are the main focus
- Council Tax Hardship Scheme no details yet if it will continue
- Test & Trace support for self-isolation payments
- DHP spend projecting overspend. Additional submission required to give more details on DHP spend covid issue.

JK Referrals still being received by Adult Social Care. Continue to help with contact tracing

KO Still operating remotely and dealing with clients, it is working well. DWP online forms useful

PT Continuing as normal, all staff still working from home. DWP on-line forms useful but some clients still reluctant to move to Universal Credit.

MJ Credit Union has worked throughout all online. Clients can apply online to join also access to affordable loans. Payments can be paid into clients account on the same day.

MW said digital inclusion has not been the issue they thought it would

TR update

- Homelessness continuing to work as normal. Strategic homelessness assessment all done remotely, this is easier and more efficient for clients than making appointments face to face and people not always turning up.
- Homeless accommodation available 24 hours to deal with emergencies
- Homeless Accommodation_and Outreach Staff (Rough Sleeping) are being treated as priority for vaccinations.

• Carlisle Homeless Prevention & Rough Sleeping Strategy making its way through the committee cycle. Executive 08 February, Full Council 02March, due to be launched in_April. Establish subgroups to be involved in key priorities
