This report reviews the existing charges for Tullie House, Bereavement Services, Parks & Recreation in the light of the recommendations of the City Council's Corporate Charging Policy.

1. BACKGROUND INFORMATION AND OPTIONS

- 1.1 Each service is required to carry out an annual review of its charges.
 - 1.2 This report proposes the review of a number of charges in respect of Tullie House, Bereavement Services and Parks & Recreation. The report has been prepared in accordance with the principles set out under the Council's current Corporate Charging Policy.
 - 1.3 Appendix A reviews the charges currently in place at Tullie House.
 - 1.4 Appendices B and C are extracts from the charges booklet which show the current and proposed level of charge for Bereavement Services and Parks &

Recreation respectively.

2. CORPORATE CHARGING POLICY

- 2.1 The Corporate Charging Policy that was approved by Policy and Resources on 30 August 2001 sets an income target so as to produce an overall increase in income equal to inflation plus 1%.
- 2.2 Therefore for 2002/03 each service is required to achieve a corporate target for income generation of 3.5% (RPI 2.5% plus 1%) and the increases proposed have been set with this requirement in mind. In addition the policy requires Service Managers to investigate scope for charging for services that have not been traditional charging areas in the past.

Tullie House

Income and Charging Review 2002/2003

A new charging structure was introduced at Tullie house in August 2001 when the Millennium Gallery was opened to the Public. At the same time the Tullie Card was relaunched for the residents of Carlisle and District. There has been a large take up of the Tullie card scheme with over 7,500 card being issued in August and September. This has boosted the footfall to Tullie House, but it has not resulted in an increase in admission income. The visitor profile to the Museum has changed in the last few months as a result of the impact of foot and mouth on the tourist industry. The projected visitor profile for 2001/02 was

This change in profile will affect the admission income targets for this year, current projections estimate a £15,000 shortfall on admission income targets as a direct result of the foot and mouth crisis and the reduction in paying tourists. The admissions shortfall will be offset by approximately £5,000 from an increase in catering sales due to the increased footfall. We are projecting that we will also achieve shop income targets as the increased footfall of local visitors have used the shop resulting in a sharp increase in the number of shop transactions. Targets will not be exceeded as the spend per head has fallen as these are not tourist visitors who would normally have a higher spend per head.

We are not proposing any increase in admission charges for 2002/3 as the charges were raised in August of 2001 as shown below.

The increases were made after research into to admission prices at other visitor attractions in Cumbria. We would propose that we review prices again for the 2003/4 budget year when the above revised prices will have been in operation for just over a year.

Income generation at Tullie House has been erratic this year and has not followed any of the projected targets. The end of year position will not be clear until the whole income and expenditure profile can be assessed. The current climate makes it extremely difficult to project income targets for the next financial year. It is unclear at this time if tourist visits to Cumbria and Carlisle will have recovered by next year especially if the foot and mouth crisis continues. As to the international travel climate we can not begin to project the impact of the attack on New York on both international and domestic travel trends.

Income targets have been included in the Millennium Business plan based on a return to previous levels of tourist admissions to Tullie House with the above increased admission charges. On the basis of this years event these income targets and the millennium business plan now need to be reviewed. We have increased foot fall this year at a time of recession throughout Cumbria this has been due to the support of the local community for Tullie House and the varied programme of exhibitions and events provided by the Museums and Arts service which has ensured repeat visits. However increased admissions income is dependent on the numbers of tourists coming to Carlisle.
