Summary of Options rejected

There are currently six such societies.

Reasons for Decision:

Since April 2004, the Council has had a duty to produce an annual Investment Strategy as part of its overall Treasury Management Strategy. Investment guidance, which came into force at the same time, analysed local authority investments for treasury purposes into 'specified' and 'non specified' categories. Broadly speaking, specified investments are investments with an institution that possesses a credit rating. All other investments are non specified. The Council must declare each year the minimum level that it will hold in specified investments and this level has been set at 50%.

The effect of this decision will be to widen the opportunities for investing the Council's surplus funds. This will at times afford the opportunity for achieving higher returns but without compromising the overriding requirement to maintain the security of the principal sum so invested.
