## **DECISION**

That grants be awarded as follows:-

(a) Carlisle Women and Girls Football Development Group - £450 towards the cost of 2 sets of team kits and publicity and promotional material such as certificates for the girls who participate.

(b) Cumberland News Rifle Club - £150 towards the cost of the total replacement of target holding boards.

(c) Pirelli U8's Football Team - £300 towards the cost of setting up and running an Under 8's football team (or possibly 2 teams) to give younger children the opportunity to play small sided football within the Carlisle area.

(d) Harraby Youth Club - £250 towards the cost of purchasing various sporting equipment for young people.

(e) Low Luckens Organic Resource Centre - £150 towards the cost of materials for 3 workshops to provide quality training or experience for both young people and adults, including storytelling skills, environmental paper making and living willow structures.

(f) Carlisle and Eden Crossroads - £500 towards the cost of expanding their service to the community.

(g) Upperby Methodist Church Short Mat Bowling - £250 towards the cost of purchasing a storage frame for the mats.

(h) Border Harriers and Athletic Club - £1,000 towards the running costs of the Club.

(i) Nicholas Jary - £100 towards the cost of participation in a Raleigh International expedition to Sabah in Borneo in February 2003.

(j) Himaka Jayawardena - £50 towards the cost of joining The National Youth Music Theatre to take part in a production of The Late Sleepers during the summer.

(k) Trip 2000 (Dance Orchestra) - £400 towards the cost of a goodwill tour to Italy via Germany.
