- 1.1 A Petition has been received from residents of Farlam requesting that highway improvements be carried out on the road to and from the village. Due to new developments in the village traffic flow has increased and problems are now occurring on the access road. The residents are requesting the following works to upgrade the road:-
 - The installation of some passing places.
 - Installation of some drainage, to remove the flooding problems which cause soft verges.
