- 1. The final draft of the Best Value Review is attached for member scrutiny.

 - meeting residents' and members' aspirations including ambitious targets to increase disabled pass take-up by 25%
 - reviewing existing policies and administrative procedures, particularly the statutory requirement to extend the scheme to men between 60-64.
 - i. Revised Service Plan Concessionary Fares Targets (Appendix N, pages 117-118)

Together with Action Plan monitoring reports, performance against these revised targets will be the basis on which reports will be submitted for member scrutiny. This will enable members to scrutinise progress on the ambitious Concessionary Fares improvement targets set out in the review.

 - that the Concessionary Fares Scheme has been significantly improved during the 2001/02 review process with 88% of Concessionary Fare passholders preferring the new system (see page 102)
 - sets down a clear and concise three year action plan and monitoring arrangements and targets to ensure that the scheme continues to improve over the medium term.
