- 1. In 23rd. March 1999 a report was commissioned by the then Head of Planning from the company Terraquest Information Management.
- 2. The purpose of the report was to produce for the Council an information audit on the property systems employed by the Council and a Geographic Information Strategy (GIS).
- 3. Terraquest produced their report in November 1999. The cost of the report was £7,500.
- 4. The report produced a number of recommendations and costs on how GIS could be moved forward within the Authority.
- 5. Because of the large capital cost detailed in the report the Council decided at the time not to proceed with the proposal.
- 6. However, since then there have been significant changes in some of the assumptions on which the report was based.
- 7. The introduction of the National Land and Property Gazette, the transfer of services away from the Council, the implementation of some recommendations due to operational reasons and an increased internal demand within the Authority for a GIS system are all factors which impact on the reports original recommendations.
- 8. Moreover, the market for GIS systems has changed significantly and the type of systems that were examined only three years ago are now more affordable.
- 9. These combined factors mean that the original report needs to be updated to take account of the changed circumstances.
- 10. There is an increasing realisation by Officers and Members that a GIS system is an urgent requirement for the Authority along with the shortcomings of the existing Fastmap GIS system. If a new business case were presented based upon new assumptions the Council might arrive at a different decision on GIS.
- 11. It is recommended that a bid of £6,000 be allowed to go forward into the budget cycle to commission a new report to update the Council on the various GIS options open to them.
