RESOLVED that the minutes of the Induction Session held Tuesday 16 November 2010 be approved as a true and accurate record of the meeting.

CEJS/9/1/11 Strategic Assessment

The Members present considered the 2010 Strategic Assessment which detailed the key points and findings. They were advised that the Strategic Assessment is used to assess the success of the 2010-11 Partnership Plan. Those present were advised that the recommended priorities for 2011/12 were:

- Anti-social behaviour to incorporate criminal damage and deliberate fires
- Violent crime to incorporate all aspects of a safer night time economy
- Domestic abuse
- Reducing re-offending

and that in addition to these priorities, the CDRP would respond to community priorities as and when they are identified.

During a discussion about the strategic assessment, Members expressed some concern about the possible reduction in funding for domestic violence support and the impact this may have and about the loss of the DAAT as it was felt that this may lead to an increase in crime generally.

Those present considered future changes regarding the introduction of Police Commissioners and the abolition of Police Authorities and how this would impact on the Community Safety Partnership structure in the future

RESOLVED that the CSP Leadership Group should consider:

- a risk assessment of each of the crime types to decide what the priorities should be for the forthcoming year;
- whether the CDRP structure is appropriate to deliver outcomes and give consideration to efficiency savings;
- working up prospective performance targets for the forthcoming year;
- what has worked and carry out a value for money assessment;
- the affects of the economic climate and do some financial modelling based on funding cuts of 5%, 10%, 15%, 20%, 25% and 70-80%.
- how the effects of the economic climate will be monitored so emerging trends are picked up;
- doing a risk assessment of partnership choices and potential withdrawal from the CDRP or reduced contributions and look at how potential gaps could be filled:
- whether 'hot spots' would be targeted;
- focussing ASB work on repeat victims and vulnerable people.

Also **RESOLVED** that the budget for 2011-12 matched against the activities in the Partnership Plan be forwarded to the Carlisle and Eden Joint CDRP Scrutiny Group as soon as possible for consideration.
