The Council has received a petition from residents in the Cheviot Road / Mulcaster Crescent area related to parking problems which they are experiencing.

1. BACKGROUND INFORMATION AND OPTIONS

- 1.1 The Council currently undertakes parking enforcement in the City on behalf of the County Council, and this includes residents parking schemes. Previous experience has shown that the introduction of residents parking schemes has in some instances displaced parkers to the fringe of that scheme. The extent and impact of this displacement is dependent upon the reasons for parking and the distance involved and alternative provision.
- 1.2 It is not possible at this time to comment on the scale of the problem in this particular location. Certainly there are problems particularly in the mornings and afternoons at school times. It would appear logical to fully examine the problem to assess the best solution.
- 1.3 The body responsible for progressing an investigation, which should include extensive community consultation, rests with Cumbria County Council. Certainly extensions to residents parking schemes have been recently considered and implemented elsewhere in the City.

2. RECOMMENDATIONS

2.1 It is RECOMMENDED that the County Council be encouraged to investigate the parking problems in this area to identify and implement the optimum solution.
