SUMMARY:

The report presents the City Council's performance for the 1st quarter, April – June 2009 as measured by a number of local and national indicators. Best Value indicators are now deleted although a small number have been retained as local measures. Place Survey results, 2008, are included for the first time. Until the Council's new priorities are agreed, we will continue to report performance against Cleaner, Greener, Safer and Learning City.

RECOMMENDATIONS:

The Executive Committee is requested to

- 1. Consider and comment on the information contained in the report with a view to seeking continuous improvement in how the Council manages performance.
- 2. Consider how current performance and satisfaction levels inform the Transformation Programme and review of corporate priorities.
- 3. Refer the report to the relevant Overview and Scrutiny panels for consideration.

1. REASONS FOR RECOMMENDATIONS

To ensure a robust performance management framework that helps the Council to achieve improvement in services that matter most to our local communities.

2. BACKGROUND INFORMATION

The report marks the transition from the Best Value regime to the new performance framework and national indicator set. Many of the national indicators are reported for the first time and will provide baseline data for future years, including Place Survey data. Satisfaction results from the Place Survey are included for the first time in the report which contains comparisons with other Cumbria Councils and all England District Councils. We intend to do further analysis of this data that will enable us to draw conclusions around smaller localities, or geographies, in Carlisle. Other Place Survey results about what local people say are priorities for them, is still to be released.

The City Council continues to develop its performance management framework in order to ensure a robust platform on which to base decisions about corporate priorities and resources, and particularly in order to inform the current Transformation Programme.

3. IMPLICATIONS

- Staffing/Resources developing the organisation's performance management framework is a key area of focus for the Policy and Performance team and has been prioritised within its existing resources.
- Financial work continues to integrate performance and financial monitoring data and information which has proved challenging. We are currently developing a performance framework around the Medium Term Financial Plan, Capital Strategy, and Asset Management Plan. This will enable a more strategic view of Council activity and inform the current Transformation Programme, particularly the review of priorities.
- Legal none
- Corporate a robust performance management framework that is integrated with finance and asset management will help us to determine new priorities for the Council and drive improvements in service delivery.

- Risk Management the risk of the Council failing to deliver its key priorities, achieve continuous improvement and value for money, will be mitigated when a robust, performance management framework is in place.
- Equality and Disability a number of Best Value indicators that measured performance in this area are being retained as management information and will enable us to develop a profile of our own workforce as part of the Pay and Workforce Strategy. The Council did not achieve its target of Level 3 of the Equality Standard for Local Government by March 2009. We have a new target of "Achieving" under the new Equality Framework; current performance is "developing". Much more detailed information will be contained in the Annual Report, August 2009.
- Environmental a number of national indicators measure performance in this area and will continue to be developed as the new priorities for the Council are determined.
- Crime and Disorder a number of indicators measure the Council's performance, in partnership, in this area and are closely monitored by the Crime and Disorder Reduction Partnership.
- Impact on Customers a robust performance management framework will help to drive continuous improvement in front line services for the benefit of our local communities.

1. Executive Summary

The overall measure of performance 'Use of Resources Assessment' 2008/2009 is reaching its final stages with relevant officers completing Key Lines Of Enquiry. As part of the assessment of Data Quality and Performance Management the Audit Commission has identified two national indicators for detailed analysis. The two indicators in question are 'NI 155 Number of affordable homes delivered (gross)' and NI 191'Residual household waste per household'.

2. Corporate Health

2.1 Introduction

There is continual development of our performance framework with new indicators being developed to monitor the Flexitime balances and percentage of staff over or under the threshold value set in the policy at the close of a settlement period.

Work on fitting a performance framework to the priorities 'economy' and 'environment' is at a very early stage of development. The Senior Management Team have agreed to retain the current Key Performance Indicators until the new priorities and associated performance framework are developed more fully in a corporate plan.

2.2 Personnel

Sickness absence is on target, albeit a much less ambitious target than last financial year. The risks to the performance are higher this year than ever before. The corporate risks are:

- Implementing the new pay model
- Reorganisation
- Flu pandemic

These are going to place increased pressure on the workforce, it is likely that the greatest cause of sickness absence - 26.5% (as reported in 2008/2009) - 'stress, depression, mental health fatigue syndromes' will continue to dominate.

These identified risks are all likely to increase the likelihood of not reaching our target for 2009/2010. Recommendations have been made to prepare for the specific risks associated with the Flu Pandemic and these are presented in a separate Flu Pandemic Risk Register in the Business Continuity Plan. The current estimate from NHS North West Public Health is for 100,000 cases a day in the UK. At the end of the year 2008/09 12.5% of our absences were due to infections (including colds and flu). This figure will be a baseline for any changes over the coming months.

2.3 Finance

Integrating financial reporting remains a key objective for both performance and finance officers. A new approach is being taken, fitting a performance framework around the Medium Term Financial Plan.

The Value For Money (NI 179) end of year figure and target have been revised prior to submission to the national database, the revised figure and target now mean that we performed well in 2008/2009. The estimation for 2009/10 is an ambitious target, it is set locally, and there is an opportunity through both the Carlisle Focus magazine and the Countywide Consultation Steering Group to explore the public perception of value for money beyond the single question in the Place Survey (MI963b).

Developing a clearer understanding of Value For Money within the organisation and integrating these measures into our performance reports will assist a fresh approach to integrating financial and performance information.

2.4 Activity

The predicted poor performance for property lettings has materialised. The figure is an estimate; the actual figure is unlikely to take the performance into the 'green'.

2.5 Customer satisfaction and opinion

Satisfaction and opinion measures from the Place Survey.

These indicators have been coded and added to Covalent. It is worth noting that four of the indicators (BV119a,c,d,e) are replicas of the Best Value User Satisfaction Survey, namely:

BV119a satisfaction with sports/leisure facilities

BV119c satisfaction with museums / galleries

BV119d satisfaction with theatres and concert halls

BV119e satisfaction with parks and open spaces

The information for these indicators was included in the End of Year Report. The downward trend is now confirmed across all these comparable indicators. Compared to all the districts in England we fall into the lowest group for satisfaction with keeping public land clear of litter and refuse; refuse collection; and theatres and concert halls. Satisfaction with museums and galleries places us in the best performing group.

The indicators that attract the most attention are:

MI963b percentage that strongly or tend to agree local council provides value for money? MI964b percentage satisfied with how council runs things.

The round up of authorities in Cumbria is presented in the table 2 below.

It is worth noting that the confidence levels for each of these figures have been delivered within the specification of the Place Survey Manual, a confidence level of 95% with +/- 3% confidence intervals .In the example of MI964b we can say that we are 95% confident that the population are between 36.8% and 42.8% satisfied with how the council runs things.

We have the highest Cumbria percentage for 'value for money', above the North West average. Overall satisfaction with how the council runs things is marginally below Allerdale and South Lakeland. All Cumbria authorities are below the North West average.

3. Priorities

3.1 Cleaner, Greener, Safer

Poor performance in 'NI 196 Improved street and environmental cleanliness – fly tipping' has triggered additional work from the Policy & Performance Team. We are gathering the base data from the Waste Team and the Customer Contact Database (CRM), as well as Impact Housing's Furniture Project to understand more fully the possible causes of the collapse in performance from 'very effective' to 'poor' in improving street and environmental cleanliness – fly tipping. A separate exception report will be produced with key recommendations by the end of July.

3.2 Learning City

Promoting access to learning remains a key objective for teams working on the Learning city priority. There is disappointing performance across key indicators relating to museums and galleries, in each case the trend is a quarter on quarter decline in performance.

4 Carlisle Area Assessment

4.1 Safer and Stronger Communities (Carlisle)

The majority of national indicators from the Place Survey fall into the thematic group 'Safer and Stronger Communities'. It is worth noting that crime and disorder remains the single most important issue for people in making somewhere a good place to live. However it is no longer in the top three of issues that most need improving in the local area. We fall into the lowest group compared to all the Districts in England for:

- NI 1 % of people who believe people from different backgrounds get on well together in their local area
- NI 3 Civic participation in the local area
- NI 6 Participation in regular volunteering

We fall into the best group compared to all the Districts in England for:

- QoL23 NI 4% of people who feel they can influence decisions in their locality
- NI 21 Dealing with local concerns about anti-social behaviour and crime issues by the local council and police
- NI 27 Understanding of local concerns about anti-social behaviour and crime issues by the local council and police
- NI 37 Awareness of civil protection arrangements in the local area

4.2 Adult Health and Well-being (Carlisle)

The remaining Place Survey indicators fall into Adult Health and Well-being, with NI 140, Fair treatment by local services, falling into a sub group entitled 'Tackling Exclusion and Promoting Equality.

Satisfaction of people over 65 with both home and neighbourhood is in the best group compared to all the Districts in England.

Fair treatment by local services is in the lowest group compared to all the Districts in England.
