1.1 A report was due to come to this Committee outlining potential areas of saving from Advice Services.

- 2. Unfortunately, due to the complex nature of the Advice Agencies funding and the desire to try to preserve the level of services as much as possible, whilst still making the significant savings required from the Council's financial contribution, it has not been possible to meet this deadline.
- 3. The situation currently is that Officers are taking a holistic look at the services provided by the Law Centre, the Citizens Advice Bureau and the Benefits Advice Centre.
- 4. Each agency has been requested to respond to a series of questions including information about their financial situation, their accommodation and their ability to extend their areas of service.
- 5. These have recently been received but not fully analysed.
- 6. In particular, Officers are reviewing the services of the Benefits Advice Centre and investigating other sources of funding which might be available to them.
- 7. There is particular optimism that a liaison with Carlisle Housing Association and the Supporting People Initiative could be a potential source, but meeting their criteria may require a re-focusing of some of the Centre's current work.
- 8. As this is a relatively new Initiative, it is taking time to assess the possibilities and indeed it is likely that if there was to be a way forward, the achievement of the full saving requirement may only be achieved incrementally.
- 9. It is anticipated that a detailed report will be available for the next meeting of this Committee.
