LICENSING HISTORY

Mr Donnelly was first licensed as a Hackney Carriage Driver on 25th November 2008. He completed all of the application criteria at the time, including taking the Driving Standards Agency 'Taxi test' on 18th November 2008. At that time the following motoring convictions were declared and he had 3 points valid on his driving licence:

25/08/00

No Vehicle Insurance. Fined £240 & 7 Points.

27/06/03

Speeding. Fined £60 & 3 Points.

04/03/06

Speeding. Fixed Penalty & 3 Points.

The offence of no insurance in 2000 related to his private car.

The 2 offences of speeding took place during his employment as a lorry driver.

24/04/09

Speeding. Fixed Penalty & 3 Points. Carrying a fare paying passenger @

44mph in 30mph zone.

LATEST CONVICTION

Mr Donnelly has reported that on 11th April 2013 he was involved in an incident when he accidentally knocked down a member of the public whilst reversing out of Greystone Road Community Centre. (Appendix B)

Mr Donnelly was interviewed by Licensing Officer on 24/04/13 (see Appendix C & D)
On 17th June 2013 he pleaded guilty to 'Driving without due care and attention' at Court
and received £120 fine & 4 points. (CD10 offence)

DRIVING LICENCE

Apart from this latest conviction Mr Donnelly's driving licence has no further endorsements (Appendix E)

LEGISLATION

Section 61 (1) of the Local Government Miscellaneous Provisions Act 1976 states that a District Council may suspend or revoke a Hackney Carriage Driver Licence on a number of grounds.

Section 61 (1) (b) gives the grounds of "any other reasonable cause" (Appendix F).

OPTIONS

It is recommended that after hearing the evidence and any other representations from Mr Donnelly the members reach a decision in line with the options available.

- 1 To take no further action.
- 2 To issue him with a letter of warning.
- 3 To suspend his Hackney Carriage Driver's Licence for a period of time.
- 4 To revoke his Hackney Carriage drivers Licence.
- As well as or instead of the above, to require him to sit and pass a Driving Standards Agency Taxi Driving Test.

Barry,

I went up to Police HQ this morning & viewed the CCTV. It shows the driver (Michael Donnelly-HD112) reversing out of the Car Park entrance on thurs 11.4.13 at 15.55 onto the busy Greystone Rd, when he could have turned in the car park to drive out of the entrance.

He had an elderly lady passenger in the back when he reversed into one of two ladies who were walking out of the car park. Due to the impact, she fell to the ground. He got out of his vehicle, police were called & the lady taken to hospital.

I have seen pictures of her injuries, which include a broken ankle, badly bruised & cut face, as well as badly bruised knees. Photos were taken today, 17.4.13. She is 80 yrs old, so I expect the ordeal to be very distressing for her & the healing process to be lengthy.

He is being interviewed by the Police on Friday, 19.4.13, where they think they will charge him with driving without due care & attention, so I will await their report & then have him in next week to assess the situation.

Both Jim & I are of the opinion (as well as the Police) that it appears to be a very unfortunate accident, with a lapse in his concentration & a very poor decision to reverse out onto a busy road, as well as his reversing speed when he hit the lady.

Unless there are other issues that we think pose a risk to public safety, we would not suspend him, but await the police conclusion, then refer him to the Panel.

I will keep you all in the loop once I know more.

APPENDIX D

Notes of meeting with Mr Michael Donnelly - Wednesday 24/04/13

Mr Donnelly attended the Contact Centre to explain the accident he was involved in on Thursday 11th April 2013.

He explained that he was called to collect a fare at Greystone Rd Community Centre at around 3.45pm that day.

He drove straight into the Car Park & pulled up to the front doors. The lady got into the back of his vehicle. As he was reversing out of the car park onto the main road, he felt a bump and someone hitting his car. It was only at that point did he realise he had knocked a lady over from the rear of his vehicle.

He had thought it was clear to reverse, but accepts it may have been a lapse in is concentration, or that the lady had walked behind his vehicle after he had checked it was clear.

He immediately called emergency services for assistance and the lady was taken by ambulance to hospital. He also reported this to his Operator, Radio Taxis.

He was in shock after the incident and did not drive that weekend. He was very concerned for the lady and her recovery.

He was worried about his licence and said he would keep us informed with the Police action to be taken.

As the interview came to a close, I felt it was not appropriate to suspend him from driving, as it appears to be an isolated incident and not as a result of Mr Donnelly having any other issues.

Local Government (Miscellaneous Provisions) Act 1976

1976 CHAPTER 57

PART II

HACKNEY CARRIAGES AND PRIVATE HIRE VEHICLES

- 61 Suspension and revocation of drivers' licences.
 - (1) Notwithstanding anything in the Act of 1847 or in this Part of this Act, a district council may suspend or revoke or (on application therefor under section 46 of the Act of 1847 or section 51 of this Act, as the case may be) refuse to renew the licence of a driver of a hackney carriage or a private hire vehicle on any of the following grounds:—
 - (a) that he has since the grant of the licence—
 - (i) been convicted of an offence involving dishonesty, indecency or violence; or
 - (ii) been convicted of an offence under or has failed to comply with the provisions of the Act of 1847 or of this Part of this Act; or
 - (b) any other reasonable cause.
 - (2) (a) Where a district council suspend, revoke or refuse to renew any licence under this section they shall give to the driver notice of the grounds on which the licence has been suspended or revoked or on which they have refused to renew such licence within fourteen days of such suspension, revocation or refusal and the driver shall on demand return to the district council the driver's badge issued to him in accordance with section 54 of this Act.
 - (b) If any person without reasonable excuse contravenes the provisions of this section he shall be guilty of an offence and liable on summary conviction to a fine not exceeding [FI level 1 on the standard scale].
- [F2(2A) Subject to subsection (2B) of this section, a suspension or revocation of the licence of a driver under this section takes effect at the end of the period of 21 days beginning with the day on which notice is given to the driver under subsection (2)(a) of this section.
