# Subject Matter:

Carlisle City Council's existing Leisure Contract with Greenwich Leisure Limited (formally held by Carlisle Leisure Limited) expires on 30th November 2017.

In August 2014 the Council secured grant funding from the Local Government Association to procure specialist advice on both the procurement of a new leisure contract and investment in new leisure facilities (in line with the Council's Sports Facilities Strategy).

V4 Services Ltd offered a range of advice on potential options and have recommended an immediate period of market engagement leading into an early procurement exercise for the Leisure Contract later in 2015.

Earlier procurement of a long term leisure service partner may allow the council to realise savings on the contract sooner than it's natural expiry on 2017. It would allow the council to explore facilities development (in particular redevelopment of swimming facilities) more urgently and avoid ongoing and increasing maintenance and repair liabilities at the existing pools.

In order to enter into market testing as soon as possible and expedite the process (for the reasons outlined above) it is proposed that a report on V4 Services Findings and recommendations for market testing is considered immediately by the Community Overview

and Scrutiny Panel. It would then be considered (complete with the panels observations) by Executive rather than the usual order of initial consideration by Executive, then Community Overview and Scrutiny and then final consideration by Executive.
