GRANTS FOR LEISURE

To consider applications received for grant assistance for the Grants from Leisure Budget 2006/07. The decision is taken in accordance with Paragraph 8.1 of the Leader's Scheme of Delegation.

### **Summary of Options rejected**

### **DECISION**

(1) That a decision on the application from James Rennie School, towards the costs of 16 pupils with learning difficulties attending the David Beckham Academy in London in April, be deferred pending the outcome of their bid to the Neighbourhood Forum.

(2) That the application from Border Harriers and Athletic Club, towards travel costs to compete against other clubs, be refused on the grounds that they had already received a grant from the Neighbourhood Forum.

(3) That the application from Burgh by Sands Sports and Recreation Association, towards the cost of preparing part of the village green to accommodate a statue, be refused on the grounds that they had already received a grant from the Neighbourhood Forum.

(4) That the Cumberland Geological Society be awarded a grant of £200 towards the cost of replacing an out of print field guide with an up to date version to encourage local people and visitors to explore the Cumbrian countryside.
