3 Current Issues

3.1 Licensing Act 2003

The Government are still considering further de-regulation of regulated entertainment and the future of the personal licence system for alcohol licensing. The areas being looked at include:

- Increase the number of TEN's from 12 to 15 per year
- Amend the validity of a personal licence from 10 years to indefinite
- Repeal restriction on children purchasing liqueur confectionery
- Allow licensing authorities to exempt designated premises from the requirement to licence late night refreshment
- Remove requirement to report lost/stolen licence to Police
- Remove requirement for community premises to hold a licence for the exhibition of a film where:
 - o Permission granted by management committee
 - Exhibition of film not for profit
 - Takes place between 8am 11pm
 - No more than 500 persons present
 - o Restriction of children dependent upon film classification

The Licensing Manager will respond to any consultation on this subject.

3.2 Football - World Cup 2014

The Local Government Association, ACPO and the British Beer and Pub Association have produced a booklet entitled 'Managing World Cup Success' with advice for licensees prior to the football World Cup. Most of the games will be broadcast live and some finish in the early hours of the morning (UK time). It is expected that liquor licensed premises will wish to take advantage of these hours and extend their opening hours as appropriate.

The document has been circulated to licensed premises that are known to show live football and will also be available on our website. A press release will also be made at the appropriate time.

3.3 Christmas crime figures

The violent crime figures have been published Cumbria Police and Carlisle has had a massive reduction especially the City Centre. There were approximately 60% less assaults than 2 years ago from 63 to 27. The rest of the force has seen an increase. This figure reflects the effort being put into the night time economy by all agencies involved. The reduction cannot be attributed to one particular reason, but members will be aware of the following initiatives, all tailored to reduce crime and anti social behaviour:

- Carlisle & Eden Best Bar None Scheme
- On going training for bar staff through sponsorship
- Carlisle & Eden Community Safety Partnership initiatives e.g. supply of spikeys, drug wipes, posters etc.
- Carlisle Pubwatch
- Street Pastors
- Taxi Marshalls
- Botchergate road closure

1.0 **BACKGROUND**

- 1.1 The Gambling Act 2005 took effect on 1st September 2007, from which date this Council assumed responsibility for administering premises licences.
- 1.2 The main thrust of the legislation was that Local Authorities took over the responsibility for licensing gambling premises from the Licensing Justices. The Gambling Commission has responsibility for licensing operators and personal licence holders.

Granted to Member's clubs to permit the use of gaming machines (as above) only.

3.3 Alcohol Premises - Gaming Machine Permits/Notifications

These are granted to alcohol licensed premises. Under the Gambling Act premises must give a notification of 2 machines or less, or a Licensed Premises Gaming Machine Permit for 3 or more machines, both of which last indefinitely (with certain conditions).

Small Society Lottery Registrations are issued to charities or sports clubs who wish to raise money for their organisation where there is no private gain.
