JMT 22/11	JOINT WASTE AUTHORITY FOR CUMBRIA
<p>A Culleton briefed JMT on the paper she is taking to the Executive meeting on 14th March about the Cumbria Strategic Waste Partnership's 'Enhanced Partnership Working Project'. JMT 24/11	SUSTRANS
<p>D Crossley relayed to JMT a telephone conversation he had just had with Tim Temple of Sustrans. He confirmed that Sustrans were willing to meet with Carlisle City Council. Darren had stressed that Cumbria County Council must be at the same meeting. Sustrans are to get back in touch next week.</p>	

A Culleton reported to JMT that she had looked over the withdrawal letter numerous times, it was a very repetitive letter.

Cllr Bloxham reported that the scheme had been discussed at the Highways and Transport Working Group meeting the previous day and they were happy to endorse a letter sent to the Big Lottery from the City Council's Leader and Chief Executive.

It was agreed that the City Council needs to do all it can to keep the scheme going. M Mooney had received correspondence from the local MP, John Stevenson, and in her response to him she would invite him to the City Council for a briefing on the scheme.

It was also agreed that a concise audit trail of correspondence and agreement between Sustrans and Carlisle City Council was needed M Lambert agreed that he would look for a copy of the Memorandum of Understanding and associated correspondence.

Cllr Bloxham asked that all Members be informed fully and quickly of progress with the scheme at all stages from now on.

It was further agreed by JMT that D Crossley would speak with Andrew Moss (Cumbria County Council) prior to the meeting between Cumbria County Council and Sustrans next week. Carlisle City Council would request a meeting with Sustrans and a meeting with Cumbria County Council to move matters along.
