1. BACKGROUND INFORMATION AND OPTIONS

- 1.1 Under the constitution of the City Council the Executive is required to undertake consultation on its draft budget proposals before making a recommendation to Council.
- 1.2 The Executive at its meeting on 17th December proposed its draft budget and sought the views of Overview and Scrutiny, National Non-Domestic Ratepayers, Trade Unions and the public. Minutes of these meetings held on the 9th, 15th and 17th January respectively appear earlier on this Agenda.
- 1.3 Consultation with the Public began with a press release on the 17th December and was followed by a leaflet outlining the main options together with a list of 8 possible future initiatives. This leaflet was delivered to approximately 46,500 to all households in the week commencing 30th December via Royal Mail.
- 1.4 The closing date for responses was 27th January 2003. The Councils Internal Audit unit has been responsible for the counting of response.
- 1.5 Up to and including 27th January 8,447 reply cards have been received, a response rate of 18.1%
- 1.6 In addition we have received 27 letters with comments and observations on both the process and the possible initiatives. Anonymised copies of these letters are available to the Executive for inspection.
- 1.7 We have also received 15 emails again anonymised copies of these are available to the Executive for inspection.

2. THE RESULTS

2.1 In terms of the options A, B and C the overall returns were as follows:

| Option A | 3,608 = 42.7% |
| Option B | 3,012 = 35.6% |
| Option C | 851 = 10.1% |
| Spoiled/Unmarked | 976 = 11.5% |

2.2 In terms of those who 7,471 who indicated a preference for options A, B or C the returns were as follows:
