C.107/12 CARLISLE CITY COUNCIL – CODE OF CONDUCT

Pursuant to Minute ST.05/12, consideration was given to a report of the Director of Governance (GD.36/12) explaining the impact of the Localism Act 2011 on the Standards Regime; seeking the establishment of a Standards Committee; recommending a new Code of Conduct / Scheme for the Registration of Interests; and authorisation for the advertisement of the position of Independent Person.

The Standards Committee had on 18 June 2012 considered the matter and the Minutes of that meeting, setting out the Committee's recommendations, were submitted.

In presenting the report Councillor Tickner commented that, since the issue was technically involved, training would be available for Members. He further pointed out that the Standards Committee had agreed that the limit for gifts and hospitality should remain at £25.00.

Councillor Tickner then moved that the City Council:

- i. Create a Standards Committee with seven Members, with Terms of Reference as specified in the appendices to Report GD.36/12, and the Director of Governance be authorised to make the appropriate amendment to the Council's Constitution, in particular the Responsibility for Functions and Article 9 as detailed in Appendices 1 and 2.
- ii. Note that the Council's existing Standards Committee would continue to exist until the relevant provisions of the Localism Act 2011 were implemented and until such time it would continue to deal with any relevant matters, including Code of Conduct Complaints that the Council had received or received under the existing regime.
- iii. Adopt the Code of Conduct for Members and Co-opted Members of the Council as shown at Appendix 3.
- iv. Adopt the Register of Members' Interests as shown at Appendix 4.
- v. In accordance with Council Procedure Rule 24.1, Council suspend Council Procedure Rule 24.2 in order that it may at today's meeting approve the amendment to the Council's Rules of Procedure as detailed in paragraph 7.1 of the report.

C.108/12 CARLISLE CITY COUNCIL: APPOINTMENT TO POLICE AND CRIME PANEL

Consideration was given to a report of the Director of Governance (GD.35/12) outlining the role of Police and Crime Panels, and the main considerations arising in terms of the establishment of a Panel for Cumbria.

The Director of Governance recommended that the City Council:

- i. Nominate a representative to serve on the Police and Crime Panel until May 2013; and
- ii. Agree to continue to appoint a Member representative to the Cumbria Police and Crime Panel on an annual basis from May 2013.

Councillor Hendry moved and Councillor Whalen seconded that the City Council nominate Councillor Bowditch to serve on the Police and Crime Panel until May 2013.

Councillor Mallinson (J) moved and Councillor Ellis seconded that the City Council nominate Councillor Morton to serve on the Police and Crime Panel until May 2013.

Following voting, it was agreed that Councillor Bowditch be so nominated.

Councillor Mrs Bowman questioned the approach adopted in terms of the make up of the Panel.

In response, the Director of Governance referred Members to paragraph 1.14 of his report which recorded that on 29 February 2012 the Chief Executives and Leaders of all principal Local Authorities in Cumbria had met to review the establishment of a Police and Crime Panel and agree how that would be taken forward, particularly focussing on who would host the Panel and the membership thereof.

Councillor Hendry then moved the recommendation that the City Council agree to continue to appoint a Member representative to the Cumbria Police and Crime Panel on an annual basis from May 2013, which was accepted.

RESOLVED – That the City Council:

- i. Nominated Councillor Bowditch to serve on the Police and Crime Panel until May 2013; and
- ii. Agreed to continue to appoint a Member representative to the Cumbria Police and Crime Panel on an annual basis from May 2013.
