CUSTOM FLEET

Following the announcement of the closure of the Custom Fleet offices on Kingstown, staff from Development Services asked GE, the new parent company, for an opportunity to meet to discuss the situation and identify ways that the Council can assist through the Redundancy Support Programme. There has been a positive response from GE and their HR Director and the HR manager dealing with Custom Fleet, and a meeting has been scheduled for 6th November with the Business Development Officer and the Economic Regeneration Officer.

JOBS, SKILLS & TRAINING FAIR

As highlighted in my last report, on the 21st September 2006 as part of the Redundancy Response Project we ran a 'Jobs Skills & Training Fair'. 89 Organisations were represented on the day with a mix of public and private sector employers, advice and support agencies and the training and education sector.

- 1150 members of the public attended the event and registered
- over 400 'live' vacancies were on offer
- 10 individuals had successfully gained employment by the close of the event
- 167 individuals to date have successfully gained employment as a direct result of attending the event
- 2000 (plus) application forms were distributed or requested on the day

We will be holding another 'Jobs Skills & Training Fair' on Friday, 2nd February at the Sands Centre. We are hoping to have even more employers offering jobs at the event, as well as agencies promoting training and support.

BRAMPTON BUSINESS CENTRE

The Business Centre held a "Celebration of Achievement", which I attended, on Wednesday 18th October 2006 to celebrate the achievements of all students over the last academic year.

Some students need to gain certificates and qualifications to get into or further their employment. Others want to learn so that they are able to use their newfound skills, but do not necessarily need a certificate to prove that they can do it

Some students come to the Centre with basic IT skills on which they want to build, and they may progress to achieve a higher level. Some come through the door without even having switched on a computer, so their learning journey starts from a very different point. Each student achieves something unique and achieves it via a different route, but one achievement is no less valid than any other.

LATE NIGHT SHOPPING

The figures for the period 1st June (first late night shopping Thursday) until 5th October are shown below. Numbers have held well with an average of 1,844 people using the Lanes between 5-6 pm each Thursday night and 995 between 6-7 pm.

This means that between 1st June and 5th October 2006 there has been, on average an additional <u>1,082</u> people using the Lanes each Late Night Thursday evening.

CITY CENTRE

Footfall through the City Centre as a whole remains strong with increases of +5.8% in August and +6.5% in September on last year's figures. 30th September saw the busiest Saturday of the year and 1st October the busiest Sunday. Footfall for the year up to 15th October is up by 1.2%.

CARLISLE CONFERENCE GROUP

Enquiries are currently up on the same period last year, predominantly due to a direct mailing campaign that was carried out earlier in the year and recent exposure at the National Venue Show and Event Expo North. Bookings however are slightly down and recent discussions with CCG members seem to show that reasons for this are: The amount of flood related meetings last year (Jan – June, by Agencies / Local authorities / Utility companies etc), companies tightening budgets / regarding them as 'jollies', in-house events and fuel costs.

EXHIBITIONS

CCG had a stand at the National Venue Show on 19, 20 & 21 September at the NEC in Birmingham. The CCG stand was the best yet thanks to 'in kind' support from Rhythm of Life who supplied a fresh modern look to the Carlisle image, with a plasma screen & powerpoint loop, a CCG Logo that was lit up in the aisles and high-spec spotlights. Visitor numbers to the stand were disappointing and it is unlikely that we will return to this show in 2007.

CCG also had a presence at Event Expo – North show on 27 & 28 September at the Yorkshire Event Centre in Harrogate. Visitor numbers to this show were highly disappointing, however this was the debut year of the show, so it is likely to be better in 2007. Although visitor numbers were low, those persons that did come to the Carlisle stand, were familiar with / interested in using Carlisle as a Business Tourism Destination.

FUTURE CONFERENCES / EVENTS

Although there have been no major developments, Carlisle Conference Group continues to work with **Rotary District 1020**, who will be returning to Carlisle for their annual conference in 2007. The main venue for the event will be the Sands Centre and approx 900 delegates are expected to attend. The event dates are 26, 27 & 28 October 2007.

Roger Albert Clark Rally is once again visiting Carlisle in November. The event will be spending two nights in the city on the 18th and 19th November. The Rally will be based at the Premier Travel Inn but it is anticipated the many of the accommodation providers across the City will benefit. Development Services have assisted the event to find suitable space for the servicing of rally cars and has put the organisers in touch with a local business that has agreed to act as in kind sponsor of the event whilst it is in the city. The event starts and finishes in Harrogate.

In recognition of this the organisers have offered that the 15 Official Cars that will run ahead of the Rally will carry the City Council's logo.

August 2006

The August 2006 jobless and claimant count figures were released by the Office for National Statistics today. The claimant count was taken on 10th August 2006.

National Measures of Joblessness

These figures may be quoted by the national press but are not available for local areas and are provided for information only. They should not be compared with those shown elsewhere in this report.

The jobless total for the UK (claimants and non claimants looking for work) rose by 93,000 in the 3 months to July 2006, giving a total of 1.70m. The jobless rate is 5.5% nationally (these data are not produced at local level).

The seasonally adjusted claimant count for the UK is 950,100, a fall of 3,900 from last month. The seasonally adjusted claimant count rate (% of working age population) is unchanged at 2.6% nationally (seasonally adjusted data are not produced at local level).

The Claimant Count (not seasonally adjusted)

The number of people out of work and claiming benefit across the UK fell by 1,959 to 958,881. The number of people out of work and claiming unemployment benefit in Cumbria rose by 31 to 5,752. The male claimant count in Cumbria fell by 23 and the female claimant count rose by 54. The number of claimants fell in Allerdale and Carlisle but rose in Barrow, Copeland, Eden and South Lakeland.

Residence-Based Claimant Rate (not seasonally adjusted)

The residence-based claimant count expresses the number of claimants in an area as a percentage of the working age population resident in that area.

UK residence rate – was unchanged at 2.6%.
 Cumbria residence rate – was unchanged at 1.9%, 0.7 below the UK rate.
 Cumbria male residence rate – was unchanged at 2.8%, 0.8 below the UK male rate.
 Cumbria female residence rate – was unchanged at 1.0%, 0.5 below the UK female rate.

National Measures of Joblessness

These figures may be quoted by the national press but are not available for local areas and are provided for information only. They should not be compared with those shown elsewhere in this report.

The *jobless* total for the UK (claimants *and* non claimants looking for work) rose by 45,000 in the 3 months to August 2006, giving a total of 1.70m. The jobless rate is 5.5% nationally (these data are not produced at local level).

The seasonally adjusted claimant count for the UK is 962,000, a rise of 10,200 from last month. The seasonally adjusted claimant count rate (% of working age population) is unchanged at 2.6% nationally (seasonally adjusted data are not produced at local level).

The Claimant Count (not seasonally adjusted)

The number of people out of work and claiming benefit across the UK fell by 5,972 to 952,909. The number of people out of work and claiming unemployment benefit in Cumbria fell by 145 to 5,607. The male claimant count in Cumbria fell by 124 and the female claimant count fell by 21. The number of claimants fell in Carlisle (-94), Copeland (-38) and South Lakeland (-32) but rose slightly in Allerdale (+7), Barrow (+3) and Eden (+9).

Residence-Based Claimant Rate (not seasonally adjusted)

The residence-based claimant count expresses the number of claimants in an area as a percentage of the working age population resident in that area.

UK residence rate – was unchanged at 2.6%.

Cumbria residence rate – was unchanged at 1.9%, 0.7 below the UK rate.

Cumbria female residence rate – was unchanged at 1.0%, 0.8 below the UK female rate.
