**UPDATE ON CORPORATE PLAN** 

- The Corporate Plan is currently being drafted based on consultation to date. This
  has so far included input from members of the executive and feedback from the
  Strategic Planning Workshop held on 1<sup>st</sup> March with members of the Executive,
  Chairs of Overview and Scrutiny Committees, Corporate Management Team and
  Service Unit Heads.
- 2. As members will recall a timetable for development of the Corporate Plan was agreed at the last meeting of the Executive on 11<sup>th</sup> March 2002. This timetable was subject to the Overview and Scrutiny Management Committee agreeing the Overview and Scrutiny consultation arrangements.
- 3. Overview and Scrutiny have now agreed their consultation arrangements and at the meeting of Overview and Scrutiny Management Committee on the 11<sup>th</sup> March, they resolved (draft minute OSM 29/02) that:
