# 1 THE APPLICATION (Appendix 1)

### 1.1 Applicant

### **Cumbria Constabulary**

In accordance with Section 51 of the Licensing Act 2003 an application has been received from Cumbria Constabulary, for a review of the premises licence relating to Time Bar, 68 Botchergate, Carlisle.

### 1.2 Grounds for review

The Police have stated that the grounds for the review are: Evidence of a breach of three of the Licensing Objectives: (A) crime and disorder, (B) concerns for public safety, and (C) the prevention of a public nuisance.

- 1.3 The application has been copied and forwarded to the Premises Licence Holder as well as all Responsible Authorities. Further additional details supporting the application have also been forwarded: Incident Count (Appendix1a), Statement PS Graham (Appendix1b), Statement PC Lightfoot (Appendix 1c), Statement PC Robbins (Appendix 1d), Statement PC Whatman (Appendix 1e), Chronology of incidents (Appendix 1f), Minutes of police meetings with Time Bar proprietor (Appendix 1g).
- 1.4 The application has been advertised on the premises, at the Council offices and on the Council website as required by statute for a 28 day period.
- 1.5 Following the application being submitted, the Ibis Hotel (located in Botchergate opposite Time Bar) has also made representations in relation to noise nuisance (Appendix 2).
- 1.6 Mr Ben Greenslade is the Premises Licence holder and Daniel Greenslade, his brother, is the designated premises supervisor. Both will be in attendance.
- 1.7 Mr Greenslade has forwarded papers which he will refer to and use in the defence of the police allegations. These are (**Appendix 4 7**) attached to this report.
- 1.8 The Licensing authority must, having regard to the application and any relevant representations, take such steps it considers necessary for the promotion of the licensing objectives. These steps are:
  - (a) to modify the conditions of the licence;
  - (b) to exclude a licensable activity from the scope of the licence;
  - (c) to remove the designated supervisor:
  - (d) to suspend the licence for a period not exceeding 3 months;
  - (e) to revoke the licence
  - (f) Issue an informal warning to the Licence holder and/or to recommend improvement within a particular time

### 2 PREMISES LICENCE

Premises: Time Bar 68 Botchergate, Carlisle. (Area Plan Appendix 3)

### 2.1 Holder of Premises Licence

Mr Ben Greenslade of Parkland Estate Carlisle is the Premises Licence holder and has been the holder of the Premises licence since November 2007.

### 2.6 Premises licence conditions attached to Time Bar.

### <u>Licensing Act 2003 Mandatory Conditions</u>

Mandatory conditions where licence authorises the supply of alcohol

- (1) No supply of alcohol may be made under the premises licence –
- (a) at a time when there is no designated premises supervisor in respect of the premises licence, or
- (b) at a time when the designated premises supervisor does not hold a personal licence or his personal licence is suspended.

(c) The supply of alcohol under the premises licence must be made or authorised by a person who holds a personal licence

### Mandatory Conditions where Door Supervisors are provided

Where a premises licence includes a condition that one ore more individuals must be at the premises to carry out a security activity, they must be licensed by the Security Industry Authority.

### The following conditions shall apply from 6<sup>th</sup> April 2010

- (1) The responsible person shall take all reasonable steps to ensure that staff on relevant premises do not carry out, arrange or participate in any irresponsible promotions in relation to the premises.
- (2) In this paragraph, an irresponsible promotion means any one or more of the following activities, or substantially similar activities, carried on for the purpose of encouraging the sale or supply of alcohol for consumption on the premises in a manner which carries a significant risk of leading or contributing to crime and disorder, prejudice to public safety, public nuisance, or harm to children-
  - (a) games or other activities which require or encourage, or are designed to require or encourage, individuals to-
  - (i) drink a quantity of alcohol within a time limit (other than to drink alcohol sold or supplied on the premises before the cessation of the period in which the responsible person is authorised to sell or supply alcohol), or
  - (ii) drink as much alcohol as possible (whether within a time limit or otherwise);
  - (b)provision of unlimited or unspecified quantities of alcohol free or for a fixed or discounted fee to the public or to a group defined by a particular characteristic (other than any promotion or discount available to an individual in respect of alcohol for consumption at a table meal, as defined in section 159 of the Act);
  - (c) provision of free or discounted alcohol or any other thing as a prize to encourage or reward the purchase and consumption of alcohol over a period of 24 hours or less;
  - (d) provision of free or discounted alcohol in relation to the viewing on the premises of a sporting event, where that provision is dependent on-
  - (i) the outcome of a race, competition or other event or process, or
  - (ii) the likelihood of anything occurring or not occurring;
  - (e) selling or supplying alcohol in association with promotional posters or flyers on, or in the vicinity of, the premises which can reasonably be considered to condone, encourage or glamorise anti-social behaviour or to refer to the effects of drunkenness in any favourable manner.

- (4) The responsible person shall ensure that no alcohol is dispensed directly by one person into the mouth of another (other than where that other person is unable to drink without assistance by reason of a disability).
- (5) The responsible person shall ensure that free tap water is provided on request to customers where it is reasonably available.

### The following conditions shall apply from 1st October 2010

- (6) (1) The premises licence holder or club premises certificate holder shall ensure that an age verification policy applies to the premises in relation to the sale or supply of alcohol.
  - (2) The policy must require individuals who appear to the responsible person to be under 18 years of age (or such older age as may be specified in the policy) to produce on request, before being served alcohol, identification bearing their photograph, date of birth and a holographic mark.
- (7) The responsible person shall ensure that-
  - (a) where any of the following alcoholic drinks is sold or supplied for consumption on the premises (other than alcoholic drinks sold or supplied having been made up in advance ready for sale or supply in a securely closed container) it is available to customers in the following measures-
    - (i) beer or cider: ½ pint;
    - (ii) gin, rum, vodka or whisky: 25 ml or 35 ml; and
  - (iii) still wine in a glass: 125 ml; and
  - (b) customers are made aware of the availability of these measures.

### Mandatory Condition where the licence authorises the exhibition of films

- (1) Where a premises licence authorises the exhibition of films, the licence must include a condition requiring the admission of children to the exhibition of any film to be restricted in accordance with this condition.
- (2) Where the film classification body is specified in the licence, unless subsection (3)(b) applies, admission of children must be restricted in accordance with any recommendations made by that body.
- (3) Where -
  - (a)the film classification body is not specified in the licence, or
  - (b) the relevant licensing authority has notified the premises which holds the licence that this subsection applies to the film in question, admission of children must be restricted in accordance with any recommendation made by that licensing authority.
- (4) In this section -

"children" means persons aged under 18; and

"film classification body" means the person or persons designated as the authority under section 4 of the Video Recordings Act 1984 (c.39)(authority to determine suitability of video works for classification).

### 2.7 Conditions Consistent with the Operating Schedule

The accommodation limit of the premises, including public, staff and performers shall not exceed:

Ground Floor - 150 persons for dancing with fixed seating and 60 persons for dancing using Tables and Chairs.

First Floor - 60 Persons

### The Prevention of Crime and Disorder:

A method of communicating with other participating licensed premises by way of text / pager or radio links shall be provided at the premises.

Any text / pager or radio link provided for communication with the other licensed premises shall be kept in good working order at all times.

When the premises are open to the public, the communications link with other participating licensed premises shall be switched on and available to and monitored by the Designated Premises Supervisor or a nominated member of staff.

Every incident of crime or disorder in the premises shall be reported via the text / pager or radio link to other participating licensed premises by the Designated Premises Supervisor or a nominated member of staff.

The Designated Premises Supervisor, when present, and all members of staff shall ensure that all lawful instructions and/or directions given by the Police are complied with.

Door supervisors shall be provided at the premises door to such a number as the management of the premises consider are sufficient to control the entry of persons to the premises and for the keeping of order in the premises when they are used for licensable activity.

A written record shall be kept on the premises by the Door Supervisor Manager of every person employed on the premises as a door supervisor in a register kept for that purpose. That record shall contain the following details:

- a) the door supervisor's name, date of birth and home address
- b) his/her Security Industry Authority licence number
- c) the time and date he/she starts and finishes duty
- d) the time of any breaks taken whilst on duty

e) each entry shall be signed by the door supervisor

That register shall be available for inspection on demand by an Authorised Officer of the Council the Security Industry Authority or a Police Constable.

A tamper proof CCTV system shall be installed at the premises in liaison with and to the satisfaction of the Cumbria Police Licensing and Community Safety Officers and shall be used to record during all hours that a licensable activity takes place on the premises.

A CCTV camera shall be installed at the locations marked, "CCTV CAMERA" on the plan of the premises.

Where CCTV equipment is fitted, it shall be maintained in good working order in accordance with the manufacturer's instructions.

A written record shall be kept every time images are recorded by CCTV and shall include details of the recording medium used, the time and date recording commenced and finished. This record shall identify the person responsible for the recording and shall be signed by him/her. Where the recording is on a removable medium (i.e. videotape, compact disc, flash card etc.), a secure storage system to store those recording mediums shall be provided. Images saved to computer hard drive.

The images recorded by the CCTV system shall be retained in unedited form for a period of not less than 31 days.

The maximum number of persons allowed in these premises shall be 145 ground floor, 90 first floor.

There shall be displayed on the premises notice(s) to warn members of the public visiting the premises of the incidence of crime, which may affect them. The notice(s) shall be displayed and securely fixed and clearly visible to members of the public.

The licence holder and/or the designated premises supervisor or a person nominated by them shall actively participate and be a member of a Pubwatch scheme for the area within which the premises is located.

### **Public safety:**

All exits and escape routes to those exits (including external escape routes) from the premises shall be provided with slip resistant even surfaces and shall be maintained in good repair, correct working order and kept free from all obstructions when the public are on the premises. External escape routes shall also be kept free from ice and snow.

All doors or gates both inside and outside the premises which are on an escape route shall be fitted only with approved fasteners and shall at all times be properly maintained, free from obstruction and be capable of being opened easily and fully so that they do not restrict the public leaving the premises and shall open in the direction of the escape route.

Where a door on an escape route opens against the direction of exit travel, it shall be locked in the open position by a tamper-proof fastening when the public uses the premises and there

shall be a clearly visible notice in capital letters which contains the following words, "THIS DOOR SHALL BE KEPT LOCKED IN THE OPEN POSITION WHEN THE PREMISES ARE OCCUPIED" displayed in a clearly visible position next to the door.

All exit doors and gates from premises or enclosure(s) surrounding it shall be capable of being opened by any person without the use of a key, card, code or other similar means and be kept free from all fastening devices when the premises are open to the public.

All exit routes and doors on such routes shall be checked on every occasion before the premises is used for purposes of a licensable activity and at regular occasions when the premises are open to the public to ensure that they are free from defect, obstruction, trip hazards and surfaces are not slippery. A record of such inspections, any defects discovered and the remedial action taken shall be made in writing in a logbook kept for that purpose. That logbook shall be made available for inspection on demand to an Authorised Officer of the Council, a Fire Officer or a Police Constable.

The method of opening any exit door or gate from the premises or enclosure(s) surrounding it shall be clearly displayed immediately above or below the fastening in white block lettering on a green background in letters not less than 50 mm high.

Where any automatic self-closing fire-resisting doors activated by a fire alarm or fire detection system are fitted within the premises they shall not be prevented from closing by any device and shall be marked to both sides of the doors so that they are clearly visible and positioned at or about eye level with the words "AUTOMATIC FIRE DOOR KEEP CLEAR" in block letters not less than 50mm high when the premises are open to the public.

Any door or gate in the premises which is not an exit door or gate shall have a sign bearing the word "PRIVATE" in block letters not less than 50 mm high.

The furniture or seating in premises shall be arranged so that it does not obstruct any exit, route to any exit or to any facility within the premises.

Before the premises are opened for the purposes authorised by the licence an inspection shall be carried out to ensure that the premises are safe for use. Details of the inspection, defects discovered and remedial action taken shall be recorded in writing in a logbook kept for that purpose. That logbook shall be made available for inspection on demand to an Authorised Officer of the Council, a Fire Officer or a Police Constable.

The premises shall be maintained so that the following fire retardancy standards are complied with:

- (i) All upholstered seating meets on a continuous basis the pass criteria for smouldering ignition source 1 and crib ignition source 5 when tested in accordance with section 5 of BS 5852:1990.
- (ii) All repairs or refurbishment of existing seating or upholstery shall include the removal of untreated polyurethane foam and its replacement by fillings which conform to the Furniture and Furnishings (Safety) Regulations 1988 (as amended).

- (iii) Carpets B.S.4790 low radius of spread.
- (iv) Walls and Ceilings Circulation areas, Building Regulations. Class O General Areas, B.S.476 Class1.
- (v) All artificial foliage, floral decorations or any other decoration provided on the premises shall be of inherently flameproof material.

At all times when the premises are used for the purpose of the \*licence/or certificate, the licence holder, a club official, manager or designated premises supervisor who is responsible for the management of the premises shall at all times be aware of the number of persons on the premises and shall if requested to do so give that information to an Authorised Officer of the Council, a Fire Officer or a Police Constable. (\*delete as appropriate). (See also CD17)

Printed notices shall be prominently displayed in the premises detailing the essential steps that must be taken if a fire is discovered or the fire alarm goes off or other emergency arises and how to call the Fire Service.

A person who is nominated for the purpose of taking control in the event of a fire, fire alarm, emergency or event which may effect the safety of persons attending the premises shall be on and in charge of the premises at all times when any licensable activity is being provided.

That person shall be responsible for calling the Fire Service in the event of any fire and that person shall also be responsible for meeting the Fire Service and advising them of the location of the fire.

Any outbreak of fire of any kind shall be reported to the Fire Service immediately and a written record shall be made in a logbook kept for that purpose.

Where the water supply to any hydrant, hose reel, sprinkler, drencher or any other fire extinguishing installation is cut off or restricted the Fire Service shall be notified immediately.

Clear and unobstructed access shall be available to the premises for use by the emergency services and emergency service vehicles at all times.

There shall be maintained on the premises at all times an adequate and appropriate supply of first aid equipment and materials.

When the public, members or guests are present, the lighting levels in all parts of the premises shall be capable of providing sufficient illumination for the public, members or guests to leave the premises safely and there shall be at least one person who is nominated to switch on the house lights in an emergency situation. (Note where the premises are a theatre or cinema, a complete or substantially complete blackout may be permitted for production reasons provided that the exit signs shall be kept lit at all times).

The controls for the emergency lighting shall be protected from unauthorised use and accidental operation and the system designed so that the emergency lighting cannot be altered.

Every battery which is used to power an emergency light or exit sign shall be maintained in a fully charged condition at all times.

On every occasion before the public, members or guests are admitted to the premises an inspection of all normal and emergency lighting shall take place. A record shall be kept in a logbook of those tests and any faults discovered together with a record of the work carried out to repair those faults. All faults discovered shall be repaired immediately or if that cannot be done then as soon as is possible and the reason for the delay shall be entered in the logbook.

(See also PS71)

The premises shall be provided with adequate and accessible lavatory accommodation which shall at all times when the premises are in use be kept clean, ventilated, disinfected and supplied with hot and cold water, soap, toilet tissue, hand drying and sanitary towel disposal facilities as appropriate.

Emergency Lighting will be tested in accordance with BS 5266 Part 1, 1999 Emergency Lighting. The results of the tests will be recorded in a logbook. A satisfactory NICEIC (or equivalent) inspection report will be provided annually to the Licensing Authority.

The fire alarm detection system will be tested in accordance with BS 5839 Part 1 2002 Fire Detection and Fire Alarm Systems for buildings. The results of the tests will be recorded in a log book. A satisfactory inspection report will be provided annually to the Licensing Authority.

Fire fighting equipment shall be provided throughout the premises at suitable locations and be appropriate to the risk to comply with BS 5306 Part 8, Selection and Installation of Portable Fire Extinguishers.

The extinguishers shall be hung on a wall bracket with the handle or carrying device approximately 1.1 metres from the floor.

Firefighting equipment shall be examined regularly by the manufacturer or other competent person and maintained and tested in accordance with BS 5306 Part 3, 2000.

All members of staff will be familiar with the operation of the firefighting equipment.

All staff shall be instructed and trained to ensure that they understand the fire precaution measures in the building and the procedure and action to be taken in the event of fire.

Practice fire drills shall be carried out at least once per year or at such additional times as required to train new staff. A competent person will conduct the drills by operating the fire alarm so that staff can rehearse their specific task or duties.

All training and instruction shall be recorded in a log book.

A ventilation system will be provided and suitably maintained to deliver fresh air and extract contaminated air away from staff and customers.

### The prevention of public nuisance:

The licensed premises or the parts of the licensed premises edged in red on the attached plan of the premises may be open to the public and their guests during the hours permitted by this licence.

The licensable activities permitted by this licence are permitted to take place on the licensed premises in those parts of the plan edged in red on the attached plan of the premises during the hours permitted by this licence.

No nuisance shall be caused by noise coming from the premises or by vibration transmitted through the structure of the premises.

All external doors and windows shall be kept closed when regulated entertainment is being provided except in the event of an emergency.

The noise level from the premises whilst being used for public entertainment purposes, shall not cause nuisance to noise sensitive dwellings in the vicinity.

Refuse such as bottles shall be disposed of from the premises at a time when it is not likely to cause a disturbance to residents in the vicinity of the premises.

There shall be no emission from the premises of any offensive smells, which are likely to cause a nuisance.

There shall be provided at the premises containers for the storage and disposal of waste foods and other refuse from the premises. Those containers shall be constructed, maintained and located so that access to them by vermin and unauthorised persons is prevented and arrangements shall be made for the regular lawful disposal of their contents.

### The protection of children from harm:

No person under the age of 12 years, unless they are accompanied by a person over 18 years, shall be permitted on the premises at any time between 10.00 p.m. and 7.00 a.m. when the premises are being used for the purposes of a licensable activity other than the supply of alcohol.

### 3 POLICY FRAMEWORK

- 3.1 It is a corporate objective to promote a healthy and safe Carlisle. The determination of an application to review a premises licence in accordance with the Act and its statement of licensing policy, fulfils that objective.
- 3.2 Paragraph 5.2.1 of the Carlisle City Council statement of licensing policy states 'The authority will view seriously applications for the review of any premises licence where it involves:
  - Persistent failure to comply with licence conditions

- Actions or omissions by the licensee (or his staff) which undermine the licensing objectives, particularly where they endanger public safety, expose children to harm or cause public nuisance'.
- 3.3 Paragraph 5.2.2 goes onto say that the authority will also view particularly seriously, any applications for review where the police have frequently been called to attend incidents of disorder at the premises.
- 3.4 Licensing Act 2003 Guidance Guidance is offered to licensing authorities under Section 182 of the Act, by the Secretary of State in relation to the review of premises licences.
  - 11.16 The 2003 Act provides a range of powers for the licensing authority which it may exercise on determining a review where it considers them appropriate for the promotion of the licensing objectives.
  - 11.17 The licensing authority may decide that the review does not require it to take any further steps appropriate to promote the licensing objectives. In addition, there is nothing to prevent a licensing authority issuing an informal warning to the licence holder and/or to recommend improvement within a particular period of time. It is expected that licensing authorities will regard such informal warnings as an important mechanism for ensuring that the licensing objectives are effectively promoted and that warnings should be issued in writing to the licence holder.
  - 11.18 However, where responsible authorities such as the police or environmental health officers have already issued warnings requiring improvement either orally or in writing that have failed as part of their own stepped approach to address concerns, licensing authorities should not merely repeat that approach and should take this into account when considering what further action is appropriate.
  - 11.19 Where the licensing authority considers that action under its statutory powers is appropriate, it may take any of the following steps:
    - to modify the conditions of the premises licence (which includes adding new conditions or any alteration or omission of an existing condition), for example, by reducing the hours of opening or by requiring door supervisors at particular times;
    - to exclude a licensable activity from the scope of the licence, for example, to exclude the performance of live music or playing of recorded music (where it is not within the incidental live and recorded music exemption);
    - to remove the designated premises supervisor, for example, because they consider that the problems are the result of poor management;
    - to suspend the licence for a period not exceeding three months:
    - to revoke the licence
  - 11.20 In deciding which of these powers to invoke, it is expected that licensing authorities should so far as possible seek to establish the cause or causes of the concerns that the representations identify. The remedial action taken should generally be directed at these causes and should always be no more than an appropriate and proportionate response.

- 11.21 For example, licensing authorities should be alive to the possibility that the removal and replacement of the designated premises supervisor may be sufficient to remedy a problem where the cause of the identified problem directly relates to poor management decisions made by that individual.
- 11.22 Equally, it may emerge that poor management is a direct reflection of poor company practice or policy and the mere removal of the designated premises supervisor may be an inadequate response to the problems presented. Indeed, where subsequent review hearings are generated by representations, it should be rare merely to remove a succession of designated premises supervisors as this would be a clear indication of deeper problems that impact upon the licensing objectives.
- 11.23 Licensing authorities should also note that modifications of conditions and exclusions of licensable activities may be imposed either permanently or for a temporary period of up to three months. Temporary changes or suspension of the licence for up to three months could impact on the business holding the licence financially and would only be expected to be pursued as an appropriate means of promoting the licensing objectives. So, for instance, a licence could be suspended for a weekend as a means of deterring the holder from allowing the problems that gave rise to the review to happen again. However, it will always be important that any detrimental financial impact that may result from a licensing authority's decision is appropriate and proportionate to the promotion of the licensing objectives. But where premises are found to be trading irresponsibly, the licensing authority should not hesitate, where appropriate to do so, to take tough action to tackle the problems at the premises and, where other measures are deemed insufficient, to revoke the licence.

### 4 THE LEGAL POSITION

- 4.1 The licensing authority must determine the application in accordance with Section 52 of the Act, which outlines the circumstances whereby a hearing is required and the options available to the committee when determining the application.
- 4.2 An appeal may be made to the magistrates' court against the decision of the authority by the responsible authority, interested party or premises licence holder, within 21 days from the date of being notified.
- 4.3 Section 52(11) provides that a determination under this section does not have effect until the end of the period given for appealing against the decision, or if the decision is appealed against, until the appeal is disposed of.

### 6 RISK MANAGEMENT IMPLICATIONS

6.1 By determining the application in accordance with the relevant sections of the Act, the statement of licensing policy and guidance offered by the secretary of state, the licensing authority is ensuring that the all of the licensing objectives are considered fully.

### 7. REASON FOR DECISION/RECOMMENDATION

- 7.1 The Licensing Authority has received an application from the Cumbria Constabulary for the review of the premises licence relating to the premises Time Bar, 68 Botchergate, Carlisle. They have stated that the grounds for the review are the current risks to the safety of public in relation to increased crime & disorder, and public nuisance
- 7.2 The application will be determined in accordance with the relevant sections of the Act, the statement of licensing policy and guidance offered by the secretary of state

### 8. RECOMMENDATION:

It is recommended the Committee determines the application in accordance with one of the following actions:

The Licensing authority must, having regard to the application and any relevant representations, take such steps it considers necessary for the promotion of the licensing objectives. These steps are:

- (g) to modify the conditions of the licence;
- (h) to exclude a licensable activity from the scope of the licence;
- (i) to remove the designated supervisor;
- (i) to suspend the licence for a period not exceeding 3 months;
- (k) to revoke the licence
- (i) Issue an informal warning to the Licence holder and/or to recommend improvement within a particular period of time

An alarming number of alcohol related violence and anti social behaviour involving the premises has been highlighted over the past 2 years. A disproportionate level of Police attendance at the premises and evidence of continuing crime and disorder.

Despite meeting on 3 occasions with the owners, door supervisor and designated premises supervisor and the implementation of 3 action plans, the level of violent and anti-social incidents continues with casualties suffering substantial injuries. The management and overall supervision of the Club inside and out is unacceptable and breaches 3 of the licensing objectives.

The prevention of crime and disorder -

The greatest number of calls for Police service relative to its size and opening hours 124 calls for service over a 2 year period. (See comparison chart attached)

Public safety

Serious injury has been inflicted within the Club and CCTV cameras either not switched on to capture evidence or evidence erased/lost.

The prevention of public nuisance

Complaints of noise and nuisance received from a nearby hotel.

Doors frequently wedged open despite repeated requests from Police and Hotel staff, breaching licensing conditions.

Please provide as much information as possible to support the application (please read guidance note 2)

Time Bar is a small Club situated on Botchergate, in Carlisle. Within this area there are approximately another 20 licenced premises, it is only open to the public 2 nights per week and has a capacity to hold 210 customers. It is one of very few clubs that remains open after 3am. Once all other clubs empty and close Time Bar becomes a magnet to people who are invariably intoxicated.

Joint owners of the Club are John Heron and Ben Greenslade.

The DPS at the present time is Dan Greenslade

As far back as 2010 Police were concerned about the number of calls for Police service to Time Bar. This resulted in Police calling a meeting on December 16<sup>th</sup> with John Heron, Ben Greenslade, Jim Messenger (Licensing) and Police. An Action Plan was agreed and Police continued to monitor the premises. (See chronology Pg 1 for actions agreed).

Between 16/12/2010 and 18/07/2011 there were 64 incidents reported to the police.
43 of these incidents were after 3am when other clubs were closed. (Attached is an incident count for other premises in the area. Please note that Time Bar is the smallest club and open for the least amount of hours). All of these incidents were of alcohol related crime, disorder and anti-social behaviour, including G.B.H. It was also noted during this time that officers were struggling to get evidential statements and CCTV from Time Bar staff. (See attached chronology). Door staff were also causing concerns due to allowing undesirable individuals from the Pubwatch Scheme to enter the club and their rough handling of customers when ejecting them.

In March 2011 we were aware of 2 serious assaults that occurred within the club, where door staff had ejected offenders and not detained them for the Police on duty outside, or even made them aware.

Also in March 2011 a door supervisor was arrested for assaulting a customer, unfortunately the customer declined to make a complaint and no further action was taken, despite this incident being witnessed by the Police. The same door supervisor remained in his post and was again arrested for another assault in May 2012 when a customer was so forcibly ejected that he hit his head on the pavement and received a potentially serious head injury. Following consultation between Sgt Higgin and Pro-Tect, his employer, the door supervisor was removed from working at Time Bar. The incident was also reported to the SIA but because the only sanction was a Caution, they took no further action. In December 2012 the same door supervisor was back working at Time Bar when Sgt Graham observed a male being "launched from inside the premises right across the pavement landing on his face on the road". When questioned, the door staff denied any knowledge of the incident so a request was made to Ben Greenslade for the CCTV, this has never been produced.

On 20<sup>th</sup> July 2011 a meeting was called by Inspector Gilroy with John Heron, Ben Greenslade, David Crosland from Pro-Tect Security and Fred Watson from Licencing. An action plan was agreed. (Minutes and Action Plan attached). It was agreed that Dan Greenslade would take over as DPS.

Between 20/07/2011 and 9/12/2012 there were a further 61 incidents reported to the police. 30 of these occurred after 3am. Time Bar was again the location for a GBH. During September a customer staying at the Ibis hotel phoned the police at 0416hrs to say that the noise coming from Time Bar was terrible. This is one of a number of complaints from the public and Police observations regarding noise and nuisance from the premises. (See Chronology). Breaching their Licence conditions.

On 9th December 2011 Sgt Higgin sent an email to Ben Greenslade and John Heron

referring to a reduction in incidents reported to police but drawing their attention to further problems i.e. getting hold of CCTV, complaints of noise from the premises due to the front door being wedged open and persons being granted access at 0415hrs despite an agreement to be completely empty by 0430hrs. This gave Time Bar another opportunity to address the problems.

On March 2<sup>nd</sup> 2012 the police requested a further meeting with Ben and Dan Greenslade. At this meeting Inspector Gilroy expressed his disappointment about the loss of evidence due to CCTV discs supplied by Time Bar having the wrong time and date on. (Minutes attached). An action plan was again implemented and agreed by all parties.

On 9<sup>th</sup> December 2012, which was the same night Sgt Graham had witnessed a male being "launched" into the street. A group of 3 girls, their partners and friends went to Time Bar to celebrate a birthday. They all stated that this was not a club they would usually frequent due to its reputation for trouble. On this occasion Ben Greenslade had agreed to cordon off an area so they could enjoy a private party. At approximately 0230 hrs, an unknown female tried to remove a handbag from the cordoned off area. One of the girls stopped her which resulted in the female offender grabbing her around the throat. The group immediately informed Ben Greenslade what had happened and that they wanted the female offender removed. Ben told them to inform the door staff. The group did this only to see the member of door staff laughing and joking with the female offender. No attempt was made to remove her from the Club. The female offender then lunged at one of the girls and 'body slammed' her backwards straight through a glass table causing the table to smash and injure 2 of the girls in the group. The girl's partner asked Ben Greenslade to contact the police and ambulance but he refused, he subsequently telephoned the Police himself. Greenslade took the two girls upstairs where he began administering first aid to their injuries. At this point Sgt Graham attended the Club and was told by the door supervisor that there were no problems in the Club, Sgt Graham was then approached by a member of the public and told her there was two injured girls inside the Club. Sgt Graham went upstairs to see the 2 injured girls. Both were extremely distressed and covered in blood. Both girls subsequently attended A & E to have their injuries treated.

Sgt Graham asked Ben Greenslade why the door staff had not apprehended the offender and he replied because her boyfriend 'was massive'. Greenslade stated he would drop the requested CCTV off at the police station the following morning but failed to do this. Eventually, after being contacted by Sgt Graham, he arrived with the CCTV late afternoon, but the CCTV coverage did not start until 0505hrs indicating that it was probably not switched on until then, or the incident had been erased and the CCTV restarted at that time. (See attached statement from Sgt Graham). PC Prangnell was told by Ben Greenslade that the reason the CCTV was not working correctly was possibly due to a water leak from guttering on the old Mood premises. PC Prangnell saw no evidence of water damage within the vicinity of the recording equipment. This poor excuse was unacceptable due to the CCTV working perfectly well after the incident.

From the two incidents that occurred that evening, Police received no coverage of either.

There was no referral made by Time Bar to the Pub Watch Scheme on 17<sup>th</sup>
December 2012 to ban this female from their premises or to inform other Pub Watch
members of her propensity towards theft and violence.

Over the Christmas and New Year period Police, again, had to request the wedged open door of Time Bar to be closed due to the noise emanating from within the Club Police also dealt with an unconscious male who had been assaulted in the Club and

taken to hospital (see chronology).

To date the police continue to struggle to get CCTV or find that the disc provided either did not work, was blank, or covered the wrong time period. Also, despite the agreed time of 0430hrs the club continues to close when it wants. Because of the late opening hours and lax management, this bar attracts and admits highly intoxicated, undesirable, individuals who then proceed to cause trouble and are subsequently thrown out, often suffering injury to themselves or having caused injury to someone else. Officers report watching extremely intoxicated customers staggering out of the Club. (Statement Sgt 1185 Graham).

The everyday running of the Club is totally inadequate. A lack of competent supervision by managers compromises customer safety and causes a public nuisance. For two years the Police have tried to work alongside the managers and staff of Time Bar in order to make it a safer and more enjoyable place to visit. Three action plans have proved unsuccessful leaving us with no other option than to ask for a licencing review and closure of the premises.

I am Police Sergeant 1185 Liz Graham of Cumbria Constabulary currently stationed at Carlisle. I am the Neighbourhood Policing Sergeant for the East of Carlisle that includes the City Centre. On Friday 7th December 2012 and Saturday the 8th December 2012 I worked 1800hrs-0400hrs shifts. As part of my role I commence foot patrol in the City Centre to meet and greet visitors and assess how busy the licenced premises are going to be to arrange the appropriate staffing levels. While on the Botchergate area I always make a point of speaking to the doorstaff at the licensed premises to let them know that we are about and appreciate an early call if they are having problems to try and prevent any violence from escalating. I try to promote a good working relationship with all the doorstaff so we can work together to provide a safe environment for all the customers.  About 0100hrs on Sunday 9th December 12 I was standing opposite the entrance to Time Bar. This bar does not open until late and most of it's customers arrive when all the other licensed premises are closing. Due to their late opening many of it's customers are already very inebriated when they arrive. Most of the licensed premises on Botchergate have a queuing system outside so they can keep a check of the numbers entering the premises and it also allows the doorstaff to assess how intoxicated the customers are and to check ages/ pub watch etc and if they want them in their premises. Time Bar does not appear to have any system. The doorstaff normally stand in the doorway surrounded by people either wanting to get in, coming out to smoke or trying to get back in after having a cigarette. They appear to have no control over who is getting in, what their numbers are or how drunk people are. I frequently saw people coming out of the bar with drinks which they are not allowed to do and the doorstaff did not appear to notice or chose to ignore it. As I was standing opposite Time Bar I was suddenly aware of a man being launched from inside the

premises out onto the street. He went right acrosss the pavement and landed on his face in the road. I immediately went to this young male and helped him to his feet. He was so drunk that it was impossible to get any information from him. He could not tell me who had thrown him out. I spoke to the doorstaff who both denied that they had thrown this man out. I noticed that one of the doorstaff was Peter HIRBEK who had previously been arrested twice for assaulting customers. I requested the CCTV from Ben Greenslade the owner of the bar to identify who it was, but this has not been produced. I can only presume that because the male was so drunk his body was relaxed so he did not suffer a serious head injury or worse. A short time after this we were called to Time Bar but then cancelled on route. We still attended and the doorstaff told us there were no problems. I remained outside Time Bar when I was approached by a male who told me that there were two females injured in the bar. I went in and was horrified by the state of the premises. The place was packed and I had real problems getting to the back of the premises where the stairs are. The floor was swilling in liquid and extremely slippy. I was directed upstairs by a member of staff. As I got to the upstairs room I saw 2 females who were extremely distressed. Both were receiving first aid for leg injuries from Ben Greenslade the co-owner of the bar. The boyfriend of one of them told me that they did not usually go to Time Bar as they knew there was always trouble there but on this occasion it had been one of the girls birthday and they had arranged to have a small area of the club cordoned off and the parents of the girl whose birthday it was had arranged for some Champagne to be placed behind the bar so they could have a private celebration. At this point the co owner Ben Greenslade approached me and immediately said "they do not need to go to hospital". I asked him what had happened and he told me that a girl had "put one of the injured girls through a glass table". I asked him where the offender was and he told me that the doorstaff had put her out. I asked him why they had not detained the offender and immediately called the police and he replied "because her boyfriend was massive". I told him that this was totally unacceptable and I required him to download the CCTV so we could identify the offender and view the incident. He told me he would do it when they closed and drop it off at the police station first thing in the morning. I agreed to this. The boyfriend of one of the girls then approached me and told me that he had repeatedly asked Greenslade to phone the police and the ambulance but Greenslade had not done this so the boyfriend contacted the police himself. He also told me that the reason the assault had happened was the female offender had tried to remove one of the girl's handbag and phone from the cordoned off area. One of the girls had seen this and confronted the offender who had grabbed her round the throat. The girl approached Greenslade and requested that the offender be removed from the premises and he told her to get one of the doorstaff. doorstaff laughing and joking with the offender and not removing her from the premises. Immediately after this the offender launched herself at the second victim, 'body slamming' her through a glass table. The table smashed causing both victims cuts to the legs and one of the victims requiring stitches to her foot. The other victim has extensive bruising down her thighs, buttocks, back and shoulder where she has smashed through the glass. The victim who was pushed through the table had been extremely lucky not to receive life threatening injuries and the consequences of the assault could have been horrific but the owner of the bar did not think it necessary to contact the police or ambulance. I can only assume he was trying to cover something up or is trying to protect the offender. Both the victims were taken to Carlisle Infirmary where they have been signed off work due to their injuries. I can think of no good reason why Greenslade did not call an ambulance to deal with the victims injuries and instead decided to treat them himself. I went back outside Time Bar and continued to monitor the premises. Groups of customers were sat on the kerb and the pavement outside the premises, extremely drunk and the doorstaff did nothing to assist them.

On Saturday 15<sup>th</sup> December 2012 I was again on a 1800-044hrs shift. I was posted outside Time Bar. About 0300hrs I saw a female come out of the bar for a cigarette for the third time. She was so drunk that the heels on her shoes were bent in as she was staggering so much. I watched her have a cigarette and then she came over to speak to me. Her speech was extremely slurred and she kept falling into me. I advised her that she should go home. I then watched her go back to the door of Time Bar and the doorman moved to the side to let her back in. I immediately confronted him about allowing this and he appeared to be surprised that this should be an issue.

There is no other licensed premises in Carlisle City Centre that allows the kind of behaviour that Time bar does and they only seem interested in getting the money from people and take no responsibility for the welfare of their customers. On many occasions I have seen people stagger down to Time Bar, being allowed entry, presumably pay to get in and then be ejected. The way this bar is run is completely spoiling the atmosphere on Botchergate and proves to be a real drain on police resources.

I have been a police officer for four and a half years.

Having been born and raised in Carlisle, I have seen considerable changes to Carlisle City Centre and Botchergate, from a busy main shopping area into what has the potential to either become a blight on the City or an attraction to locals and visitors alike.

What was an Avenue filled with shops, has become a mecca to licensed premises and a multitude of take-away's open until the early hours.

As a Police Officer I am regularly tasked with high-visibility foot patrol on Botchergate and the surrounding area. And during that patrol, we take the time to speak and interact with door staff and supervisors of various establishments, along with the general public.

Throughout various shifts on foot patrol on Botchergate I have encountered many members of the public out to enjoy themselves, some to the extreme of intoxication. It's at this point I may have become involved in dealing with them, and in doing so have been assisted by some door supervisors from various premises to prevent or assist in the arrest of persons. In some cases Door Staff have taken the time to step in to either prevent incidents and deal with them accordingly or have detained/restrained persons until Police arrive.

In recent years the bars and nightclubs have extended their opening times to the ridiculous 05:00hrs, and taken advantage of 24hour licencing. This has led to the Take-Away premises following suit to increase business revenue. This knock on effect is that people now stay out longer drinking to excess, and premises such as Time Bar are permitting intoxicated person's entry. In my opinion this is leading to a downwards spiral of unnecessary increased alcohol induced ASB, crime, and a stretch of resources of not only over-stretched resource such as Police but the impact to Ambulance Service, and Hospital treatment of individuals.

Most bars in the Botchergate area close at the reasonable 02:00-03:00hrs, with the exception of Club Rock and Time Bar. With the ever increasing opening times of these bars, everyone still left within the area home in on Time Bar, to continue their social experience.

Having dealt with numerous incidents at Time bar, the main theme is the overzealous ejection of patrons by door staff, which normally results in a complaint from the person on how heavy handed and unfairly he has been dealt with by staff. I have seen on occasion a male be ejected, I use the word ejected loosely, as the male was physically thrown out. And when the male has returned to remonstrate with the door staff, he has been confronted 'squared' up to by a member of door staff, before they've then started to grapple with each other. This incident has resulted in Police pulling both involved parties apart and speaking to them separately. The member of door staff was spoken to by the Duty PS at the time, and warned regarding his conduct and behaviour.

The Door Staff at Time Bar come across to the general public as a 'bunch of thugs', or so I'm told. But I have to agree in part, that their management and decision process in dealing with intoxicated persons falls far below the level required by SIA Licencing.

Due to the Door Staffs behaviour most serving Police Officers who work foot patrol on Botchergate, know instinctively to move down to Time Bar area after all the other establishments have closed, as it always has the potential to flare up... and usually does. If you take a look at the rest of Botchergate including the likes of Outrageous and Concrete only require passing attention from Officers. The door staff elsewhere, appear to be proactive and remove the potential for other incidents, calmly and with respect to the person. Where it would appear Time Bar react, and normally with a heavy handed approach.

Time Bar seem to let in anyone who is intoxicated, or who is on their guest list despite being banned or on pub watch. It is well known that Time Bar is the place to be for CUFC players, and one in particular was Gary NADINE. NADINE as you may know was banned from the City Centre after a nasty assault. However, Time Bar would allow him and 'others' access from the rear of the premises on Collier Lane.

I make this statement as a Police Officer who is in a position to offer his opinion on the needs and requirements for Carlisle City Centre. I would recommend that Time Bar step into line with all the other licenced premises and close at the reasonable time of 03:00hrs.

supervisors from banging a males head on the road while they simply rugby tackled the person down.

The supervisors have no respect what so ever for the safety or welfare of anyone they remove from the club and simply see it as a game. I have watched as people they have previously 'removed' are allowed back into the club only to cause further trouble.

Also heavily intoxicated people that have been refused entry from other clubs are allowed entry.

Time Bar requires extra police resources; you can almost guarantee a fight either inside or outside the club between 03:00-4.30 in the morning. I would say that you are definitely going to witness the heavy handiness of the door supervisors. The club itself requires special policing every weekend that along with further investigations required for the offence that go on inside means that it is a drain on Cumbria Constabulary budget along with taking officers of the street.

I make this statement as a police officer who is a position to offer an 'expert' opinion on the requirements of policing Carlisle city centre. To continue as we are at the moment is not an option, I feel that Time Bar should have it licence to stop open until 04:30 removed and to for it to come into line with Walkabout i.e. close at 03:00.

## MINUTES OF MEETING RE: TIME BAR 2<sup>nd</sup> MARCH 2012

PRESENT: Inspector Gilroy; PS Higgin; PC Paterson; Ben Greenslade, Time Bar Director, Dan Greenslade, DPS..

The meeting opened with Inspector Gilroy discussing all the positive actions and general improvement in the management of the bar until the end of 2011. It was then agreed by all that there had been a general slippage in the early part of 2012.

The Club's CCTV was discussed and Inspector Gilroy expressed his disappointment and concerns re. the loss of evidence due to evidential discs supplied by Time Bar had the wrong time and date on them and therefore did not record the incident required. Ben admitted that this was something which had happened but that it was now rectified and it was now operating correctly. Dan stated that he would rather give the Officer requesting CCTV the evidence there and then and it was agreed by all that it would be perfectly acceptable to close the CCTV system down for 15 mins whilst burning off a disc. It was agreed that this is what will happen in the future. Ben also added that every area in the Club was now covered by the CCTV and there were no blind spots as before.

Closing times were discussed and Ben explained that if the venue was full at 4.30 am it broke his heart to have to close due to the financial loss. He also said that since Party Party had closed they were getting in a more undesirable clientele, which they didn't particularly want. Pub Watch referrals were then discussed and it was explained by Inspector Gilroy that if they referred these undesirable characters to Pub Watch then it would prevent them from entering their premises, therefore making it a nicer place to go and reducing the chance of violent incidents.

Dan stated that Ben has taken a step back from managing the Club and that he runs it now and that his paperwork has all gone to Licensing and expects to be the official DPS before the end of March.

Ben asked for extra time in keeping the Club open, he would have liked 4.30 am on Friday and 4.45 am on Saturday. Inspector Gilroy said that he would prefer the same closing times for both nights and that 4.30 am would be clear to everyone. It was discussed around the table and decided that although there had been a bit of slippage at the beginning of the year the overall running of the club had improved. The Police would continue to monitor the Club and if things started to slip then the times would be reviewed. This was agreed.

## **AGREED ACTIONS**

- 1. Improve co-operation and communication between Time Bar staff, door staff and Police. Provision of statements on request. Provision of CCTV at time of incident (preferable) or within 24 hours of incident.
- 2. Clear demarcation of responsibility with regards to door policy and internal running of bar.
- 3. To actively place offenders on Pub Watch.

- 4. Ben Greenslade to resign as DPS and once paperwork returned from licensing Dan Greenslade to take over, before the end of March 2012.
- 5. One person will always be available during opening hours, in order to download evidence.
- 6. Premises to be empty by: Friday/Sat - 04:30 hrs Sat/Sun - 04:30 hrs

At the conclusion of the meeting Dan and Ben offered their personal e-mail addresses in order to contact them quickly and more directly.

### MINUTES OF MEETING RE: TIME BAR 11 AM 20<sup>TH</sup> JULY 2011

**PRESENT:** Inspector Gilroy; PS Higgin; PC Paterson; John Heron, Time Bar Director, Ben Greenslade, Time Bar DPS and Director, David Crosland, Pro-tect Security, Fred Watson, Carlisle Licensing, Sue Stashkiw Carlisle Licensing.

The meeting opened with Inspector Gilroy discussing the Action Plan, which had been agreed at a previous meeting on the 16<sup>th</sup> December 2010. He pointed out that a minor variation had not been subsequently submitted and questioned why. Ben Greenslade's reply was that he though he would have been sent the paperwork, this had not been received. It was pointed out that this was his responsibility and that the licensing officers would offer completion advice on request

The number of calls for police service, since the 16<sup>th</sup> December meeting totalled 64. 43 of those reported were after 03:00 hours. It was then explained that the purpose of the meeting was to agree an Action Plan to improve co-operation and communication in order to reduce calls for service. At this point Ben Greenslade informed everyone that he intended to step down as DPS and that his brother Dan Greenslade would be taking over after completing his Licensing training. It was confirmed that Dan Greenslade would go on the next available licensing course. Licensing would be informed when this has been carried out.

Inspector Gilroy highlighted the nature of the incidents the police had responded to in and around the premises with particular emphasis on a number of serious incidents where the police felt particularly let down by the failure to provide CCTV and statements.

Dave Crosland stated that it was in the door supervisor's conditions of employment that they assist the Police.

An incident was discussed where Ben had witnessed an assault but had not provided a witness statement, he denied knowledge of this, stating that he does make statements and that he was shortly to attend court with reference Aaron Turnbull. He accepted that he could not recall all the incidents mentioned

John Heron is to ensure a detailed incident log is kept in the premises, detailing what incidents have occurred and what CCTV has been handed to the Police, he hoped that this would capture both positive and negative actions.

Provision of CCTV was discussed in particular around an incident where CCTV was never provided following a very serious assault. It was identified that the club currently is covered by two independent CCTV systems, one of which can be downloaded easily and the second which requires an engineer callout at a cost to the club of £80 per visit. It was agreed that the delays associated with this procedure were not acceptable

After discussion, an agreement was made to upgrade CCTV so that footage could be obtained immediately and also there would always be a suitably qualified person on duty at all times to download the CCTV.

Dave Crosland pointed out that there was a lack of communication with regards to incidents both inside and outside the premises, between Ben, Door Supervisors and bar staff and he admitted, because of known previous problems, that he had just recently put on new door staff.

Ben Greenslade admitted that he had overruled door staff on previous occasions, though that this was due to emotional blackmail, he denied letting undesirables in the premises. Inspector Gilroy pointed out that it was up to the management to set their admission policy, which the door supervisors should then follow. Mr Greenslade's interference at the door was likely to cause confusion and be inconsistent.

Pub Watch was discussed and Ben refuted not being an active member and stated that he was responsible for referring several prominent troublemakers.

### AGREED ACTIONS:

- 1. Improve co-operation and communication between Time Bar staff, door staff and Police. Provision of statements on request. Provision of CCTV at time of incident or in any case, within 24 hours of incident. (Ben Greenslade agreed to submit a minor variation to the premises licence to include this provision).
- 2. Clear demarcation of responsibility with regards to door policy and internal running of bar.
- 3. To actively place offenders on Pub Watch.
- 4. Ben Greenslade to resign as DPS and once fully trained, Dan Greenslade to take over. A meeting to be arranged with Police and Dan to discuss expectations.
- 5. CCTV. A training plan is to be devised whereby 1 person will always be available, during opening hours, in order to download evidence.
- 6. Times. Premises to be empty by:

Friday/Sat - 04:00 hrs Saturday/Sun - 04:30 hrs Sunday/Mon - 03:00 hrs

At the conclusion of the meeting John Heron provided 2 e-mail addresses for direct contact with himself and the neighbourhood policing team.

Inspector Gilroy added that Police would continue to monitor the running of the bar and would inform John Herron and Ben Greenslade immediately if there were any further issues.

A review meeting is to be arranged.

To whom it may concern,

After viewing the notice outside Time Bar from the council to review the licence for the premises we wish to make a representation from the Ibis which is situated just across the road from Time Bar.

Time bar causes the hotel numerous complaints on a weekend, as it is only open on a Friday and Saturday. We notice a lot of people accumulate outside the premises to smoke and also to get some fresh air. Also we have noticed that the level of music played from the bar is extremely loud. Time Bar are meant to keep the front doors closed at all times, yet they keep them open 99% of the time, to let in cool air as they have no air conditioning inside.

On a bank holiday weekend, when Carlisle is at its busiest, we find there are more complaints. This due to the fact that not only are more people visiting time bar but that more trouble seems to be caused, which makes our hotel guests feel unsafe and annoyed the fact they have been awoken.

The complaints we receive are not only in the morning of the guest checking out, but also during the night about the noise coming from Time Bar. The only way we can solve this problem is by moving the guest to another room which is situated at the back of the hotel facing the car park as we have no control over the noise coming from Time Bar. This is not always possible as most weekends we are fully booked and people just have to stay in that room. This has a massive impact on business as people do not wish to return to a 'noisy' and possibly unsafe area where the hotel is situated.

In the hotel we have chandeliers in the front window, and on some occasions the bass from Time Bar can cause these to bounce in the window. If this is happening then the bass must be vibrating through the walls and will be heard in the bedrooms.


We understand that people have to leave the premises at some point during the night, but this can also cause noise complaints, as when the majority leave when the bar closes, people shout and scream through drunken behaviour and also fights break out.

I can also confirm that there is a queuing system in operation at Time bar, although, like every other venue, it is always hard to police since the introduction of the smoking ban, causing customers to constantly leave and re-enter for smoking breaks. The Queue for entering is to the right of the premises, whilst the smoking area & queue for re-entry after being stamped is from the left. There have also been barriers purchased & used over the Xmas period following several requests for this to help try and control the access better.

Very nice location, walking distance to loads of Restaurants in the area (the family friendly ones are 15minutes and more walking distance beside the Chinese (adjacent to hotel) and Nandos (around the corner)). Rooms are of average quality, mattresses are not of good quality just firm sponge (no springs). There is a shower and toilet and they were clean and relatively good condition.
