This report is presented to give an update on the current position under the Licensing Act 2003.

Background

- 1.1 The Licensing Act 2003 took effect on 24th November 2005 and this Council had issued all licences by the end of February 2006.
- 1.2 During 2006 and early 2007 there was a run of variation applications as premises have been consolidating their positions in the entertainment market place. We now appear to have reached a position where variations are down to about two per month, with transfers and changes of Designated Premises Supervisor becoming the more common application. Temporary Event Notices (TEN's) have continued to be popular with many villages/communities taking advantage of this 'non bureaucratic' method of holding an event. Full licence holders have also been using TEN's for one off events and a number of personal licence holders are specialising in running these events on behalf of organisations.

Current Issues

- 5.1 The licensing section continue to respond to applications, there being on average 20 pending at any one time.
- 5.2 An Independent Fees Panel set up by the DCMS has gathered evidence during 2006 in relation to the fees for premise licences. Their report was published in February 2007. The DCMS have said that the fee structure under the Licensing Act 2003 will be set fairly to ensure that there is full cost recovery for local authorities. The Minister is still considering the report and his response will be included in a future report to this committee.
- 5.3 A number of Licensing Update Seminars for the trade were arranged at Brampton and Carlisle during March and April 2007. This was supported with funding from Carlisle and Eden Crime and Disorder Reduction Partnership.
- 5.4 The seminar looked closely at licence holder's responsibilities under the Act and stressed the importance of staff training, especially with regard to under age sales. Police Officers also attended the events, which proved beneficial to both themselves and other delegates. The response from the trade was very poor, only about 20% of licensed premises being represented.
- 5.5 One of these seminars was a special event that was organised in respect of village halls and community centres. Their responsibilities are different to pub and club premises licences in that they tend to have more temporary event notices. This particular event was organised by Rural Support Officers and also included health and safety and financial advice. This event was well supported and received excellent feedback from delegates.
- In a joint initiative with Eden District Council and Cumbria Constabulary, we are looking at the 'Best Bar None' scheme initially started by Greater Manchester Police about three years ago. This scheme aims to reduce the risk of alcohol related harm, disorder and crime by establishing a benchmark of good practice for licensed premises. Preliminary meetings have been held and an update will be presented at a future meeting (Appendix 1).

GEST GAR NONE

- Best Bar None is a scheme which aims to reduce the risk of alcohol related harm, disorder and crime by establishing a benchmark of good practice in licensed premises.
- Through Best Bar None we are seeking to create consistence of standards throughout the area with which to underpin the alcohol harm reduction strategy and the 2003 Licensing Act.
- In addition we aim to improve the knowledge and skills of enforcement and regulation agencies, licensees and bar staff in order to deal effectively with issues relating to the management of licensed premises.
- Best Bar None schemes are being set up in the Carlisle and Penrith areas. In each area, all licensed premises which apply for Best Bar None accreditation are assessed by independent assessors against four key objectives: the prevention of crime and disorder; public safety; the prevention of public nuisance; and the protection of children from harm.
- Awards and accreditation are then given to successful premises.
