1. BACKGROUND INFORMATION AND OPTIONS

- 1.1 A petition has been submitted by Brampton Parish Council, signed by 64 residents, objecting to the proposed parking charges at Talkin Tarn. A sample page from the petition is attached together with a covering letter. The petitioners consider that charges should not be introduced as similar leisure facilities within the urban area are free of charge.
- 1.2 As part of the 2009/10 Budget proposals the Business Plan for Talkin Tarn identified that additional income of £40,000 per year would be required to ensure that present levels of service could be maintained in the future after an annual revenue contribution from the County Council expires in 20010/11. The present proposal to introduce a £1 per day parking charge and charge £25 per year for a parking permit to be used by Friends of Talkin Tarn are estimated to generate income of £26,000 per year. This additional income will be ring fenced to Talkin Tarn to ensure levels of service can be maintained.
- 1.3 Members may wish to consider referring this issue back to the Executive for them to consider the level of charge and the hours of operation of the charging scheme.
