#### **Homelessness**

The homelessness Task and Finish Group continue with their work with a workshop for partners which was held on 6<sup>th</sup> February 2012. A verbal update will be provided at the panel on these events.

## **Support for Elderly People in their Homes**

Members may recall that the DFG Task Group were to reconvene to look at other support which is provided to elderly people in their homes. Due to pressures of time it has been suggested that this work is carried over to the next Civic Year and a new Task Group be appointed to undertake the review.

### 4. Resource Centre Visit

Arrangements were made for Members of the Panel to have a tour of the Resource Centre in Shaddongate on 7<sup>th</sup> February 2012. An update on the plans for the Centre is included on today's agenda.
