1.0 BACKGROUND INFORMATION AND OPTIONS

- 1.1 The Local Development Framework introduced by the Planning and Compulsory Purchase Act 2004 requires a Statement of Community Involvement (SCI) to be produced by each Local Planning Authority. The SCI document sets out how the Planning Department will involve communities and stakeholders in the production of policy and decisions on major planning applications.
- 1.2 The SCI supports all documents prepared under the new Local Development Framework. It sets out who, how and when communities and stakeholders will be involved in policy production and major planning application decisions. The management and resourcing of any consultation within the SCI document is also included.
- 1.3 This stage of the process is defined in PPS12 as the pre-submission draft. The draft Statement of Community Involvement and the Statement of Consultation on the SCI is attached at Appendix 1.

2.0 CONSULTATION

2.1 Consultation to Date

Regulation 25 of the Town and Country Planning (Local Development) (England) Regulations 2004 requires early involvement before the writing of the draft SCI. This has already been completed by departmental consultations, a questionnaire being sent to selected stakeholders and a section included in the May 2006 Citizens Panel questionnaire. The results of these are set out in the Statement of Consultation on the SCI attached at Appendix 2.

2.2 Consultation Proposed

A formal 6 week consultation stage is proposed. Notices will be placed in the Cumberland News and posters in libraries. The draft document will be available on the Council's web site, at the customer contact centre and local libraries.

- 2.3 Following consultation the responses will be reported back to Infrastructure Overview and Scrutiny Committee. Consultation feedback will enable editing of the draft SCI before a further report back to Executive. Following approval by Council a revised version will be submitted to the Secretary of State, at the same time as further consultation. An examination into the document will be undertaken by the Planning Inspectorate. Recommendations by the Inspectorate will be binding and need to be incorporated into the SCI before adoption.

3.0 RECOMMENDATIONS

- 3.1 It is recommended that the draft Statement of Community Involvement be forwarded to Council for approval prior to consultation.

4.0 REASONS FOR RECOMMENDATIONS

- 4.1 In order to fulfil the statutory requirements of the Planning and Compulsory Purchase Act 2004 the Council is required to consult on a draft version towards adoption of the Statement of Community Involvement.

5.0 IMPLICATIONS

- Staffing/Resources – The document production and management of the consultation is resourced from within the Local Plans and Conservation section.
- Financial – Costs of production and consultation are contained within Local Plans and Conservation budgets.
- Legal – The consultation process proposed is a statutory requirement of the Planning and Compulsory Purchase Act 2004 and associated regulations and guidance.
- Corporate – The SCI will provide a framework for the Planning section's involvement with the communities and stakeholders affected by policies and development proposals.

- Risk Management – Without consultation on the draft SCI the Council will not be able to fulfil its statutory requirements under the Planning and Compulsory Purchase Act 2004.
- Equality Issues – Documents will be available in different formats on request. Access issues relating to consultation are covered in the document.
- Environmental – None
- Crime and Disorder – Appropriate bodies who are involved in the reduction of antisocial behaviour are included in the list of consultation stakeholders.
- Impact on Customers – The SCI sets out how they can get involved and have their say on all planning policy and development decisions.

1 Introduction

- 1.1 The Statement of Community Involvement (SCI) sets out the Council's intended approach to engaging effectively with the community on all planning policies and decisions. The new Local Development Framework introduced in the Planning and Compulsory Purchase Act 2004 requires the Council to prepare Development Plan Documents with early consultation with all stakeholders and communities affected.
- 1.2 This differs from the existing system where consultation occurs at a later stage, once the **planning policies** have been written. The Government aim is to empower communities and stakeholders to help shape their own environments and be enabled to play a key role in plan making.
- 1.3 Community involvement at the **planning application** stage will be increased for larger or sensitive proposed developments. This will be done by encouraging consultation at an early stage (before the application is formally submitted) and by increased involvement through the planning process.

Carlisle City Council's vision

- 1.4 We seek to extend community involvement in many areas, including in the planning processes as described in this document.
- 1.5 Carlisle City Council welcomes participation by its citizens in its work and has won 'Excellence in Communications' award for its Focus magazine from the Chartered Institute of Public Relations in 2005.
- 1.6 The Council was awarded a "good" score in the Government's Comprehensive Performance Assessment (CPA) process announced in October 2004. The assessment found that Carlisle City Council is doing well in the following areas:
- The Council has consulted with local people and is acting on their views, including responding to the views and needs of young people.
 - It is working in partnership with others to deliver improvements for the residents of Carlisle.
- 1.7 The Council says in its City Vision Partnership booklet that

"City Vision is all about communities having their say in the future but it doesn't stop there. This Partnership is committed to communities being empowered and effectively involved in making decisions that affect their lives"

with a Key Priority

"To ensure we effectively act upon the views of the people of Carlisle, involve our communities more actively in decision making in the city area"

and in their Listening to the Rural Voice strategy

“A rural society that is fully engaged in decision-making processes that affect local issues and has the capacity and support to address local problems and opportunities”

Council's strategy for community involvement in planning

- 1.7 We want to make it as easy as possible for you to become involved in the planning system. Ensuring that your views and comments are received as early as possible will mean that we will have time to take your views into account in drawing up policies and proposals. Communication must be a two way process where everyone who wants can be:

INVOLVED in the planning process;
EMPOWERED to have a voice within the planning and decision making process; and
ENABLED to play a key role in the strategic planning of the environment.

- 1.8 We have the following strategic aims:
- To create plans that reflect the wishes of the community
 - To involve all stakeholders / community that will be affected by the plan
 - To engage in consultation appropriate for the task / fit for purpose
 - To allow feasible time scales for consultations
 - To be transparent
 - To be fully accessible
 - To make effective use of resources.
 - To provide feed back showing how consultation has affected policy

Consultation will not take place when:

- modification of plans is not possible
- there is only one option
- the community has recently been consulted on the same issue

This will help to avoid consultation fatigue

- 1.9 In support of these Strategic Aims and in line with Government requirements, we will consult and secure community involvement in two areas of planning.

- A. Development Plan Documents and Supplementary Planning Documents that are part of the Local Development Framework as set out in the 'Local Development Scheme for Carlisle District'
- B. Development Control decision making in relation to major planning applications

- 1.10 Where possible the consultation on planning issues will be linked to other council consultations. All consultations by the planning section are set out 3 years in advance to enable Council consultation co-ordination.

- 1.11 The Planning Charter June 2006 states that 'the Council is committed to providing a Planning Service that:

- "Provides the local community with appropriate opportunities for influencing planning policy, for commenting on applications and for ensuring the quality of decisions."
- "Works with partners and stakeholders for the benefit of the community."

- “Council is committed to providing the best possible pre-application service and will encourage developers and applicants to enter into pre-application discussions with the Council, the local community and any relevant stakeholder groups at the earliest opportunity.”

The new planning system

- 1.11 Under the new planning system that came into force in 2004, central Government requires local authorities to consult stakeholders and the community upon their development plans. The current development plan is the Carlisle District Local Plan adopted 1997, the Cumbria and Lake District Joint Structure Plan 2001 – 2016 and Regional Planning Guidance for the North West. These are at present in the final stages of being replaced by the Carlisle District Local Plan 2001 – 2016 and the Regional Spatial Strategy.

- 1.12 Under the new system the Council’s Local Development Framework will consist of a “saved” Local Plan and a number of Supplementary Planning Documents. In time the Local Plan will be replaced by a series of Development Plan Documents
- 1.13 Meanwhile, in order to complete the Local Plan 2001 – 2016 the findings of the Carlisle Renaissance, the Strategic Flood Risk Assessment, Strategic Environmental Assessment, Retail Capacity Study Update and the Regional Spatial Strategy have been taken into account in the Revised Redeposit Draft Local Plan 2001-2016. This Plan went out for 6 week consultation in between 25th September and 3rd November 2006.

- 2.1 This document (the SCI) draft will be available for consultation between 20 November 2006 and 5 January 2007. Participation in this draft SCI

- 2.2 The process for preparation of the Statement of Community involvement is indicated below. The Council will secure community participation in the draft document in this context.
- 2.3 Participation in the preparation of this document involves your input to ensure that we do involve you when and how it is most effective.
- A consultation letter was sent to 69 consultees asking if there were any planning policy making or planning application consultation issues, with 6 weeks to respond. (Reg 25)
 - 11 questions included in the May 06 Citizens Panel to 1,000 local members of the community. (Reg 25)
 - Discussion and 6 week consultation on the draft SCI to enable its revision to produce the submission SCI.
 - 6 week consultation on submission SCI
 - independent examination by Inspector of submission SCI for compliance with the tests of soundness set out in Appendix 1 and your representations
 - Inspectors report enables us to produce adopted SCI

Reviewing the SCI

- 2.4 The effectiveness of the Statement of Community Involvement and consultation process will be reviewed in the future as part of the continuous process of updating the Local Development Documents. The timetable for any future reviews will be included in the Local Development Scheme.

3 Community involvement in the Local Development Framework (LDF)

Background

- 3.1 The LDF is a set of documents that describes the policy framework for promoting and controlling development.
- 3.2 There are two types of local development documents:
- **development plan documents** that have been subject to independent examination and have the status of a development plan, which carry more weight.
 - **supplementary planning documents**, which are not subject to independent examination and do not have development plan document status. However, they will be subject to rigorous procedures of community involvement and sustainability appraisal so giving them considerable influence on decisions.

The Local Development Framework

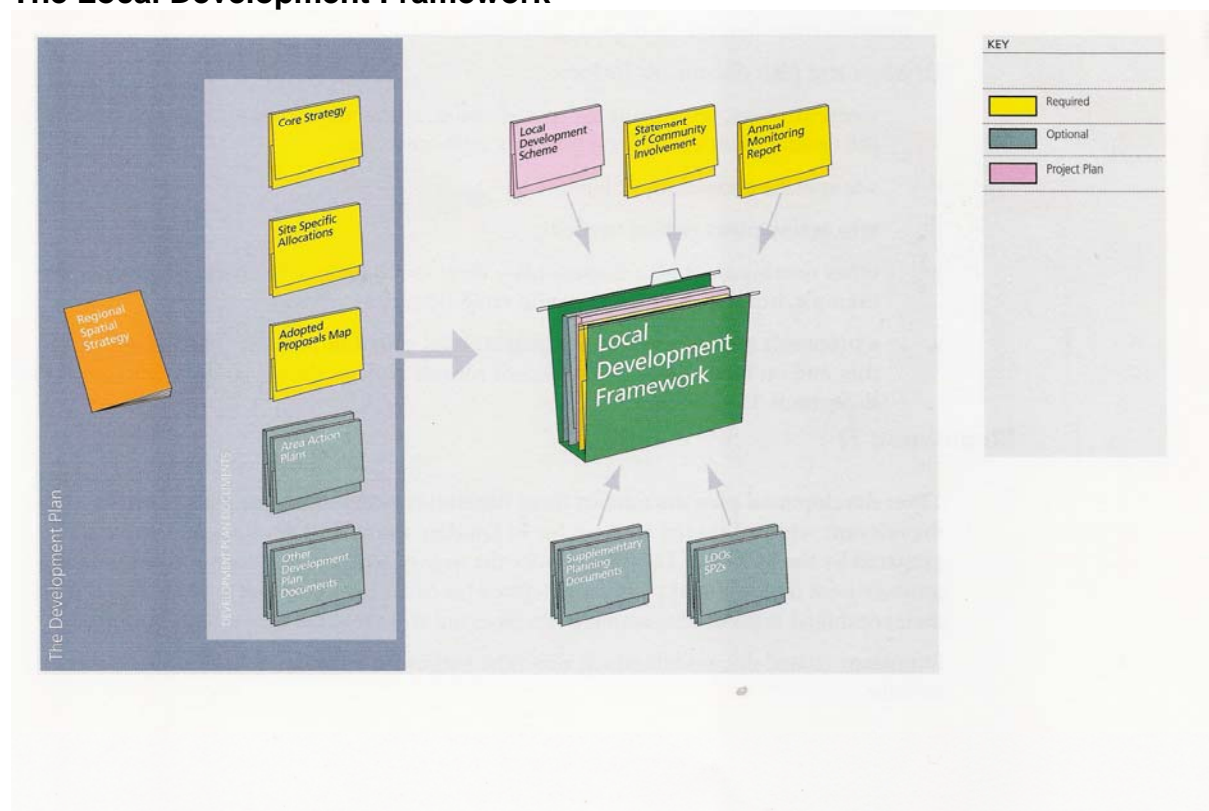


Fig 1 Extract from ODPM Planning Policy Statement 12 (PPS) 2004

Community involvement

- 3.4 There are many organisations and individuals that have an interest in shaping the future of Carlisle. The Planning and Compulsory Purchase Act 2004 and related Regulations set out the consultation standards that underpin this Statement of Community Involvement. These can be seen in the PPS12 on the www.planningportal.gov.uk or www.dclg.gov.uk

Who we intend to involve

3.5 Carlisle will involve the appropriate stakeholders and sections of the community on every production of planning documents. The involvement will be mostly at an early stage to enable plans and decisions to reflect the views of the majority.

3.6 The broad categories of stakeholders to be consulted are:

- The general public:
- residents of Carlisle District
- those who work in the district
- local neighbourhood and resident's groups
- Parish councillors
- Cumbria Association of Local Parishes
- other community and neighbourhood-based groups
- groups representing black and ethnic minority communities
- groups representing the young and the city's elders
- groups representing disabled people
- faith groups
- travelling communities

Political representatives:

- ward councillors
- MPs
- MEPs

Individuals, groups and organisations, including those with an interest in:

- environment, transport and health
- education, learning, skills and employment
- business, industry and commerce
- retail and leisure
- landowners
- sport, recreation and tourism
- agriculture and fisheries
- law enforcement & legal representation
- voluntary sector
- planning and property
- politics
- communities

National and regional governance:

- Government Office for the North West
- North West Regional Assembly
- Development Agencies – North West Development Agency & Cumbria Vision
- Housing Board
- Other Government departments and agencies
- neighbouring local authorities & parishes

Providers of public services, including:

- utility providers
- telecommunications operators
- transport companies and organisations
- national services

3.7 Our list of consultees will develop continuously. An up-to-date list will be available on request from the Planning and Housing Services at Carlisle City Council.

- 3.8 List of consultees for the Local Plan first deposit can be viewed on the Council's website www.carlisle.gov.uk/localplans 'Statement of Community Participation July 2004'
- 3.9 Independent advice on planning issues or support in preparing a community response to a consultation is available from independent agencies as well as Planning Aid North service which is provided by the Royal Town Planning Institute, particularly to those of limited resources.

How we want to involve you

- 3.10 The Council is seeking to secure community involvement in the planning processes as early as possible, and to engage with all sections of the community and stakeholders to produce plans that reflect what is wanted. Special attention will be paid to engaging groups that in the past have been difficult to gain opinions from.
- 3.11 A range of different consultation and engagement techniques will be applied in appropriate quantities to the level of outcome and resources available.
- 3.12 Your elected representatives both at parish and district level can make your views and opinions known about the policies that affect you.
- 3.13 If you need help in making a representation on a Document then this can be obtained from Planning Aid.

- 3.14 Our proposed consultation methods are shown in Appendix 2.

When we want to involve you

- 3.15 It is important that you are involved in the plan making process as early as possible so that your views can help to shape the policies and proposals of the Development Plan Documents.
- 3.16 Involvement in the preparation of Development Plan Documents will be at three stages, firstly at the pre-document stage, then on the draft document stage, then again on the submission document.
- 3.17 Every document has a Sustainability Appraisal on which we will also consult you. The Development Plan Documents will also have a Strategic Environmental Assessment included in its Sustainability Assessment. These studies will be consulted on at the same time as the Documents
- 3.18 The process for preparing and consulting on Development Plan Documents and Supplementary Planning Documents are shown in Appendix 3a & 3b. Each process entails a number of stages of information gathering, consultation and drafting, leading to adoption, after which continual monitoring takes place.

Feedback and reporting

- 3.19 The results of each consultation will be fed back into the plan to shape the document to reflect the wishes of those that will be affected by the plan.
- 3.20 Reports of consultations will be published after each stage. These will cover a summary of the comments and the Councils response. Letter/email will be sent to all respondents informing them of the availability of the consultation reports which will be available on the website, at Council offices and at libraries

4 Community involvement in Development Control (Planning Applications)

Background – Development Control

- 4.1 Carlisle City Council as the local planning authority for the area deals with all the planning applications for Carlisle District. This is called Development Control. The system works within the framework set by the Development Plan. This is currently
- *Regional Planning Guidance for the North West*
 - *Cumbria and Lake District Joint Structure Plan 2001 – 2016 (adopted April 2006)*
 - *Carlisle District Local Plan adopted 1997*

these are in the process of being replaced by

- *Carlisle District Local Plan 2001 – 2016*
- *The Regional Spatial Strategy*

In the future they will be replaced by the *Local Development Framework* as already described.

- 4.2 The Development Plan does not in itself prescribe how each planning application should be determined. Planning legislation and government guidance allows a considerable degree of discretion to local planning authorities in considering each case. The guidance attaches significant importance to seeking and taking note of the views of residents and other stakeholders. There are minimum standards set in regulations as to who should be consulted.

- 4.3 A 'Planning Application Validation Checklist' is sent to all planning applicants, which includes a list of all the information and studies that need to accompany a planning application. Under the section 'Supporting Planning Statements' it states details of consultations with Carlisle City Council and the wider community/statutory consultees undertaken prior to submission. However, a separate statement on community involvement may also be appropriate.

Community involvement

- 4.4 The Council will encourage developers of **Major development** to involve the community prior to the submission of the planning application. Developers should contact the Development Control section of the Planning and Housing Services on 01228 817179 before submitting their application in order to establish how the community can be involved. The Council is keen to help facilitate consultation where appropriate and work with developers to ensure an acceptable outcome for the communities affected by major development.

Major applications are those defined in the **Town & Country Planning (General Permitted Development) Order 1995** and the **ODPM PS2 Return**

Housing development sites where 10 or more dwellings proposed, or consideration of housing on sites of more than 0.5 ha in size
Development with a floor area 1000sqm or a site of 1ha or more. Development includes uses and infrastructure
Change of use development meeting these thresholds is included
Development requiring the submission of an Environmental Assessment
Development that does not accord with the Development Plan
Development that proposes the closure of a public right of way

Who the Developer needs to involve

- 4.5 The extent of involvement will be confirmed by the Council on a case-by-case basis. Those to be consulted should include:
- statutory consultees
 - neighbours
 - community groups
 - service providers
 - others likely to be affected by the development

How the Developer will engage with the community

- 4.6 The Developer should provide a Consultation Statement as part of the planning application, setting out what community involvement has been carried out. This should reflect the following steps and actions:
- Awareness raising, for example:
 - Site Notices
 - Press Releases
 - Letters to adjacent residents
 - Leaflet drops
 - Notification to Interested Stakeholders
 - Consultation
 - Statutory stakeholders (eg Highway and drainage authorities)
 - Adjacent land owners
 - Interested stakeholders including Parish Councils
 - Participation
 - Events and Exhibitions held
 - Feedback
 - Recording, analysing and actioning comments received
 - Feedback to the community
 - Describe influences/changes to the proposed development following consultation activities

Timing of community involvement in major developments

- 4.7 The Council will discuss with the Developer the programme for community involvement on a case-by-case basis. In any event, the Developer will have to plan for an adequate period of consultation and for handling feedback.

What the Council will do

- 4.8 The Council will carry out its own consultation on all planning applications submitted in line with statutory requirements as set out in the Town and Country Planning (General Development Procedures) Order 1995.
- 4.9 The Council raises awareness of applications and will consult with affected and interested stakeholders. There is the statutory 21 day period to respond.
- 4.10 In addition to the statutory consultations we may involve stakeholders and the community further on a major development. Cases where we may need such consultation are given below in the context of three tiers.
- Tier 1 Applications where they do not accord with Carlisle Local Plan (in the future the Carlisle Development Framework) policies or are of a large scale or controversial
- Tier 2 Applications broadly in accordance with the Carlisle Local Plan (in the future the Carlisle Development Framework) but raising controversial issues or detail, including sites 'sensitive' to development pressures.
- Tier 3 Large applications, which require wider community consultation as the site is 'sensitive' to development pressure and/or raises significant objections
- 4.11 Each tier will require different approaches to consultation, set out in Appendix 2.

5 Management and resourcing

There is a need to balance the scale, extent and format of community involvement within the resources available.

Methods of consultation need to make the best use of limited resources (staff and finances). Involvement will need to be well focused to will obtain views from stakeholders and the general public that are relevant and useful to help create policies of value.

Building on the established mechanisms and structures in place for consultation will be effective use of resources whilst allowing room to include additional consultation methods when required.

The costs involved in consultation will be covered by the LDF and Development Control budget using staff in each of the teams.

The Local Plan and Conservation Team for the LDF includes:

1 Planning technician

2 Support Staff

with assistance from the Corporate Communications Team

The Development Control Teams will soon include:

Seasonal students

with assistance from the Legal and Democratic Services

Expert assistance will be sought from external Consultants and Facilitators when appropriate.

Introduction

This 'Statement of Consultation' sets out what consultation has been undertaken in the preparation of the draft 'Statement of Community Involvement' (SCI) document.

Consultation before the first draft SCI

In March and April 2006 pre draft consultation took place in line with Regulation 25 of the Town and Country Planning (Local Development)(England) Regulations 2004. This consisted of a letter to local and surrounding planning authorities and elected representative bodies.

A set of 11 questions were included in the May Citizens Panel 1,000 people who are a cross section of the local community.

Letter requesting comment

A letter was sent to 69 consultees asking if there were any planning policy making or planning application consultation issues that they would like to raise in relation to their organisation before the draft SCI was written. A 6 week period was allowed for responses.

See appendix 1 and 2

We received 7 responses to the letter, 3 by email and the rest through the post.

A summary of the responses in appendix 3

The Citizens Panel

11 questions were included in the May Citizens Panel which asked for opinions of past experience with the consultation methods and possible future methods of consultation. These were in respect of both policy documents and planning applications. See appendix 4

SUMMARY of Citizens Panel results on Planning applications and issues

- The most popular source for obtaining information about planning and/or to look at planning documents was local newspapers (78%).
- Overall 17% of the panel has taken part in the consultations listed. 14% has taken part in the City Council Local Plan; 1% has taken part in the Lowry Hill/Wakefield Rd Development brief; 1% has taken part in the Cosmo Site Development brief and 1% has taken part in the Burgh-by-Sands Parish Design Statement.
- For those that have taken part in the consultations, the main way of finding out about the consultations was via a notification letter (37%)
- Only 10% say they are not interested in planning issues covered in the Local Plan or Development Briefs. 44% say they did not take part because it was not relevant to where they live and 41% did not know a consultation was taking place.
- 71% of the panel has previously found out about planning applications through a newspaper notice or article
- 90% of the panel thinks that applicants should do some public consultation on their plans before submitting a major planning application
- On issues of planning policy and/or planning applications, around 60% would get involved if consultations were through the Cumberland News.



INTRODUCTION

CN Research carried out the fieldwork and report of the 19th Citizen Panel questionnaire. This report looks at responses to questions from Carlisle Renaissance on valued and promotional aspects of Carlisle, views on the Performance and Council Tax Summary Leaflet; Talkin Tarn; Community Safety and consultation mechanisms for planning issues and planning applications.

METHODOLOGY

A postal questionnaire was carried out with Citizens Panel members. 1453 questionnaires were sent out and 615 returned in total, giving an unadjusted response rate of 42% and a + or – error of 3.9% at 95% confidence levels. The preparation and fieldwork began in May, data entry was carried out throughout June and analysis was done in early July.

i.e. The proposal to build a giant Tesco in the middle of the city, creating tremendous traffic jams, for everyone, should not even be considered, that was agreed by two thirds of the citizens panel 18th issue.

Simply a fair system for all.

Why does the council hinder certain companies from carrying out business in places where the council have not designated e.g. Willowholme ice rink- this is so easy to get to as there is generally no traffic problems getting there, so what if it does not fall into the correct compartment invented by the council. The building seems ideal for its purpose and no doubt very cost effective in this area.

Petitions and mass produced letters in response to planning issues distort the public response to that of the vociferous few and should be discounted.

Clear maps and sketches of future buildings which may be proposed in the local press.

Public notices in the Cumberland news works and for major decisions/ discussions public should be approached by way of a council meeting to see real views held.

I keep a general ear open and respond verbally or in writing when I feel my comment is necessary.

Enclose these surveys with the council tax bills, instead of all the other rubbish, after all we don't decide how our money is spent, so why tell us

Is any of this worth it? I'm still waiting to hear about my in-laws habitat

Some decisions are absurd and give residents the impression that no form of co-ordinated thinking takes place at the civic centre

Advice should be given by those citizens whose family have lived in the areas concerned and not by those with very limited local knowledge

Recently I was part of Orton parish planning committee, we invited heads of departments to the launch night but only one or two turned up, why should we take an interest in you if you don't take an interest in us?

There should be greater transparency of planning decisions and the minutes of meetings should be more accessible and without confidential sections

I own a business in Botchergate South which you plan to knock down, nobody has come to us and explained what is going to happen to us and our businesses in the area, we are locals but the council are only interested in the big stories

Local radio

Local people should have the final say, not individuals like John Prescott

Make the public better aware of planning applications and permissions and refusals

We should all have a say, notification of major plans is often too discreet, so is not opposed

More details in local newspapers

Ask local businesses before allowing large national shops to open and wipe out small community shops and post offices

Sack the planning committee

Listen to what the people of Carlisle Really want, i.e. the Lonsdale issue

The best way would be to put public notices in the Cumberland News and place posters adjacent to the area effected and also send out written notification to adjoining properties that are effected

Get on with it, don't take years

More focus

Don't use outside consultants, who will at the end of the day provide the answer you wanted and therefore do not put any new input into the project

Written policies that apply to all, would be helpful

You need to be unbiased and consistent

The city and district councils should give more weight to the views of the parish councils, when they ask for their opinions

Strike a balance about consultation with members of the public (major organisations) on planning applications- consult to who is appropriate.

Those receiving letter notifying you of application should receive letters of result.

I like to look at the council's website from time to time but have never looked for information planning matters. Highlighting major issues more often may stimulates better involvement.

Get off the web, I can't afford it.

Most consultation (so called) is leading aspiring participants to agree with someone else's views.

Applications seem always to be low key, almost as though they are hoped to be passed unnoticed. I resent this - especially as I don't routinely object to any local building.

Difficult, newspapers and Border TV and in good time - 2-3 weeks is not enough time to make a considered decision or judgment.

Consultation and feedback maybe helpful to the council committees but does it change council decisions. E.g. if you want public involvement you may as well have referendums for everything as well as council vote.

The council should ensure time scales for grant applications are met i.e. Scotland to west ring road.

Planning need to think of wider population in Carlisle and surrounding areas invite younger youths and visit schools to get their views

Not sure.

Use local TV and radio, this will cause more interest.

Feel local newspapers should list all proposed planning policies and planning applications.

The council does a good job, this is appreciated.

Actively engage people, e.g. telephone panel members directly, contact survey people directly if any planning applications are in place within a mile of their homes.

That people actually have a say and rights. It is all very well consulting, but then to make an popular decision for whatever reason - regardless of public opinion because the decision makers think they know best- is all rather pointless and infuriating.

When planning consult neighbourhood not just the next door neighbour. Particularly when a large scale extension is requested. Take note of views and not only the size of the building, extensions to bungalows, should not be larger than the main building.

Advise residents associations.

Perhaps local councillors should attend community meeting when invited, regarding plans affecting there areas.

Best method of getting a response is to write to Civic Centre, telephones calls seemed to be ignored!! Martin Tickner in Civic Centre planning department has been very helpful with a query about a neighbours planning permission.

The public should be able to have a say in what happens in Carlisle, it affects us all. Re Tesco building store is going to make Carlisle more gridlocked that should have been built outside Carlisle live the Warwick road one.

Issues like planning are best left to be discussed by experts, who are unbiased and preferably local

Most people are only concerned about planning if it affects them personally

Major planning applications should be placed in a prominent position in the local newspaper, so that at least people would have the opportunity to hear about the plans and take action if they wish

Older people like myself are rarely consulted be the Count Council

When Brampton Parish Council turn down plans, Carlisle Council often give them the go ahead

Concentrate on the Northern bypass, early completion will improve transport and business and reduce pollution

Use decent architects instead of the current rash of " Fred Story Bland" style buildings and stop all barn conversions

Rate payers should be consulted before the council take action and spend money on the city

The public need to be made more aware of planning applications and should have the opportunity to comment on applications

I think for major planning applications there should be a full page advert in the Cumberland News or an exhibition at the town centre with people there to answer questions

More public meetings

Consult international artists and architects

Residents should be consulted when there are plans to build

Consultation is pointless as government lays down the policies that councils must abide by

It should be easier for all to pass on there opinions and to be listened to

Transparency

I think a 3D model of any future plans, exhibited in the city centre would reach the most people and give the clearest impression

More progress reports would be helpful to the general public

You need a higher level of publicity, I have not been aware of any consultations unless I have been written to directly

Major plans should always be on display for the public

Planning is a joke, where is the Western/Northern relief road

I was born in 1914 and feel I am too old to answer a lot of these questions

The planning department should take more notice of local people on these matters

Residents should be made aware of applications before planning decisions are made, newspaper columns are insufficient

Tesco should not be allowed to build on the viaduct because it will have an adverse affect on Denton Holme

This council is allowing far too many house building applications to build too many properties at each location, It highlights a greed for council tax and not a consideration for the property purchasers to have space.
