#### 1.1 Options for Carlisle City's Property Portfolio

The Executive will now consider the above item on 16<sup>th</sup> February 2009. In order for CROS to consider this item prior to this date, their meeting on 19<sup>th</sup> February 2009 will be rescheduled. In consultation with the Chair and Vice-chair the meeting can be held on either 9<sup>th</sup> or 11<sup>th</sup> February and Committee Members are asked to agree a date.

### 1.2 Performance Task Group

The Performance Task Group held its first meeting on 12 November 2008 to review the Council's performance framework. The next meeting of the group will be held on 18<sup>th</sup> December 2008 and will discuss what performance information should be reported to scrutiny and the frequency of reporting. Following this meeting, a final report will be provided to Members outlining what indicators will be reported to the Committee in future.

## 1.3 Pay and Workforce Strategy

Due to no significant update on the above for this meeting of CROS, there will be no agenda item on PWS. The Head of Personnel & Development Services has provided the following:

We are now well into the final stage of the PWS project - implementation. We are meeting regularly with the trade unions in order to arrive at a consensus with regard to a new Pay Policy for the council. This will incorporate the alignment of Job Evaluation scores (points) with pay and the principles and arrangements by which we will reward all our employees in the future, including any temporary transitional arrangements (notably back pay and protection). It will also incorporate the outstanding single status matters, about which we have now reached agreement with the unions.

The eventual overall agreement will need to be one that is both seen as affordable by Members and likely to be acceptable to the majority of union members who will be balloted on the outcome. Discussions with the unions on such an agreement are progressing well and in a constructive manner.

## 1.4 Work programme (Appendix 1)

The new work programme format is attached as Appendix 1. The Informal Chairs Group agreed this format on 6 November 2008, and the revised format was circulated to all scrutiny members on 11 November.
