1. BACKGROUND INFORMATION AND OPTIONS

- 1.1 A petition has been submitted signed by 134 residents of the Botcherby Ward requesting the installation of a Bus Shelter near the junction of Edgehill Road/Pennine Way where a Bus Shelter was previously located. A sample page from the petition is attached together with the covering letter submitted with the petition. A plan of the area is also attached to highlight the general area where the shelter has been requested.
- 1.2 A Bus Shelter was previously located outside No. 393 Pennine Way but this was removed several years ago following repeated complaints about anti-social behaviour in and around the shelter, and after consultation with local ward members.
- 1.3 At the present time all requests for new Bus Shelters are forwarded to the County Council (Public Transport Unit) for them to consider the request and decide what action is appropriate. It is usual to assess the particular location, identify possible sources of funding and consult the local community. It is proposed that this petition should be forwarded to the County together with any comments the Council may wish to make. If a shelter is eventually provided at this location it would be normal for the City Council to deal with the future maintenance of the shelter using the funding provided in the Miscellaneous Environment Budget.

2. CONSULTATION

2.1 Consultation to Date.

There has been no consultation on this issue other than the consultation which took place prior to the original shelter being removed.

2.2 Consultation proposed.

It is proposed that this issue be forwarded to the County Council. It is anticipated that they will decide what consultation is required.
